- Exhibitors must sign a Wavier of Responsibility for their art, and a Hold Harmless Waiver for participation (both on back of this page)
- Art must be delivered to the Fox Community Center, 306 Main Street on Thursday, May 14, 2015 from 6:00 9:00 p.m.
- Visitors will choose one overall People's Choice Winner, plus the Cultural Arts Commission will choose one adult and one student piece for Honorable Mention
- Art should be picked up following the event on Saturday, May 16, 2015 from 3:00 4:00 p.m. If necessary, arrangements may be made to pick up art at a later date from the City Museum, 132 Main Street
