- Exhibitors must have a connection to West Chicago, through school, work, home, Gallery 200 etc.
- Ready to hang two-dimensional art (framed with wire and eye hooks preferred)
- Sculpture and crafts welcome
- Registration fee is \$5 per piece of art (limit two works per artist with a combined size dimension of 24" x 24")
- Exhibitors must sign a Wavier of Responsibility for their art, and a Hold Harmless Waiver for participation (both on back of this page)
- Art must be delivered to the **Fox Community Center, 306 Main Street** on Thursday, **May 14, 2015** from **6:00 - 9:00 p.m.**
- Visitors will choose one overall People's Choice Winner, plus the Cultural Arts Commission will choose one adult and one student piece for Honorable Mention
- Art should be picked up following the event on Saturday, May 16, 2015 from 3:00 - 4:00 p.m. If necessary, arrangements may be made to pick up art at a later date from the City Museum, 132 Main Street

WAIVER AND HOLD HARMLESS AGREEMENT

In consideration of _____ (participant name) participating in **Artéculture** on Thursday, Friday and Saturday, May 14, 15 & 16, 2015, the undersigned hereby recognizes, acknowledges and assumes any and all risk pertaining to their participation in **Artéculture**.

To the fullest extent permitted by law, the undersigned hereby agrees to defend, indemnify and hold harmless the City of West Chicago, its officials, agents and employees, against all injuries, deaths, loss, damages, claims, suits, liabilities, judgments, cost and expenses (including attorneys fees), which may in anywise accrue against the City of West Chicago, its officials, agents, and employees, arising in consequence of participation in the activities related to **Artéculture, on Thursday, Friday and Saturday, May 14, 15 & 16, 2015** or which may in anywise result therefore, except that arising out of the sole legal cause of the City of West Chicago, its agents or employees.

The undersigned shall, at its own expense, appear, defend and pay all charges of attorneys and all costs and other expenses arising therefore or incurred in connections therewith, and, if any judgment shall be rendered against the City of West Chicago, its officials, agents and employees, in any such action, the undersigned at its own expense, will satisfy and discharge the same. The invalidity or unenforceability of any of the provisions hereof shall not affect the validity or enforceability of the remainder of this Agreement.

WAIVER OF RESPONSIBILITY

The City shall use reasonable care in the handling of the Artwork(s) and, if displayed in a building or controlled by the City, in the display of the Artwork(s). The City shall not be responsible for any damage to the Artwork(s) while in the custody of the City except that arising out of the sole legal cause of the City of West Chicago, its agents and employees. The City shall allow the Owner to retake possession of the Artwork(s), while the same are displayed or stored in any City owned building, or any location owned or controlled by the City, during the normal business hours of such building or location and upon such notice as is reasonable under the circumstances to allow for removal of the Artwork(s) from their display with out disruption of normal operations of such building or location. The Owner acknowledges and agrees that responsibility for any/all arrangements for retaking possession of the Artwork(s) while the same are displayed or stored in any building or other location not owned or controlled by the City shall be borne by the Owner.
