1. Call to Order. Mayor Michael B. Kwasman called the meeting to order at 7:00 pm.

2. Pledge of Allegiance to the Flag. Alderman Dzierzanowski led all in the pledge of allegiance.

3. Invocation. The City Clerk gave the invocation.

4. Roll Call and Establishment of a Quorum. Roll call found Aldermen Lori J. Chassee, James E. Beifuss, Jr., H. Ronald Monroe, James Smith, Russell Radkiewicz, Ruben Pineda, Sandy Dimas, Alan Murphy, John C. Smith, Kurt Meissner, Nanette B. Connelly, Rebecca Stout, Nicholas Dzierzanowski, and Matt Fuesting present. The Mayor announced a quorum.

City Clerk Nancy M. Smith and City Treasurer Donald F. Earley were also present. .

Also in attendance were City Attorney Patrick K. Bond, Public Works Director Rob Flatter, City Administrator Michael L. Guttman, and Marketing and Communications Coordinator Rosemary Mackey. Alderman Chassee made a motion, seconded by Alderman Meissner, to approve Resolution 12-R-0004. During discussion, Alderman John Smith clarified that the grant would be for three years, and there would be no cost to the City. He asked who would bear the costs after that time. City Administrator Guttman said that would be a policy decision by the City Council if they want to continue the program or not. Alderman Smith felt that while this may be a good program, it appears that the City is taking on types of things that maybe parents should be doing. The Mayor said the City would pay the upfront costs and then be reimbursed by the state. He said a trust factor is always going to be there with regard to the state. Mr. Guttman said this will save the City money. Previously, the City spent \$15,000.00 for the Youth Program. Currently there is a part time coordinator who will become a full time employee at the same hourly rate. There will be a few aides. Alderman Beifuss said the Open Gym program will be included in this grant. We all know those that take on a cause and hope to have friends follow them, but you usually look back and those that said, "we are behind you" are far far behind you. They stir the pot and cause division and again let someone else to fight. They say that they are part of a team until you are ready to take on the enemy, an enemy that you maybe didn't make, but still is an enemy. You tight for what is right not just what is right for you, but what is right for all. Remember the words of this man of peace: "In the end, we will remember not the words of our enemies, but the silence of our friends" – Martin Luther King Jr.
