- 1. Call to Order. Mayor Michael B. Kwasman called the meeting to order at 7:00 pm.

The church owns six lots that will be annexed and rezoned to ER-1, which does not permit churches. Mr. Bovey asked for some sort of amendment to the annexation to bring the lots into R-5 zoning which is what it is now. He asked that this item be tabled until the zoning could be brought into a manner consistent with current usage.

<u>From Item 8.B: Ordinance 09-O-0003</u> – An Ordinance of the City of West Chicago, Illinois, Providing for Annexation of Certain Territory Located on Blair and Stimmel Streets Between Lyman Avenue and Sherman Street

Alderman Pineda made a motion, seconded by Alderman Radkiewicz, to adopt Ordinance 09-O-0003. During discussion, Alderman Pineda made a motion, seconded by Alderman Chassee to table the motion to allow staff time to research actions to bring this to an R-5 zoning. Voting Yea: Aldermen Chassee, Beifuss, Monroe, Smith, Radkiewicz, Pineda, Dimas, Murphy, Bunch, Gianforte, Connelly, Stout, Dzierzanowski, and Fuesting. Voting Nay: 0. Motion carried.

<u>From Item 8.D</u>: <u>Ordinance 09-O-0009</u> – An Ordinance Granting a Special Use for a Church 134 Main Street – Apostolic Assembly Church

Alderman Pineda made a motion, seconded by Alderman Stout, to adopt Ordinance 09-O-0009. Voting Yea: Aldermen Beifuss, Monroe, Smith, Radkiewicz, Pineda, Murphy, Bunch, Gianforte, Connelly, Stout, and Fuesting. Voting Nay: Aldermen Chassee, Dimas, and Dzierzanowski. Motion carried.

**10. Unfinished Business**. Alderman Murphy said there were two articles in the Daily Herald about Canadian National Railway. One of their trains derailed in Buffalo Grove. There were 72 cars, and two contained molten sulfur, which is highly toxic. This is something our community will face. On the opposite page was an article on the move to halt the rail merger. West Chicago is going to continue to fight it. TRAC asked for \$7,500, which is a small price for our future, and it is something we should do. The derailment also shut down METRA for the rest of the day. Alderman Murphy asked how such an event would affect West Chicago. He said the molten sulfur was reason alone to continue to fight. Alderman Beifuss said on January 16<sup>th</sup>, in the US Court of Appeals, the City of West Chicago and others filed an emergency motion to stay the effective date of the STB's decision. It is currently pending in the courts. Alderman Pineda said the same motion was filed by Barrington, Bartlett, and Will County itself. West Chicago joined in with TRAC.
