- 1. Call to Order. Mayor Michael B. Kwasman called the meeting to order at 7:00 pm.

Alderman Bunch made a motion, seconded by Alderman Dzierzanowski, to approve Resolution 09-R-0007. During discussion, Alderman Bunch said it would be good to hear from staff as to why this contract did not go through the sealed bid process. Public Works Director Flatter explained that staff is asking the City to award a three year no bid contract to Kramer Tree Specialists in the amount of \$189,000. This amounts to \$63,000 per year. Kramer has received the contract 11 out of the past 14 years. Staff believes that no bid would be awarded for two reasons: The prices are competitive and firm for three years. Kramer performs the brush collection for many communities in the western suburbs. Staff believes they are the best in the business. They have the best equipment and they demonstrated that when they do brush collection, there is minimal disruption to the community, and callbacks are rare. They are very courteous and prompt. In the past, the contract asked for a 7 day pick up, but now we are asking for 5 working days, and Kramer will do it in three.

12. Mayor's Comments. The Mayor said today we honor Presidents Day which brings together two great leaders of our nation: Abraham Lincoln and George Washington, Being from Illinois we all know the greatness of old Honest Abe and what he had to endure with a war that pitted brother against brother and the freeing of peoples from other lands, commonly known as slaves.

The federal holiday for Washington's Birthday honors the accomplishments of the man who has been referred to, for over two centuries, as "The Father of his Country." He is celebrated for his leadership in the founding of the nation.
