### **MINUTES**

# PUBLIC AFFAIRS COMMITTEE April 26, 2010, 7:00 P.M.

# 1. Call to Order, Roll Call, and Establishment of a Quorum

Chairman Chassee called the meeting to order at 7:00 P.M. Roll Call found Alderman Connelly, Monroe, Smith and Radkiewicz present. Alderman Fuesting joined the meeting at 7:06 p.m. and was not present for the vote on Items for Consent.

Also in attendance were Chief of Police Donald Goncher, Luann Bombard, Director of Museum and Cultural Services, Wayne Lofton Jr., West Chicago Chamber, Don Early, City of West Chicago Treasurer and Anna Rosales, West Chicago Park District.

## 2. Approval of Minutes

A. Public Safety Committee of March 22, 2010. Alderman Connelly made a motion, seconded by Alderman Smith to approve the minutes of the Public Safety Committee Meeting of March 22, 2010 with no changes. Voting Yea: Chairmen Chassee, Alderman Connelly, Monroe, Smith and Radkiewicz. Voting Nay: 0. Motion carried.

A. Use of the City LED Information Sign located at Main St and Neltnor Blvd. – Don Early asked who / what organizations were authorized to have information displayed on the sign. It was believed that parameters for who could use the sign were set out at a previous Community Affairs Committee Meeting. Chairman Chassee stated she would ask for the minutes of that meeting to review the parameters and possibly revisit them.
