11. New Business. City Treasurer presented a proposal to rename the Wilson Street Bridge after long time resident and former Mayor, A. Eugene Rennels. He was the major figure in obtaining the funds for the construction of the bridge. He also served this town for a long time in a variety of ways. He was on the school board, an Alderman, City Treasurer, and then

Mayor. He had many initiatives while Mayor including "Clean and Proud" to clean up the railroad station and police department and have blooming plants and flowers so something was growing all the time. West Chicago has a history of naming streets after local people who have done something for the community such as Colford, Turner, McDonald (a County Treasurer), Dayton, Tye Court, and Turner Court. Treasurer Earley read from a letter saying it was time to do something for Mr. Rennels, saying, "It is not the Wilson Street Bridge, it is the Rennels Bridge." The Mayor related how when he moved here 22 years ago the first person he met was Gene Rennels who told him the history of West Chicago. The Mayor saw how much this man loved West Chicago. Mr. Rennels was also the person who started the war against storing thorium in West Chicago. He went to Washington, D.C. and gathered the troops to start that battle. The Mayor said he will ask the Public Affairs Committee to put this on their next agenda to discuss and report back to the City Council.

12. Mayor's Comments. The Mayor welcomed Mr. Meissner to the Council, saying the City looks for forward thinking. Whatever the Council does is so the future generations will be proud of this community. Mr. Meissner comes from the north side, from one of the newer subdivisions, and took on the duties of a former alderman who has very hard shoes to fill. He advised Mr. Meissner to ask the questions. He will get answers, even if he may not like them. The Mayor said this is not a City Council of followers. He again welcomed Mr. Meissner to the City Council, what the Mayor calls, "My Dream Team."

The Mayor said he got involved in local government from John Smith to work on the police referendum to be able to hire more officers. The referendum passed on the first try, and from that, the City was able to get our new Chief. Chief Perez hit he ground running. The City's crime rate has drooped 27%, which is easy to say, but hard to do. The drop is due to our police department and its leadership. The Mayor said he was proud to appoint Laz Perez, who is the epitome of a police chief and an ambassador, and we welcome him to our community.
