- 1. Call to Order. Mayor Michael B. Kwasman called the meeting to order at 7:00 pm.

City Clerk Nancy M. Smith and City Treasurer Donald F. Earley were also present.

Also in attendance were City Attorney Patrick K. Bond, Museum and Cultural Services Director LuAnn Bombard, Public Works Director Rob Flatter, City Administrator Michael L. Guttman, Community Development Director Joanne Kalchbrenner, and City Museum Registrar Sara Phalin.

5. Public Participation.

A. Cultural Arts Commission Banner Program. The Mayor called upon Museum Director Bombard who said there are two exciting projects downtown. She introduced Heidi Morris who spoke about the banner project. Ms. Morris thanked the City Council for supporting the Cultural Arts Commission's banner program for the second year in a row. The banners will be up all summer and the public can vote on favorites. The banner concept started several years ago when John Keeney joined the Commission. He uses a digital image to print the banners. The goal is to bring art into the community and have the community exposed to local artists. Anni Holm worked on getting the artists and organizing the program. The banners will be on sale at the end to raise funds to sustain this project.

Anni Holm then spoke, and said she was an immigrant from Denmark and an international artist. She chose to live in West Chicago. She introduced the City's second Artist-in-Resident, Jorge Rojas. For the past ten days he has been stationed at the Museum where he has invited residents to come participate in his project. This is also broadcast live every day to share with the rest of the world on the Internet. Ms. Holm thanked Don and Marilyn Earley for hosting Mr. Rojas for the past two weeks. Ms. Holm thanked the Earley's, the City Museum, and Sara Phalin for all her commitment to the Cultural Arts Commission and the City of West Chicago and Jorge Rojas for coming from New York.

Jorge Rojas thanked the Mayor and City Council members and spoke about his project. He worked with the City Museum to create a slide show. Before showing it, he again thanked the City for supporting this project, the Museum staff, and Anni Holm. He thanked Don and Marilyn Earley for being the greatest hosts. Mr. Rojas said West Chicago is a wonderful city. He then presented the slide show of adults and children of the community painting at the Museum. Over 400 people came in over the weekend to participate in the process. One of the intentions was to blur the lines between the art and the viewer. The Mayor thanked Mr. Rojas for the great presentation.
