MINUTES

PUBLIC SAFETY COMMITTEE May 26, 2009, 7:00 P.M.

1. Call to Order, Roll Call, and Establishment of a Quorum.

2. Approval of Minutes

- A. Public Safety Committee of April 27, 2009. Alderman Connelly made a motion, seconded by Alderman Murphy to approve the minutes of the Public Safety Committee Meeting of April 27, 2009 with no changes. Voting Yea: Chairmen Chassee, Alderman Monroe, Connelly, Radkiewicz, Smith and Murphy. Voting Nay: 0. Motion carried.

- 4. Items for Consent.
 - A. Ordinance 09-O-0035 Article XIX, Chapter 17, Section 17-1205; The Seizing and Impounding of Motor Vehicles Used in Connections with Illegal Activities.

Chief Goncher did comment that he would like for this ordinance to go to legal council before sending it to City Council. The offense of Unlawful Contact with Street Gang Members, in violation of 720 ILCS 5/25-1.1 should be reviewed by our city attorney. A police officer will be able to seize the vehicle of the driver if that person has a no gang contact card and another gang member is the vehicle.

Alderman Connelly made a motion, seconded by Alderman Murphy to approve Ordinance 09-O-0035 – Article XIX, Chapter 17, Section 17-1205; The Seizing and Impounding of Motor Vehicles Used in Connections with Illegal Activities. Voting Yea: Chairmen Chassee, Alderman Monroe, Connelly, Radkiewicz, Smith and Murphy. Voting Nay: 0. Motion carried.

5. Items for Discussion.

A. Nuisance Trapper Animal Agreement

Chief Goncher explained the fees for the removal of nuisance animals for the City of West Chicago. There will not be a set up of \$95. The set up fee will be waived however residents will be charged \$75.00 for the first animal and \$45.00 for each additional animal.
