MINUTES

PUBLIC AFFAIRS COMMITTEE June 20, 2011, 6:00 P.M.

1. Call to Order, Roll Call, and Establishment of a Quorum

Chairman Chassee called the meeting to order at 6:00 P.M. Roll Call found Alderman Connelly, Fuesting, Monroe and Meissner present. Alderman Radkiewicz joined the committee at 6:01pm and Alderman Murphy joined the committee at 6:07pm.

2. Approval of Minutes

A. Public Affairs Committee of May 23, 2011. Alderman Fuesting made a motion, seconded by Alderman Meissner to approve the minutes of the Public Affairs Committee Meeting of May 23, 2011 with no changes. H. Resolution No. 11-R-0056 – Resolution to Change The Name of The Wilson Street Bridge to the A. Eugene Rennels Bridge

Alderman Connelly made a motion, seconded by Alderman Fuesting to approve and direct this item to City Council. Voting Yea: Chairman Chassee, Alderman Connelly, Fuesting, Monroe, Radkiewicz, Murphy and Meissner. Voting Nay: 0. Motion carried.

I. St. Mary's Annual Festival – Members from St. Mary's Church have requested from the City to waive the \$200 Electrical Fee Inspection since the City now has a private company doing their inspections.

Chairmen Chassee addressed the committee and participants that she is opposed to making a blanket policy statement at this point.

Committee unanimously voted to review these requests on a case by case basis.

J. Drug Disposal Program – The West Chicago Police Department was seeking direction from the Public Affairs Committee to launch a Prescription Drug Disposal Program. The purpose of this program will be to collect old, unwanted and discarded prescription medications and properly dispose of them through an approved EPA site. In order to implement the program, the department will purchase a secured metal cabinet, which will be permanently attached at the police department and video monitored. The container's cost will be between \$1,000 and \$1,500 depending on product selection.

Committee gave the Chief of Police direction to move forward with this request.
