December 3, 2012

- 1. Call to Order. Acting Mayor Ruben Pineda called the meeting to order at 7:00 pm.
- 2. Pledge of Allegiance to the Flag. Alderman Jim Smith led all in the pledge of allegiance.
- **3. Invocation**. The City Clerk gave the invocation.
- **4.** Roll Call and Establishment of a Quorum. Roll call found Aldermen Lori J. Chassee, James E. Beifuss, Jr., H. Ronald Monroe, James Smith, Russell Radkiewicz, Ruben Pineda, Sandy Dimas, Alan Murphy, John C. Smith, Kurt Meissner, Nanette B. Connelly, Rebecca Stout, Nicholas Dzierzanowski, and Matt Fuesting present. The Acting Mayor announced a quorum.

City Clerk Nancy M. Smith and City Treasurer Donald F. Earley were also present. .

Also in attendance were City Attorney Patrick K. Bond, Museum and Cultural Services Director LuAnn Bombard, Krista Coltrin with Marketing and Communications, City Administrator Michael L. Guttman, HR Coordinator Carol LeBeau, City Attorney Keith E. Letsche, Deputy City Clerk Valeria Lopez, Marketing and Communications Coordinator Rosemary Mackey, Chief of Police Laz Perez, Community Development Director John D. Said, and Deputy Police Chief Mike Uplegger.

## 5. Public Participation.

The following people spoke during Public Participation:

- 1) Kristen Jungles, Illinois Association of Realtors, 216 Douglas Avenue, Naperville, Illinois, thanked the Mayor, City Council and staff for changing the cash requirements in realty sales and for making the turnaround from inspection to re-inspection down to five days. She suggested that the funds collected be put into a realty program rather than the General Fund.
- 2) Jeff Stibal, 424 Highland Avenue, West Chicago, spoke about the Wiant House on Washington Street. He read from the City's web page about the importance of history. The Wiant House is no different from a family's heirlooms. He would like the City to use TIF funds to stabilize the Wiant House. He said the City repaired the roof on the old train station for \$17,000.00 and spent \$35,000.00 demolishing the Santos Restaurant. The money spent for demolition could be used for the stabilization costs. He said the Historical Preservation Commission would be having a public hearing tomorrow evening to discuss the Wiant House. People can go to the web site www.wianthouse.org for more information. He would like the City to show that it lives by its motto, "Where History and Progress Meet."
- A. Swearing in of Valeria Lopez Deputy City Clerk. City Clerk Smith administered the oath of office for one of the Deputy City Clerk positions to Valeria Lopez. Clerk Smith noted that Ms. Lopez has been performing the duties of Deputy City Clerk excellently for a number of years. Acting Mayor Pineda said Deputy Clerk Lopez keeps him on schedule, and she works hard on many things including the Mexican Independence Day celebration.
- **B. Proclamation: Drunk and Drugged Driving Prevention Month.** At the Acting Mayor's request, the City Clerk read *Proclamation Number 10, National Drunk and Drugged Driving (3D) Prevention Month December 2012*, in which the Acting Mayor declared December 2012 as such in West Chicago, and called upon all citizens, government agencies, business leaders, hospitals and health care providers, schools, and public and private institutions to promote awareness of the impaired driving problem, to support programs and policies to reduce the incidence of impaired driving, and to promote safer and healthier behaviors regarding the use of alcohol and other drugs this December holiday season and throughout the year. Acting Mayor Pineda added that this is very necessary during the holidays, and he appreciates this coming out at this time of year.
- **C. Proclamation: Honoring LuAnn Bombard.** Acting Mayor Pineda read the Mayoral Proclamation Honoring Luann Bombard On the Occasion of Her Retirement as Director of Museum and Cultural Services, in which he praised Ms. Bombard for her 23 years of dedicated services to West Chicago. A copy of the Proclamation is attached. The Acting Mayor said he could not thank Ms. Bombard enough. On behalf of the City, he said she would be greatly missed. He invited people to a reception in Ms. Bombard's honor after the

meeting. Ms. Bombard thanked the Mayor and gave an eloquent farewell speech, a copy of which is attached.
