Also, Central Development Corporation, 40W115 Campton Crossings Dr., Suite A, St. Charles, IL 60175, petitions the City of West Chicago for a special use to amend a planned unit development in accordance with Sections 15 and 10.3-4(M) of the City of West Chicago Zoning Ordinance for certain vacant property located on the south side of Roosevelt Road (IL Route 38) between Joliet Street and Bishop Street together with the property commonly known by the following addresses: 100-157 Wycliffe Drive, 1301 and 1325 Joliet Street.

Also, Central Development Corporation, 40W115 Campton Crossings Dr., Suite A, St. Charles, IL 60175, petitions the City of West Chicago for a special use to landbank required off-street parking in accordance with Sections 5.5 and 13.3 of the City of West Chicago Zoning Ordinance for certain vacant property located on the south side of Roosevelt Road (IL Route 38) between Joliet Street and Bishop Street together with the property commonly known by the following addresses: 100-157 Wycliffe Drive, 1301 and 1325 Joliet Street.
