WHEREAS, Garth Keck has helped enhance, preserve, and restore many significant structures within the City of West Chicago through his volunteer efforts with the West Chicago Historical Preservation Commission serving from 2003 until 2014.

13. Mayor's Comments. The Mayor said Mexican Independence Day was celebrated this past week-end in West Chicago. It was a great event with many faith based groups in the parade. The event was well attended, but could use more volunteers for a larger event. He challenged the community to come out and volunteer. Planning will start in January. The actual Consul General of Mexico came to the event and was very happy to be here. He spent the whole day here. El Coco Loco prepared the best Mexican food.

The Mayor announced that the Fox Valley Composite Squadron – the local unit of the Civil Air Patrol – located at DuPage Airport (West Chicago) beat the Guinness World Record of "Highest Paper Airplane Flight from a High Altitude Balloon." The paper airplane was launched from Kankakee, Illinois, and reached 96,563 feet, breaking the prior record of 89,591 feet, and then landed 82 miles away in Indiana. The Mayor will invite the Squadron to visit the City Council.

The Mayor announced that the underpass on Main Street is now open.

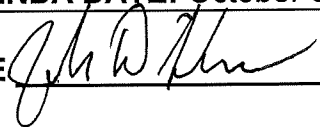

ITEM SUMMARY:

Tony Arias, owner of 112 Galena Street, has requested Façade Grant funding for painting the exterior façade of his multi-tenant commercial building. The proposed improvements are eligible expenses under the Downtown Façade Grant Program. A Certificate of Appropriateness (COA) was approved by the Historical Preservation Commission on July 22, 2014.

Mr. Arias submitted three quotes for the painting: 1) Eddie Prime Maintenance Inc. for \$3,200.00, 2) College Craft Enterprises Ltd. for \$4,320.00; and 3) Prime Time Painting for \$3,474.00. Based on the lowest quote by Eddie Prime Maintenance Inc., the shared cost to be incurred by the City will be \$1,600.00.

The funding for the Grant Program comes from the downtown TIF district. Per the guidelines established for the Grant Program the City may contribute up to 50% of the costs of the improvements, based on the lowest quotes submitted, if sufficient funding is available. City staff acknowledges that there are sufficient funds available to reimburse the \$1,600.00 expense to the City.

The City's Sanitary Sewer Lift Station No. 3, located at the northeast corner of Illinois Route 38 (Roosevelt Road) and Washington Street/Fabyan Parkway, is the City's largest sanitary sewer lift station collecting and pumping approximately 70% of the City's daily sanitary sewage to the City's Wastewater Treatment Plant. The lift station was originally constructed in 1966 and was last updated in 1996. Since 1996, flow conditions to the lift station have significantly increased and City staff routinely experiences operational problems at said lift station, resulting in concerns for its ability to maintain the lift station during severe wet weather conditions and long term.

In June 2012, the City contracted with Clark Dietz, Inc. (CDI) to perform an evaluation of Sanitary Lift Station No. 3; to report on its current condition, provide recommendations for operational and safety improvements, and to provide cost estimate(s) for each recommendation. CDI's evaluation and recommendation report, dated October 2012, outlined numerous areas that require updating to maintain functionality and worker safety for the long term operation of the station. At the March 7, 2013 Infrastructure Committee meeting, CDI presented and discussed its finding and recommendations outlined in its report. With Committee approval, CDI then prepared engineering plans and project specifications, and the project was bid.

The proposed project includes improvements to safety, data communication, maintenance, electrical, pumps, and operations. A partial listing of improvements to be completed at the lift station include:

- Installation of Safety Grating, Safety Line Attachments and other Safety Measures.
- Installation of new Sluice Gate on 15" and 42" Influent Lines.
- Replace Flow Meter.
- New Level Transducer.
- Replace existing pumps with new Wemco screw centrifugal pumps.
- Install 4th Pump (i.e., new Wemco screw centrifugal pump) and Discharge Header.
- Sandblast and Paint Discharge Piping and Valves.
- Clean Wet Well.
- Install Emergency Notification System.
- Install Variable Frequency Drive Starters for Pump Motors.
- Replace Pump Electrical Leads.
- Replace Pump Base Discharge Elbows and Slide Rails.
- Installation of new by-pass pumping station.

- Reconfigure discharge piping system (to accommodate Illinois Route 38/Fabian Parkway Intersection Improvement Project).
- Miscellaneous Site Improvements.

The request for bids was advertised in the Daily Herald on August 7, 2014. All bid documents and plans were made available electronically to interested parties via Quest Construction Data Network. Bids were opened August 26, 2014. There were nine plan holders, but the City received only one bid. Manusos General Contracting, Inc. of Fox Lake, Illinois, was the only bidder at \$1,729,600.00. CDI's engineer's estimate of cost for the project was \$1,714,600.00

Manusos General Contracting, Inc. has previously performed satisfactory work for the City in 2011 for the WWTP Raking Bar Screen Improvement Project, and Clark Dietz's previous experience with Manusos has been positive. In addition, Clark Dietz has checked the references for Manusos' listed subcontractors with positive results.

Within the Fiscal Year 2014 Sewer Fund budget (i.e., Sanitary Collection Program (05-34-43-4402)), \$2,000,000.00 has been budgeted for improvements to Sanitary Lift Station No. 3 (which includes \$250,000.00 for engineering design and construction oversight services).

It is staff's recommendation that a contract be awarded to Manusos General Contracting, Inc. of Fox Lake, Illinois, for the 2014 Lift Station #3 Improvement Project, in an amount not to exceed \$1,729,600.00.

Having experienced multiple years of poor service resulting from the public bidding process, in May 2008 and again in October 2011, City Council voted to waive competitive bidding and approved a three (3) year contract with Buck Services, Inc. of West Chicago for professional custodial services of six City owned and maintained facilities. Buck Services' current Custodial Services Contract is scheduled to expire on December 31, 2014.

Buck Services, Inc. has indicated its desire to continue to provide professional custodial services for the City and has submitted a three year contract proposal for like services. For fiscal year 2015, Buck Services has proposed a zero percent increase from FY 2014 prices, providing services for an amount not to exceed \$79,567.50. For FY 2016 and FY 2017, Buck Services has proposed a three percent (3%) increase for each subsequent year (i.e., not to exceed \$81,954.53 for FY 2016 and \$84,413.17 for FY 2017).

Staff has been extremely pleased with the services provided by Buck Services, Inc. over the past six plus years, and as such staff recommends approval of a new three (3) year contract (i.e., FY 2015 thru FY 2017).

Custodial services are budgeted and paid from various funds, depending on location for services. Adequate funds will be budgeted into the Commuter Parking Fund, the General Fund, and the Water Fund to cover future year's services.

If it is the desire of City Council, staff is prepared to seek bids through the competitive bidding process if directed to do so.

The 2014 Contractual Street Striping Program consists of pavement marking removal and installation of thermoplastic pavement markings on Prince Crossing Road between Hawthorne Lane and Geneva Street, on Ingaltan Avenue between Risch Court and Hawthorne Lane, and on Hawthorne Lane between Arbor Avenue and Illinois Route 59 (approximately 1.6 miles of roadway).

Like FY2012 and FY 2013, for FY2014, Superior Road Striping, Inc. holds a joint purchasing contract through the Suburban Purchasing Cooperative (SPC). The Suburban Purchasing Cooperative (SPC) Joint Purchasing Program is sponsored by the Northwest Municipal Conference, DuPage Mayors and Managers Conference (West Chicago is a member), South Suburban Mayors and Managers Association, and Will County Governmental League; together representing over 150 municipalities, townships and other governmental agencies. Gasoline and diesel fuel delivery, vehicle purchases, and pavement striping, are items for which SPC has procured joint purchase pricing through a competitive bid process. Utilizing the SPC Joint Purchasing Program, and Superior Road Striping, Inc.'s unit pricing offered in said program, the City's 2014 Contractual Street Striping Program as referenced above will cost approximately \$29,400.00, depending on final quantity measurements.

It is staff's recommendation that City Council award a contract to Superior Road Striping, Inc. of Melrose Park, Illinois, for the 2014 Street Striping Program, using pricing obtained from the SPC Joint Purchasing Contract, in an amount not to exceed \$40,000.00. The additional approximate \$10,000.00 will be spent on replacing/upgrading painted school zone markings with Thermoplastic markings throughout the City. This year's program is will be paid for using Capital Project Funds (08-34-53-4869) in which \$40,000.00 has been budgeted.

In the Sewer Fund, identified as a FY 2014 plant equipment replacement project, is the replacement of the grit removal system equipment at the City's Regional Waste Water Treatment Plant. In June 2014 the City hired Clark Dietz, Inc. (CDI) to evaluate the headworks' grit removal equipment and prepare/update an engineer's estimate of construction cost. The initial cost estimate of \$600,000.00, used for past budgeting purposes and development of a Capital Improvement Plan, was generated by CH2M Hill OMI staff in 2010. CDI has completed its evaluation and has developed an engineer's estimate of cost of approximately \$1,100,000.00 to replace the existing equipment with stainless steel equipment. City staff, CH2M Hill OMI staff, and Village of Winfield staff have recently met and discussed CDI's preliminary investigation report and the project; all have agreed that replacement of the screening and grit removal system equipment is a priority and that the project should proceed with stainless steel equipment and appurtenances.

Therefore, City staff approached CDI and requested a cost proposal to perform engineering design and bid assistance services for the project. CDI's proposal is for a not to exceed amount of \$64,295.00. Adequate funds are available in the Sewer Fund (i.e., Sewer Plant Equipment Replacement Program) to cover this expenditure.

The project will be bid in January 2015, with construction anticipated for Summer 2015. The proposed Sewer Fund budget for FY 2015 will include adequate funds to cover construction costs for the Grit Removal System Equipment Replacement Project.

The City's Sanitary Sewer Lift Station No. 5, located at 344 S. Neltnor Boulevard behind the Burger King Restaurant on Illinois Route 59 (Neltnor Boulevard), collects sanitary sewage from an approximate area bounded by Wilson Avenue (west), Washington Street (north), Prince Crossing Road (east) and Blair Street (south), and pumps said sewage to the gravity sanitary sewer system on Main Street, near 461 Main Street. City owned Lift Station No. 7 and No. 12, and the private lift station at the Main Street Apartments, all pump sanitary sewage to Lift Station No. 5. The sanitary force main for Lift Station No. 5 is cast-iron pipe, approximate 60-years old, that has exceeded its useful life. The condition of the cast-iron force main is weak, and the combination of age and deterioration has resulted in holes and cracks forming in the pipe from the pressure of the sanitary sewage pumped through it. Three breaks occurred in the pipe, in front of the Metra Station, over a four-month period in early 2014.

Given the condition of the force main, City staff determined it was beneficial to develop plans and obtain construction quotes to permanently repair or replace it. With surveying and design services from RJN Group of Wheaton, Illinois, in May 2014 the City sought pricing from several contractors to install a liner in the existing force main, approximately 1,000 lineal feet, and to install approximately 800 lineal feet of new sanitary sewer pipe downstream of the Metra Station. Unfortunately, the City received no bids/price quotes.

To understand why the City failed to receive a single bid, in June 2014 we reached out to several potential contractors...all sighted either existing work load or restrictions on the lining portion of the project as reasons for not bidding on the project. The existing sanitary lift station continually collects and pumps raw sewage (i.e., 24 hours a day, 7 days a week). When the lift station is shut down, sewage must be constantly pumped or extracted from the collection system, transported, and dumped off-site into a gravity sewer system. Contractors want five to seven days to install a liner in the existing sanitary force main; which means no sanitary sewage can be pumped through the force main during lining operations. Given the Union Pacific railroad tracks south of, Main Street north of, and the Metra Station west of the lift station, there is no means to by-pass the lift station with pumps. All contractors stated that their pricing would exceed \$750,000.00 if the City's original design proposal was sought.

In June 2014, RJN and City staff worked with two contractors to determine a viable alternative to replacing the existing sanitary force main. Apollo Infrastructure Services, LLC of Phoenix, Arizona (working with a local Illinois contractor) and RA Mancini, Inc. of Lakemoor, Illinois, both suggested eliminating the sewer lining portion of the project and directional drilling all new sanitary sewer pipe,

approximately 1,800 lineal feet. The new sewer force main and gravity sewer pipe could be installed in the drive aisle of the Metra parking lot, with a sanitary manhole being installed west of the Metra Station for future sanitary sewer service to the Metra Station. Moving the force main and gravity sewer into the parking lot would eliminate future disruption to the Metra Station sidewalk, landscaping, and stairs. In July 2014, RA Mancini submitted a cost proposal for \$591,680.00. Apollo submitted a cost proposal for \$432,138.00

Given the condition of the force main, City staff feels strongly that the existing sanitary force main should be replaced as soon as possible, before another failure occurs under the Metra Stairs. Therefore, City staff recommends that a contract be awarded to Apollo Infrastructure Services, LLC of Phoenix, Arizona for the Lift Station No. 5 Force Main Rehabilitation Project, in an amount not to exceed \$432,138.00. If approved, work will commence in late October 2014/early November 2014.

This project is unfunded in the FY 2014 Sewer Fund. With other budgeted projects being delayed until FY 2015, adequate funds are available to cover this emergency expenditure.

In March 2014 City Council approved the submission of the Joint Purchasing Requisition to the State of Illinois Department of Central Management (CMS), Bureau of Strategic Sourcing & Procurement, for the guaranteed purchase of a minimum of 2,800 tons, and authorizing a maximum purchase of 4,200 tons, of rock salt for winter season 2014-2015. In August 2014, CMS notified the City that its purchase price for rock salt during the 2014-2015 winter season will be \$112.69 per ton delivered. For comparison, the City paid \$53.71 per ton delivered for the 2013-2014 winter season.

In August 2014, City staff contacted the sales representative for North American Salt, who acknowledged an ability and willingness to deliver up to 1,400 tons of Thawrox Deicer (i.e., treated rock salt) to the City during the 2014-2015 winter season for \$118.08 per ton delivered. However, North American Salt Company is looking for an 80% purchase commitment from the City (i.e., minimum 1,120.00 tons). For comparison, the City paid \$73.41 per ton of Thawrox delivered during the 2013-2014 winter season.

The City utilized Thawrox in 2011 and 2014, and was very pleased with its performance and effectiveness during extreme cold conditions, when regular salt was not. In addition, Thawrox does not require the additional use of Geomelt or other pre-wet agents. Given the fact that Thawrox is more effective at melting snow and ice in than regular rock salt, and given the fact that Thawrox is only \$5.39 per ton delivered more than regular rock salt, City staff recommends the purchase of up to 1,400 tons of Thawrox from North American Salt Company for the 2014-2015 winter season; resulting in an additional expenditure of \$7,546.00 over the purchase of 1,400 tons of regular rock salt.

If approved, City staff would purchase the minimum 2,800 tons of regular rock salt through the State's Program and the minimum 1,120 tons of Thawrox; leaving 1,400 tons of regular rock salt available through the State's Program and 280 tons of Thawrox available for emergency or extended weather conditions.

Rock salt and Thawrox Deicer are paid from the Public Works Motor Fuel Tax Fund (01-09-26-4670), in which \$250,000.00 is typically budgeted for rock salt. For FY 2015, the budget line item will be increased to cover expected expenditures.

ACTIONS PROPOSED:

That the West Chicago City Council waive competitive bidding and authorize the purchase of purchase of up to 1,400 tons of Thawrox Deicer, at the price of \$118.08 per ton delivered, from North American Salt Company of Overland Park, Kansas.

ITEM SUMMARY:

For FY 2014, the Public Works Department has planned and budgeted for the replacement of one 2002 Dodge Ram 1500 2wd pick-up truck. Said truck will be replaced with a 2015 Ford F-250 Super Duty, Regular Cab, 4wd pick-up truck equipped with a Knapheide Service Body and a Western snow plow (to be used by the Utility Division for various tasks including citywide snow removal operations as needed).

To allow local vendors an opportunity to quote on the 2015 Ford F-250 truck, the City of West Chicago solicited a price quote from Haggerty Ford of West Chicago, Illinois, Zimmerman Ford of St. Charles, Illinois, Joe Cotton Ford of Carol Stream, Illinois, Freeway Ford of Lyons, Illinois, Wright Automotive of Hillsboro, Illinois, Morrow Brothers Ford of Greenfield, Illinois, Landmark Ford of Springfield, Illinois, Currie Motors Ford of Frankfort, Illinois (dealership that currently holds the Suburban Purchasing Cooperative (SPC) Joint Purchasing Program contract), and Bob Ridings Ford of Taylorville, Illinois (dealership that currently holds the State of Illinois official joint purchasing contract). From our request only three quotes were received: Haggerty Ford quoted \$35,357.00 per truck, Zimmerman Ford quoted \$35,035.00 per truck, and Freeway Ford quoted \$35,884.00 per truck.

Although Zimmerman Ford provided the lowest price quote, when considering the Local Vendor Preference Policy (Resolution No. 12-R-0009) Haggerty Ford would be entitled to the purchase transaction.

Vehicles will be purchased from the Capital Equipment Replacement Fund (04-34-39-4804) in which adequate funds are available in the Capital Equipment Replacement Fund to cover this expenditure.

ITEM SUMMARY:

Pursuant to the Illinois Fire Investigation Act (425 ILCS 25), the Office of the State Fire Marshal formally adopted the National Fire Protection Association's *Life Safety Code* (NFPA 101), *2000 Edition*, as the State's minimum fire prevention and safety code. In conjunction with the authority granted by the Fire Investigation Act, the 2000 edition of NFPA 101 became the minimum requirement that must be met statewide. The Act provides that all municipalities must enforce this code or a code of equal or higher standards.

The attached Ordinance creates a new municipal code section 4-10. *Life Safety Code* under the Building Code and adopts the 2000 edition of NFPA 101. The amendments also attached to the ordinance mirror those established by the State Fire Marshal.

**AN ORDINANCE OF THE CITY OF WEST CHICAGO, DUPAGE COUNTY, ILLINOIS
AUTHORIZING THE ACQUISITION OF A PARCEL COMMONLY KNOWN
AS "120 CHICAGO AVENUE" FOR ASSEMBLAGE PURPOSES AS PART
OF THE DOWNTOWN REDEVELOPMENT PLAN AND PROJECT**

WHEREAS, the City of West Chicago has previously adopted Ordinance Nos. 2273, 2274 and 2275, which adopt a Downtown Redevelopment Plan and Project, and which designate a Project Area and adopt Tax Increment Allocation Financing for the Plan and Project; and

WHEREAS, all of the statements and findings contained in the aforementioned Ordinances are incorporated herein as if stated in their entirety; and

WHEREAS, the City of West Chicago is empowered pursuant to 65 ILCS 5/11-74.3 and 5/11-74.4 *et seq.*, to acquire by purchase, donation, lease, or eminent domain, real property within the Downtown Redevelopment Plan and Project; and

WHEREAS, the City Council has determined that the implementation of the Downtown Redevelopment Plan and Project will attract additional commercial businesses and ventures to the City of West Chicago, increase business for commercial ventures currently established within the City of West Chicago, strengthen the property and non-property tax and income bases, and will provide jobs and business or commercial opportunities for City residents; and

WHEREAS, the City Council has determined that it is reasonable, necessary and in the public interest and welfare that the real property bearing the common address of 120 Chicago Avenue, West Chicago, and which bears the P.I.N. 04-10-119-004 as legally described in Exhibit "A," attached hereto and incorporated herein by reference, should be acquired for purposes of the Downtown Redevelopment Plan and Project; and

WHEREAS, funds for the acquisition of the real estate described herein are available and shall be used from the Downtown TIF Fund.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of West Chicago, Illinois, in regular session assembled:

Section 1. That it is necessary and desirable that the real property described herein in Exhibit "A" be acquired by the City of West Chicago for the purposes set forth herein.

Section 2. That the City Council does hereby ratify and approve the terms of the real estate purchase contract, and addenda thereto, as executed by the City's Attorney, between the City of West Chicago and the owner of said real property, in the form attached hereto and incorporated herein by reference as Exhibit "B," and the Mayor and/or City Administrator are hereby authorized to execute all other documents necessary to effectuate the purposes of the acquisition of the real property.

Section 3. That the City Clerk be, and the same is hereby authorized to attest to all documents necessary to effectuate the purposes of the acquisition of the real property.

Section 4. That the Attorney and Staff of the City of West Chicago, Illinois are hereby authorized to take the necessary steps to acquire title to the real property described herein, after determining that the title to the real property is in proper order, and to pay any and all costs related thereto.

Section 5. That the Attorney and Staff of the City of West Chicago, Illinois are hereby authorized to execute, on behalf of the City of West Chicago, all documents necessary to effect the acquisition of the real property including all documents for purposes of the closing on this property, and, after acquisition of the real property, and to take the necessary steps to properly remove said property from the general real estate tax rolls at the appropriate time.

Section 6. That upon direction from the Attorney for the City of West Chicago, Illinois, the City Administrator is authorized to issue a check, draft or wire transfer in the amount of One Hundred Thirty Thousand and 00/100 Dollars (\$130,000.00), and as adjusted by proper prorations determined by the City's Attorney, payable from the Downtown TIF Fund, and made payable to the

owner of the real property, or as otherwise directed by the City's Attorney.

Section 7. That all ordinances and resolutions, or parts thereof in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 8. That this Ordinance shall be in full force and effect from and after its adoption, approval and publication in pamphlet form as provided by law.

PURCHASE AND SALE AGREEMENT
120 CHICAGO AVENUE, WEST CHICAGO, ILLINOIS

THIS PURCHASE AND SALE AGREEMENT (hereinafter "Agreement") is entered into this ____ day of _____, 2014 by and between Timothy G. Sasse (referred to herein as the "Seller") and the City of West Chicago, an Illinois municipal corporation (referred to herein as the "Buyer").

RECITALS:

A. Seller is the owner of that certain parcel of land, identified by P.I.N. 04-10-119-004, commonly known as 120 Chicago Avenue, West Chicago, Illinois (referred to herein as the "Property"), as is legally described in Exhibit A, attached hereto and incorporated herein by reference.

B. Seller desires to sell the Property to Buyer, and Buyer desires to buy the Property from Seller for purposes of assemblage for a redevelopment project on the terms and subject to the conditions of this Agreement.

THEREFORE, in consideration of the mutual covenants contained herein, and for other good and valuable consideration, the receipt and sufficiency are hereby acknowledged, Seller and Buyer agree as follows:

ARTICLE I
PURCHASE AND SALE

1.01. Agreement to Buy and Sell. Subject to the terms and conditions of this Agreement, Seller will sell to Buyer, and Buyer will purchase from Seller, good and marketable title to the Property subject only to the Permitted Exceptions which may appear on the Title.

1.02 Condition of Property On Transfer of Possession. Buyer plans to demolish the structures on the Property upon acquisition and therefore, accepts the structures in "as is" condition.

1.03. Purchase Price. The purchase price ("Purchase Price") for the Property is One Hundred Thirty Thousand and 00/100 Dollars (\$130,000.00), which price Seller agrees to accept as the fair cash market value of the Property.

1.04 Payment Terms. The Purchase Price, less any prorations or hold back agreed to by the Seller and Buyer will be payable at Closing (as hereinafter defined) in U.S. funds, by cashier's check or wire transfer of immediately available funds.

ARTICLE II PRE-CLOSING MATTERS

2.01. Title Commitment. Concurrently with the execution of this Agreement, Seller will procure a commitment for an owner's title insurance policy ("Title Commitment") issued by a Title Company (the "Title Company") acceptable to the Buyer in the amount of the Purchase Price, covering title to the Property on or after the date of this Agreement, showing title in the intended grantor, subject only to the general exceptions contained in the policy, the Permitted Exceptions and title exceptions pertaining to liens or encumbrances of a definite or ascertainable amount which may be removed by the payment of money at Closing and which Seller will so remove or cause to be removed at Closing by using funds Buyer will pay upon delivery of the deed.

2.02. Survey. The Buyer agrees to acquire the Property without benefit of Survey, so long as this is acceptable to the Seller's Title Company. For this purpose, Seller shall provide to Buyer any existing survey it has in its possession, with an affidavit of no new improvements provided the survey is acceptable to the Title Company. In the event the Title Company requires a Survey, it shall be provided by the Seller.

2.03. Title Defects. If either the Title Commitment or the Survey disclose any encroachment or violation or any exceptions to title or other than an exception described in Section 2.01 of this Agreement (an "Unpermitted Exception"), Seller shall have ten (10) days from the date of delivery thereof to have the Title Company issue its endorsement insuring against damage caused by such encroachments, violations or Unpermitted Exceptions, and provide evidence thereof to Buyer. If Seller fails to have the same insured against within said 10-day period, Buyer may elect, on or before the Closing, to terminate this Agreement or accept the Property subject to such encroachments, violations and Unpermitted Exceptions.

2.04 Inspection/Occupancy. The Buyer shall waive the requirements of the change of occupancy inspection, as the Property is to be demolished upon acquisition. However, the Seller must secure a City deed certification prior to Closing, which will involve paying all debts due and owing to the City in their entirety.

ARTICLE III APPORTIONMENT OF COSTS

3.01. Real Estate Taxes. Seller shall remain liable for payment of all general and special real estate and other ad valorem taxes and assessments and other state or city taxes, fees, charges and assessments affecting the Property through the date of tender of possession to Buyer, which is to be ninety (90) days past the date of Closing. For this purpose, taxes shall be prorated as of the planned date of possession on the basis of one hundred and five percent (105%) of the most recent ascertainable amounts of, or other reliable information in respect to, the tax amount then due, and that amount shall be paid to Buyer at Closing, subject to recalculation as of the date possession is tendered to the Buyer.

3.02. Title; Recording Costs. Seller will pay any fee the Title Company charges for issuing the Title Commitment, including any date down fee, and will also pay all premiums for the Owner's title insurance policy. Seller will also pay any separate title exam charges and the recording fees for any mortgage or other encumbrance releases. Buyer will pay its usual and customary fees for title and for recording the deed conveying the Property.

ARTICLE IV CLOSING

4.01. Closing Date and Location; Escrow. Seller and Buyer will use their best efforts to close this transaction on or before October 31, 2014 (the "Closing Date"), subject, however, to satisfaction of the conditions set forth in this Agreement, at the offices of the Title Company, or at such other time as is mutually acceptable to Seller and Buyer. In this Agreement, the term "Closing" refers to Seller's conveyance of title to the Property to Buyer.

4.02. Seller's Closing Documents. At Closing, the Seller will deposit with the Buyer, the following documents:

- (a) A recordable warranty deed, in a form reasonably acceptable to Buyer's counsel and the Title Company, conveying good and marketable title to Buyer in fee simple, free and clear of all liens and encumbrances, except the Permitted Exceptions.
- (b) An ALTA Owner's Title Insurance Policy ("Title Policy") issued by the Title Company in the form customarily used by the Title Company for property similar to the Property, in the amount of the Purchase Price, insuring that Buyer or Buyer's assignee has marketable, good, insurable and indefeasible fee simple title to the Property, subject only to the general exceptions of the Policy, the Permitted Exceptions, and any other exceptions Buyer has elected to accept.
- (c) Payoff letters issued by the holders of all mortgages or trust deeds or record, if any, setting forth the amount(s) required to release the Property from such mortgages or trust deeds, or release deed(s) sufficient to release such mortgages or trust deeds or record as to the Property.
- (d) A duly executed affidavit attesting to the absence of any claims of lien or potential lienors known to the Seller and further attesting that there have been no improvements to the Property for one hundred twenty (120) days immediately preceding the Closing Date which have not been fully paid for.
- (e) Executed ALTA Statement.
- (f) Executed real estate transfer tax declarations.
- (g) Such other documents as reasonably may be required to consummate the transaction contemplated by this Agreement.

4.03. Buyer's Closing Documents. At Closing, in addition to the Purchase Price, Buyer will deposit with the Seller, the following documents:

- (a) Executed ALTA Statement.
- (b) Executed counterpart of Seller's Closing Statement.
- (c) A copy of the ordinance of Buyer's City Council, approving this Agreement and authorizing Buyer to complete the transaction described herein, certified by an authorized officer of Buyer as being a true and complete copy of the original and as being in effect.
- (d) Such other documents as reasonably may be required to consummate the transaction contemplated by this Agreement.

ARTICLE V REPRESENTATIONS AND WARRANTIES

5.01. Seller's Representations and Warranties. To induce Buyer to enter into this Agreement, Seller makes the following representations and warranties (all of which representations and warranties will be deemed to have been made again at the time of the Closing, and all of which will survive the Closing), and Seller's obligations under Section 5.03 to indemnify and hold Buyer harmless from any and all loss, expense or liability Buyer may suffer or incur, including reasonable attorneys' fees and court costs, as a result of any inaccuracy in any of such representations and warranties, will be applicable.

- (a) Seller has full power and authority to enter into and carry out the terms and provisions of this Agreement. The execution and performance of this Agreement and the terms and provisions hereof by Seller are not inconsistent with, and do not result in the breach of any terms of any agreement or instrument to which Seller is a party by which Seller may be bound.
- (b) There is no litigation involving the Property or operation of the business thereon which could constitute an impediment to the sale of the Property, or a future lien affecting title to the Property.
- (c) Seller has the right and authority to perform hereunder without obtaining any consent from governmental authorities or others except as expressly provided herein. The transactions herein contemplated will not constitute a violation of any applicable law, rule, regulation, ordinance, judgment, order or decree of any governmental entity or court to which Seller is subject.
- (d) Seller will at all times on and after the date of this Agreement, act with diligence and in good faith to satisfy any contingencies remaining unsatisfied from time to time, and to perform its obligations under this Agreement.

- (e) Neither the Property nor the transfer of the Property contemplated by this Agreement is subject to the Illinois Responsible Property Transfer Act, 765 ILCS 90/1.

5.02. Buyer's Representations and Warranties. To induce Seller to enter into this Agreement, Buyer makes the following representations and warranties (all of which representations and warranties will be deemed to have been made again at the time of Closing, and all will survive the closing), and Buyer's obligations under Section 5.03 to indemnify and hold Seller harmless from any and all loss, expense or liability Seller may suffer or incur, including reasonable attorneys' fees and court costs, as a result of any inaccuracy in any of such representations and warranties, will be applicable.

- (a) Buyer is a municipal corporation, duly organized, validly existing and in good standing under the laws of the State of Illinois, with full power and authority to enter into and carry out terms and provisions of this Agreement. The execution and performance of this Agreement and the terms and provisions hereof by Buyer are not inconsistent with, and do not result in the breach of any terms of any agreement or instrument to which Buyer is a party or by which Buyer may be bound.
- (b) Buyer has the right and authority to perform hereunder without obtaining any consent from governmental authorities or others except as expressly provided herein. The transactions herein contemplated will not constitute a violation of any applicable law, rule, regulation, ordinance, judgment, order or decree of any governmental entity or court to which Buyer is subject.
- (c) Buyer will at all times on and after the date of this Agreement at with diligence and in good faith to satisfy any contingencies remaining unsatisfied from time to time, and to perform to obligations under this Agreement.

5.03. Survival of Representations and Warranties; Indemnification. The representations and warranties of the parties will be deemed to be continuing representations and warranties up to and including the Closing Date, with the same force and effect as though such representations and warranties had been made as of Closing. The representations and warranties of the parties will further survive the Closing, will not merge with any deed of conveyance, and will be continuing commitments and obligations of the parties hereto following the Closing Date, subject to any applicable statutes of limitations. Seller and Buyer agree to reimburse and indemnify each other (and Seller's and Buyer's employees, agents, successors and assigns) from and against all liability, damages and losses whatsoever, including reasonable attorney's fees and court costs resulting from an misrepresentation, breach of warranty, or breach of covenant made by the indemnifying party in this Agreement or in any document certificate or exhibit given or delivered to the other pursuant to this Agreement.

ARTICLE VI ENVIRONMENTAL

6.01 Environmental Definitions. For purposes of this Article VI, the term “Hazardous Substance,” shall mean at any time, any substance, waste, pollutant, contaminant, or material, in solid, liquid, or gaseous form, which:

- (a) Is a substance regulated or defined or designated as hazardous, extremely or imminently hazardous, dangerous or toxic pursuant to any law, by any local, state, territorial, or federal governmental authority; or
- (b) Is a substance with respect to which such a governmental authority otherwise requires environmental investigation, monitoring, reporting, or remediation, including but not limited to,
 - (1) All substances, wastes, pollutants, contaminants and materials regulated, or defined or designated as hazardous, extremely or imminently hazardous, dangerous or toxic, under the following federal statutes and their state counterparts, as well as these statutes’ implementing regulations: the Comprehensive Environmental Response, Compensation and Liability Act, 42 U.S.C. §9601 *et seq.*, the Resource Conservation and Recovery Act, 42 U.S.C. §6901 *et seq.*, the Toxic Substances Control Act, 15 U.S.C. §2601 *et seq.*, the Clean Water Act, 33 U.S.C. §1251 *et seq.*, the Clean Air Act, 42 U.S.C. §7401 *et seq.*, the Emergency Planning and Community Right to Know Act, 42 U.S.C. §11011 *et seq.*, the Safe Drinking Water Act, 33 U.S.C. §300f *et seq.*, the Federal Insecticide, Fungicide and Rodenticide Act, 7 U.S.C. §136 *et seq.*, the Atomic Energy Act, 42 U.S.C. §2011, and the Hazardous Materials Transportation Act, 42 U.S.C. §1801 *et seq.*;
 - (2) Petroleum and petroleum products including crude oil and any fractions thereof;
 - (3) Natural gas, synthetic gas, and any mixtures thereof;
 - (4) Radon;
 - (5) Radioactive substances;
 - (6) Asbestos;
 - (7) Urea formaldehyde;
 - (8) Polychlorinated biphenol; and
 - (9) Electromagnetic field radiation.

The term “Environmental Laws” shall mean all statutes specifically described the

foregoing sentence and all federal, state and local environmental health and safety statutes, ordinances, codes, rules, regulations, orders and decrees regulating, relating to or imposing liability or standards concerning or in connection with Hazardous Substances.

6.02. Environmental Representations and Warranties. Seller represents and warrants that: (i) neither the Property nor any part thereof is in breach of any Environmental Laws, and (ii) the Property is free of any Hazardous Materials that would trigger response or remedial action under any Environmental Laws or any existing common law theory based on nuisance or strict liability. If any such representations is in any manner inaccurate or any such warranty is in any manner breached (collectively a "Breach"), and if such Breach gives rise to or results in liability (including, but not limited to, a response action, remedial action or removal action) under any Environmental Laws or any existing common law theory based on nuisance or strict liability, or causes a significant effect on public health, Seller shall promptly take any and all remedial and removal action as required by law to clean up the Property, mitigate exposure to liability arising from, and keep the Property free of any lien imposed pursuant to, and Environmental Laws as a result of said Breach.

6.03. Environmental Indemnity. Additionally, but not in lieu of Seller's affirmative undertakings set forth in Section 6.02, Seller agrees to indemnify, defend and hold harmless Buyer from and against any and all debt, liens, claims, causes of action, administrative orders and notices, costs (including, without limitation, response and/or remedial costs), personal injuries, losses, damages, liabilities, demands, interest, fines, penalties and expenses, court costs and all other out of pocket expenses, suffered or incurred by Buyer and its grantees as a result of (a) any breach, or (b) any matter, condition, or state of fact involving Environmental Laws or Hazardous Materials which existed or arose prior to the Closing Date and which failed to comply with (i) the Environmental Laws in effect as of the Closing Date, or (ii) any existing common law theory based on nuisance or strict liability in existence as of the Closing Date, regardless of whether or not the Seller had knowledge of same as of the Closing Date. The representations and warranties of the Seller under this Article VI will be deemed to be continuing representations and warranties of the Seller up to and including the Closing Date, with the same force and effect as though such representations and warranties had been made as of the Closing. The representations and warranties of the Seller in this Article VI will survive the Closing, will not merge with any deed of conveyance, and will be continuing commitments and obligations of the Seller hereto following the Closing Date, subject to any applicable Statute of Limitations.

6.04. No Notices. Seller has received no notice that the Property or any part thereof is, and, to the best of their knowledge and belief, no part of the Property or any part thereof, is located within an area that has been designated by the Federal Emergency Management Agency, the Army Corps of Engineers or any other governmental body as being subject to special hazards. Seller will reasonably cooperate with Buyer to provide information which the Buyer may request regarding the Property. Seller is not under a duty to investigate facts not within his knowledge or control.

ARTICLE VII POSSESSION

7.01 Seller shall have the right to occupy and possess the Property following the Closing on the terms and conditions set forth in the Agreement for Post Closing Possession attached hereto and incorporated herein as Exhibit B.

7.02 Holdback. Five Thousand and 00/100 Dollars (\$5,000.00) of the acquisition funds shall be placed in a non- interest bearing account by the Buyer, to be held though the period of post-closing possession. Monies held in this account will be disseminated to Seller upon uneventful transfer of the possession of the Property from the Seller to the Buyer. If needed, these funds will be used to pay taxes, insurance, to remove personalty from the property or for other items required of the Seller, which have not been satisfied in accordance with the Agreement.

ARTICLE VIII BROKERS

8.01. Brokers. The Parties agree that there have been no Brokers involved in the sale of this Property.

8.02. Survival. The representations and warranties of Seller and Buyer, and their agreements contained in this Article VIII, will survive the Closing or other termination of this Agreement.

ARTICLE IX MISCELLANEOUS

9.01. Fees and Expenses. All costs, fees and expenses, including reasonable attorneys' fees, and court costs, incurred by a non-defaulting party as a result of the default of the other party will be paid by the defaulting party.

9.02. Notices. Any notice required or permitted to be given under this Agreement will be in writing and will be deemed to have been given when delivered personally, or on the date deposited in the United States mail, registered or certified mail, postage pre-paid, return receipt requested, and addressed as follows:

9.03. Amendment. This Agreement cannot be amended or terminated except by written instrument signed by all the parties hereto.

9.04. Waiver. No failure by Seller or Buyer to insist upon the strict performance of any covenant, duty, agreement or condition of this Agreement, or to exercise any right or remedy upon a breach thereof, will constitute as waiver thereof. Any party hereto, by notice to the other parties, may, but will be under no obligation to, waive any of its rights or any condition to its obligations hereunder, or any duty, obligation or covenant of the other parties hereto. No waiver will affect or alter any other covenant, agreement, terms or conditions of this Agreement, all of which shall continue in full force and effect.

9.05 Captions. The captions of this Agreement are for convenience and reference only and in no way define, limit or describe the scope or intent of this Agreement.

9.06 Governing Law. This Agreement has been entered into in the State of Illinois and will be interpreted under and governed by the laws of the State of Illinois.

9.07. Assignment. Seller may not assign this Agreement, or any of Seller's rights or duties hereunder without first obtaining Buyer's written consent, which Buyer may withhold in its absolute discretion.

9.08. Binding Effect. Without limiting the provisions of Section 9.07, this Agreement will bind and inure to the benefit of the parties hereto and their respective successors and assigns.

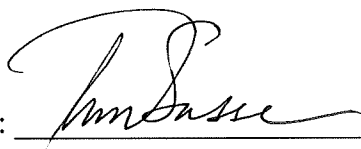

**Third Extension to the Temporary Occupancy
Agreement 139 W. Washington, West Chicago, IL**

The City of West Chicago ("City"), as owner, hereby agrees to allow Nilkanth Varni Inc., to continue to occupy 139 W. Washington, IL (the "Property") past the September 1, 2011 date for when temporary occupancy would have ended per the original Agreement, and past the December 31, 2014 date for when temporary occupancy would have ended per the second extension to the temporary occupancy agreement for 139 W. Washington, West Chicago, IL, on the following terms and conditions:

1.01 **Possession.** Nilkanth Varni, Inc., will deliver possession of the Property to the City on or before 12:01 a.m. December 31, 2016. This date of possession may be modified by written agreement of the City and Nilkanth Varni, Inc. At the time of tender of possession, Nilkanth Varni, Inc., shall remove all personal property belonging to Nilkanth Varni, Inc. Failure to remove all such personal property shall be held to be a breach of the Agreement.

1.02 **Rent.** Nilkanth Varni, Inc., will pay to the City rent payments, as follows:

- \$1,950.00 due on or before January 11, 2015;
- \$1,950.00 due on or before February 1, 2015;
- \$1,950.00 due on or before March 1, 2015;
- \$1,950.00 due on or before April 1, 2015;
- \$1,950.00 due on or before May 1, 2015;
- \$1,950.00 due on or before June 1, 2015;
- \$1,950.00 due on or before July 1, 2015;
- \$1,950.00 due on or before August 1, 2015;
- \$1,950.00 due on or before September 1, 2015;
- \$1,950.00 due on or before October 1, 2015;
- \$1,950.00 due on or before November 1, 2015;
- \$1,950.00 due on or before December 1, 2015;
- \$2,150.00 due on or before January 1, 2016;
- \$2,150.00 due on or before February 1, 2016;
- \$2,150.00 due on or before March 1, 2016;
- \$2,150.00 due on or before April 1, 2016;
- \$2,150.00 due on or before May 1, 2016;
- \$2,150.00 due on or before June 1, 2016;
- \$2,150.00 due on or before July 1, 2016;
- \$2,150.00 due on or before August 1, 2016;
- \$2,150.00 due on or before September 1, 2016;
- \$2,150.00 due on or before October 1, 2016;
- \$2,150.00 due on or before November 1, 2016;
- \$2,150.00 due on or before December 1, 2016;

Any payment not received by the City by the 6th day of the corresponding month shall be considered late and subject to a late penalty of \$100.00 per day.

1.03 **Hold-back.** Bond, Dickson & Associates, P.C. will continue to hold the sum of Ten Thousand and 00/100 Dollars (\$10,000.00), in their client trust account for the benefit of both parties, to secure performance of the terms of this Third Extension to the Temporary Occupancy Agreement. Said funds shall be made payable to the party entitled to the same at the conclusion of the Agreement, pursuant to written direction of the Parties, or by order of Court, should an order be required as a result of a dispute over payment of said funds.

1.04 **Insurance.** During the period of possession, Nilkanth Varni, Inc. shall provide the City (c/o City Administrator, 475 Main Street, West Chicago, Illinois 60185) an original Certificate of Insurance that maintains limits no less than the following:

1. Commercial General Liability: \$1,000,000 combined single limit per occurrence for bodily injury, and property damage and \$1,000,000 per occurrence for personal injury. The general aggregate shall be twice the required occurrence limit.
2. Business Automobile Liability: \$1,000,000 combined single limit per accident for bodily injury and property damage.
3. Worker's Compensation and Employers' Liability: Workers' Compensation and Employers' Liability limits of \$500,000 per accident.

The Certificate of Insurance shall also list the City of West Chicago as loss payee as well as, its officials, agents, employees, and volunteers as additional insureds. Nilkanth Varni, Inc. further agrees to assign to the City any proceeds from said policies occasioned by loss of property belonging to the City, without any defense.

1.05 **Indemnification.** Nilkanth Varni, Inc. agrees to indemnify and hold the City harmless from any and all claims, demands, actions or the like arising in any way, from or out of its occupancy, use or enjoyment of the Property subsequent to the closing of title and delivery of deed to the actual delivery of possession to the City.

1.06 **Post-Closing Occupancy Rental.** Nilkanth Varni, Inc. shall be responsible for payment of monthly rental for occupancy of the Property during the term of the Possession granted herein, as detailed above. It shall also be responsible of all operating and maintenance costs and real estate property taxes, and any and all other taxes associated with use of the Property, during its period of possession. Property taxes shall be paid in the manner set forth by law upon tender of the tax bill to Nilkanth Varni, Inc. in 2015 (taxes for 2014) and 2016 (taxes for 2015). Taxes for 2016, payable 2017, shall be prorated on the basis of 105% of the last ascertainable tax bill and shall be payable on or before the last date of possession by payment made to the City of West Chicago, c/o City Administrator, 475 Main Street, West Chicago, Illinois 60185. Failure to tender said sum within ten (10) days after receiving an invoice from the City, shall constitute a material breach of this Agreement and the City shall deduct said amount from the Hold-back defined in Section 1.03.

1.07 Property Condition. Nilkanth Varni, Inc. shall, during the term of the Possession, keep the Property in as good condition, maintenance and repair as that which existed on the date of the transfer of title to the City, less ordinary wear and tear. Nilkanth Varni, Inc. acknowledges that it is solely responsible for paying for and maintenance of all utilities serving the Property and for both interior and exterior maintenance of the premises. Nilkanth Varni, Inc. acknowledges that notwithstanding the transfer of title of the Property to the City, and the City's acceptance of same, the City shall have the right to conduct a subsequent inspection of the Property on the date of delivery of possession of the Property to the City to ensure that this provision has been followed. At the date of tender of possession, Nilkanth Varni, Inc. shall execute an affidavit attesting to the absence of any claims of lien or potential lienors known to Nilkanth Varni, Inc. and further attesting that there have been no improvements to the Property for one hundred twenty (120) days immediately preceding transfer of possession which have not been fully paid for. Nilkanth Varni, Inc. will provide copies of all reports submitted to the IEPA related to the Property (c/o the City Administrator) and any environmental reports received or provided between the time of the original Temporary Occupancy Agreement and December 31, 2016.

1.08 Deed Certification. Prior to transfer of possession, Nilkanth Varni, Inc. shall secure a deed certification from the City, for tender to the City upon transfer of possession. Costs of said certification and the requirement of a change in occupancy inspection shall be waived.

1.09 Breach. Nilkanth Varni, Inc. shall be deemed in breach of this Agreement should it fail to perform all obligations set forth herein. Specifically as to possession, unless Nilkanth Varni, Inc. has been granted a later date of possession in writing by the City on the date provided for herein in accordance with the terms set forth herein, the City shall have the right, among other legal remedies afforded to it by law, to maintain an action for emergency injunctive relief in order to take immediate possession of the Property. The parties agree that other means of possession accorded by law, including but not limited to, an action in Forcible Entry and Detainer, shall not limit in any way the City's right to gain possession through injunctive relief, and the parties agree for this purpose that money damages would be inadequate to satisfy the City's desire for immediate possession of the Property. In the event the City must sue to enforce the terms of this Agreement, Nilkanth Varni, Inc. shall be responsible for court costs and reasonable attorney's fees incurred by the City.

1.10 Access Rights. During the period of possession, the City shall have the right to access the Property upon reasonable notice to Nilkanth Varni, Inc.

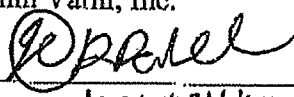
1.11 Non-Assignable. This Agreement, and the right to possess the Property, is not transferable to any other party.
