(1) Call to Order and Establishment of a Quorum.

Carol said she would pull about 4 or 5 applicant files to begin the background process for the next Academy in April. Juan asked what the goal was for how many to enter the Academy and Carol responded two. Yisnery asked if we were going to have an additional hire from 2014 and Carol responded we would go for two with this April Academy and possibly a third later in 2015. Juan requested an organization chart at least for the Police Officers from Carol. Yisnery asked when the Commission would receive the files and Carol reminded the Commission that some testing could not be done prior to 60 days of hire and then said the files might not be in February but possibly in March but would notify the Commission when the files would be ready for review and she would notify the Commission.

The Commission welcomed Sarah Schafer.

Yisnery nominated Juan for Chairman and Sarah for Secretary. The Commission elected Juan Chavez as Chairman and Sarah as Secretary. Juan stated that Carol performed the duties of the minutes etc. as appointed by the Commission.

(10) Adjournment – Commissioner Yisnery Gomes made a motion to adjourn and Chairman Juan Chavez seconded the motion to adjourn. The motion was approved and the meeting adjourned at 5:04 p.m.
