The special use permit and preliminary planned unit development, if granted, would allow the operation of an automobile service station (gas station). The subject property is located at the northwest corner of Illinois Route 59 (Neltnor Boulevard) and Illinois Route 38 (Roosevelt Road), in West Chicago, IL 60185.

The public hearing was closed after all testimony was received from the petitioner and all interested persons in the audience.
