#### CITY OF WEST CHICAGO – 475 Main Street CITY COUNCIL MINUTES Regular Meeting June 1, 2015

1. Call to Order. Mayor Ruben Pineda called the meeting to order at 7:00 pm.

2. Pledge of Allegiance to the Flag. Alderman Edwalds led all in the pledge of allegiance.

3. Invocation. The City Clerk gave the invocation.

#### 4. Roll Call and Establishment of a Quorum.

Roll Call found Aldermen James E. Beifuss, Jr., Jayme Sheahan, Laura Grodoski, Alton Hallett, Sandy Dimas, Melissa Birch, John C. Smith, Kurt Meissner, Mark Edwalds, Rebecca Stout, John F. Banas, and Noreen Ligino-Kubinski present. Aldermen Lori J. Chassee and Donald F. Earley were absent. The Mayor announced a guorum.

City Clerk Nancy M. Smith was also present.

Also in attendance were City Attorney Patrick K. Bond, Public Works Director Rob Flatter, City Administrator Michael L. Guttman, Chief of Police Mike Uplegger, and Felix Jerome Grodoski.

### 5. Public Participation.

The following person spoke during Public Participation:

Marilyn Kroll, West Chicago, said the name of her homeowner's association is the West Chicago Homeowners Association. She is unhappy with the snow cleaning in her area and would like the City take action so she does not have to endure another winter like this past one. She regretted that Community Development Director John Said was not at this meting. She also suggested that the Coffee with the Mayor include Aldermen so people can actually meet their aldermen.

The subject property was annexed into West Chicago's corporate limits in the 1990's and given Manufacturing zoning at the time of annexation. The City Council approved a special use for a gas station and car wash in 2000, which is how the site is still used today. The City recently approached the property owner regarding the potential rezoning of the subject property because the City would like to create a commercially zoned presence at this prominent intersection, which is also a southwest gateway into the City.

The existing gas station use on the subject property is an approved special use under the Manufacturing District. A gas station is also an allowable special use in B-2. The subject property's existing gas station special use zoning approval would carry over and not be affected by the proposed rezoning. The subject property was originally developed in compliance with the Manufacturing District's bulk regulations (a.k.a. setbacks). If the proposed rezoning is approved the existing car wash building adjacent to the east lot line will become legal non-conforming (a.k.a. grandfathered) with respect to its required setback from the east (side yard) lot line. The Manufacturing District requires a minimum side yard setback of twenty (20') feet, which is what the existing car wash building was originally constructed at. The B-2 District requires a side yard setback of twenty-five (25') feet. If the proposed rezoning is approved, the gas station use will be permitted to continue using the car wash building as it exists.

Please note that the subject property will also be legal non-conforming with respect to the front yard (south) and corner side yard (west) landscape setbacks due to IDOT acquiring some land from the property owner for right-of-way improvements that are currently underway. Because the land acquisition has not been finalized at this time City staff could not confirm the degree of the non-conformity based on IDOT's anticipated land acquisition. Regardless of the degree of the land acquisition, it has no bearing on the proposed rezoning because a reduction in the landscape setback would result in a legal non-conforming situation either way because the Manufacturing District and B-2 District have identical twenty (20') foot front and corner side yard landscape setback requirements. The subject

property was developed with front and corner side yard landscape setbacks of twenty (20') feet each.

The 2.3 acre subject property and the 3 acre adjacent property at the northwest corner of Roosevelt Road and Washington Street are both proposed to be rezoned to B-2 with the goal of creating a new commercial node at this prominent intersection. If the proposed rezonings of these two properties are approved, they would currently be the only properties in the surrounding area zoned B-2. The B-2 District has a minimum district size of one (1) acre; therefore each of these properties could be independently rezoned to B-2 exclusive of the other property and still comply with the B-2 District's minimum district size.

The City's Comprehensive Plan designates the subject property as Commercial. The Commercial land use designation is compatible with the proposed B-2 zoning, current use of the property (gas station), and with the City's long term development goals of creating a commercial corridor along this area of Roosevelt Road.

At its June 2, 2015 meeting, the Plan Commission/Zoning Board of Appeals (PC/ZBA) recommended approval the proposed rezoning from the Manufacturing District to the B-2, General Business District for the BP Gas Station located at 1491 W. Roosevelt Road by (6-0) vote. Their recommendation is included as Exhibit "B" of the attached ordinance.

### **ITEM SUMMARY:**

Speedway petitions for a zoning map amendment (rezoning) from the ORI, Office, Research and Light Industrial District to the B-2, General Business District for the subject property located at the northwest corner of Roosevelt Road and Washington Street. Speedway also petitions for a special use for a gas station, as well as building setback and signage variances.

The subject property is vacant, with the exception of a legal non-conforming billboard, which will be removed as part of the proposed development of the site. The subject property is approximately three (3) acres in area and is currently zoned ORI, Office, Research and Light Industrial District. The applicant is proposing to rezone the subject property to the B-2, General Business District to develop the site with a gas station. Gas stations are not an allowable use in the ORI District, but are permitted by special use in the B-2 District. The applicant did a conceptual review of the proposed development before the Development Committee in March, at which time it was determined that the subject property would be best suited for development under the City's B-2 zoning regulations. That determination was based on the use proposed as well as the City's long term development goals of creating a commercial corridor along this area of Roosevelt Road.

The three (3) acre subject property and the 2.3 acre adjacent property at the northeast corner of Roosevelt Road and Washington Street, which is currently developed as a gas station, are both proposed to be rezoned to B-2 with the goal of creating a new commercial node at this prominent intersection. If the proposed rezonings of these two properties are approved, they would currently be the only properties in the surrounding area zoned B-2. The B-2 District has a minimum district size of one (1) acre; therefore each of these properties could be independently rezoned to B-2 exclusive of the other property and still comply with the B-2 District's minimum district size. The City's Comprehensive Plan designates the subject property as Commercial. The Commercial land use designation is compatible with the proposed B-2 zoning, proposed use of the property (gas station), and with the City's long term development goals of creating a commercial corridor along this area of Roosevelt Road.

The applicant is proposing to develop the subject property as a Speedway gas station. The proposed gas station will consist of a four thousand six hundred (4,600) square foot convenience store, eight (8) automobile fueling islands located under one large canopy south of the building, and two (2) diesel fueling islands located under a smaller canopy north of the convenience store building. The site will have two (2) underground stormwater detention vaults; both located under the pavement leading to and from the diesel fueling canopy. The proposed underground fuel storage tanks are to be located under the drive aisle immediately north of the proposed convenience store building.

The subject property has three (3) access points proposed. A right-in/right-out is proposed at the southwest corner of the site to Roosevelt Road. There is also a full access point centrally located on the property's Washington Street frontage; however this access point will only allow for inbound automobiles because of the design of the traffic flow on-site and the proposed barrier median that will limit northbound Washington Street truck traffic from entering the site. This access point is designed for full access for all types of vehicles exiting the subject property though. A second shared access point is proposed at the northeast corner of site. This access point is designed as an entrance only for the adjacent asphalt plant and an exit only for truck traffic leaving the subject property. The asphalt plant has its own separate exit further east on Washington Street.

The applicant estimates approximately ninety (90) daily trips from all truck traffic, which is a comparable amount of truck traffic associated with the adjacent BP gas station located at 1495 W. Roosevelt Road. The subject property is designed to segregate all truck traffic from the remainder of the site with all trucks entering the site from westbound Roosevelt Road and exiting the site from the shared access point at the northeast corner of the subject property. Directional signage will be placed at the northeast corner of the subject property as well as on the east façade of the diesel fueling canopy indicating no westbound truck traffic is permitted from the northeast access point. In the event that a truck does perform this prohibited maneuver, a by-pass lane is being proposed along the south side of the diesel fueling canopy for the truck to safely exit the site via westbound Roosevelt Road only.

The applicant is proposing to stripe twenty-four (24) parking spaces along the south and east side of the proposed convenience store building. This does not include sixteen (16) additional unstriped spaces available at the automobile fueling pumps. All of the proposed parking complies with the City's minimum requirements for both stall dimensions and quantities required.

The applicant is proposing landscaping around the entire perimeter of the proposed development. The landscaping is a mixture of shade, evergreen and ornamental trees, shrubs and perennials, as required by City Code. The applicant is also proposing landscaping around the perimeter of the north, east, and west sides of the foundation of the building and the monuments sign, as required by City Code. All of the proposed landscaping complies with the City's minimum landscaping requirements.

The entire exterior of the proposed building will be brick. The roof access ladder will be located on the north façade and the rooftop equipment will be visually screened by being recessed into the proposed hip roof. The roofing material will be standard asphalt shingles.

The two (2) proposed fueling canopies will have exposed steel structural support columns. The flat roof canopies will have a sheet metal fascia.

The proposed trash enclosure will be five hundred seventy-six (576) square feet in area (24' x 24') and will be constructed with structural block walls and cedar plank slats on the access gates. The block walls will have a brick covering the exterior that will match what is being proposed on the convenience store building's exterior. The overall height of the enclosure will be approximately six (6) feet tall. The west façade will have double hung access gates.

The applicant is also proposing a one hundred twenty (120) square foot (10' x 12') storage shed located between the convenience store building and the diesel fueling canopy. The shed will be constructed with structural block walls. The block walls will have a brick covering the exterior that will match what is being proposed on the convenience store building's exterior. The shed will have a flat roof. The overall height of the enclosure will be approximately ten (10) feet tall.

All of the proposed architectural features of the proposed development comply with the City's Appearance Code requirements.

The applicant is proposing a total of ten (10) LED pole mounted light fixtures throughout the subject property. The lights are strategically located to provide maximum allowable illumination of the site while minimizing any light spillage off the subject property. The proposed light poles will be twentynine (29) feet in height and the light fixture will be affixed parallel to the ground. The applicant is also proposing fifteen (15) total LED wall mounted light fixtures on the building. The lights will be affixed nine (9) feet above grade and parallel to the ground. Both of the fueling canopies will also have LED light fixtures recessed into their ceilings. There will be two (2) light fixtures above each fueling station (32 light fixtures for the automobile fueling canopy and 8 light fixtures for the diesel fueling canopy). These light fixtures will be 16.5 feet above grade and affixed parallel to the ground. All of the proposed exterior lighting outlined in this subsection complies with the City's lighting requirements.

The applicant is proposing a seventy-two (72) square foot monument sign located in the southeast corner of the subject property. The proposed sign will have a six (6') foot tall brick base and a six (6') foot tall sign cabinet (an overall height of 12 feet). The sign cabinet and brick base will both be approximately twelve (12') feet wide. The proposed sign will be internally illuminated with an eighteen (18) square foot LED reader board, which is designed to only display the gas prices.

The applicant is proposing internally illuminated "Speedway" channel lettering signs on the east and west facades of both fueling canopies. Each of these canopy signs will be identical. The lettering will be 2.3 feet tall, 11.2 feet wide (25 total square feet in area), and have a red face.

The applicant is proposing eight (8) internally illuminated directional signs throughout the subject property. These signs are proposed to be five (5) square feet in area. City Code allows a maximum area of three (3) square feet. The applicant is therefore, requesting a variance to increase the maximum allowable area from three (3) square feet to five (5) square feet.

All of the proposed signage for the proposed development complies with the City's Sign Code requirements, with the exception of the directional signs, which is further outlined herein. The subject property has an existing legal non-conforming billboard on-site that will be removed in its entirety as part of the proposed development of the site.

Final Engineering has not been approved as of the completion of this staff report. However, final engineering will be approved prior to the issuance of a building permit for the site. Also, City staff does not foresee any outstanding issues that would limit or cause dramatic modifications to the site design or layout. If any significant modifications to the site design or layout are implemented then the development will have to go back through the special use approval process for further consideration.

The applicant is requesting three (3) variances as part of their zoning approval; two (2) building setback variances associated with each of the proposed fueling canopies and one (1) signage variance associated with the proposed directional signs. Specifically, the applicant is requesting a reduction in the minimum required front yard building setback from fifty (50') feet to thirty-nine (39') feet for the automobile fueling canopy. The applicant is also requesting a reduction in the minimum required rear yard building setback from twenty-five (25') feet to eleven (11') feet for the diesel fueling canopy. Lastly, the applicant is requesting an increase in the maximum allowable area of a directional sign from three (3) square feet to five (5) square feet.

The applicant is proposing the placement of both fueling canopies within the required building setbacks on the subject property in order to maximize the usable area of the site given its unique triangular shape. City staff supported both of these building setback variance requests because of the fact that both of the fueling canopies are open air structures that do not have the same mass as a typical building with walls.

The applicant is proposing eight (8) directional signs throughout the site. Each directional sign is proposed at five (5) square feet in area. The City's maximum allowable area for a directional sign is three (3) square feet. City staff did not support this requested variance because increasing the area of the directional signs by sixty (60%) percent will not make the signs more effective than designing the signs per Code. The directional signs are proposed to be located in highly visible areas of the site and will be internally illuminated making them very visible to motorists.

At its June 2, 2015 meeting, the Plan Commission/Zoning Board of Appeals (PC/ZBA) recommended approval the proposed rezoning from the ORI, Office, Research & Light Industrial District to B-2, General Business District, a special use for a gas station, and building setback and signage variances for the Speedway Gas Station located at 1501 W. Roosevelt Road by (6-0) votes. Their recommendations are included as Exhibit "B" of the attached ordinances.

Please note that while City staff recommended denial of the requested variance to increase the area of the proposed directional signage, the Plan Commission unanimously recommended approval of said variance due to the site's proposed layout and the benefit the larger directional signs would serve in aiding motorists to properly navigate the site.

The City received the objection attached letter, dated May 29, 2015, from the adjacent property owner, Dixit Patel, who owns and operates the BP Gas Station at 1491 W. Roosevelt Road. Mr. Patel also spoke against the proposed development at the June 2<sup>nd</sup> Plan Commission meeting.

#### **ACTIONS PROPOSED:**

Consideration of a rezoning from the ORI, Office, Research & Light Industrial District to the B-2, General Business District, a special use for a gas station, building setback and signage variances, and an easement abrogation for the Speedway gas station located at 1501 W. Roosevelt Road.

### COMMITTEE RECOMMENDATION:

At its June 8, 2015 meeting, the Development Committee recommended approval of the rezoning from the ORI, Office, Research & Light Industrial District to the B-2, General Business District, a special use for a gas station, building setback and signage variances, and an easement abrogation plat for the Speedway gas station proposed at 1501 W. ### ITEM SUMMARY:

Well Station No. 7, the shallow well located at 627 Hawthorne Lane, was originally installed in May 1983 by Layne-Western Company, Inc. of Aurora Illinois, with a Byron Jackson 75 HP pump with an all bronze bowl assembly and Byron Jackson Type H (mercury sealed) submersible motor set to a depth of 250 feet with six inch schedule 40 T&C coated column pipe. In 1988 the well was serviced by Layne-Western and the well assembly was reinstalled at a depth of 290 feet. The well was again serviced in 1992 and was last serviced in 2006 by Layne-Western Company, Inc.

During April of 2015, the pump output from Well Station No. 7 demonstrated uncharacteristic instability. Layne Christiansen Company, Inc. (formerly Layne-Western Company) of Aurora, Illinois was called to the site to perform an initial investigation. Layne Christiansen's testing determined that there is a probable perforation (hole) in the column pipe (i.e., piping that connects the pump to the raw water supply main) allowing water to recirculate back into the well.

At staff's request, Layne Christiansen proffered a quotation to remove the well assembly, perform all necessary inspection and repair services to the assembly, replace the failed sections of the column pipe, inspect the well hole, and to return the well to service. Layne Christiansen's quotation includes pricing to pull and inspect the well assembly, and perform a television survey of the well hole. Price estimates have also been provided for some additional typical repairs that may be necessary once the well assembly is removed from the ground and inspected (see attached). Taking a best guess approach based on past experiences with this and other well station repairs, staff estimates a repair budget of \$40,000.00 (this amount should also cover any unexpected and unforeseen expenses should they arise while making the repairs and/or during installation and testing).

Layne Christiansen Company, Inc. is the local exclusive distributor for Byron Jackson motors and pumps in our region and Layne employs factory-certified servicemen to complete the several-step procedure to properly service the motor.

Presently Well Station No. 3 is out of service being repaired by Water Well Solutions Illinois Division, LLC. In addition, Well Station No. 12 continues to experience construction delays and as of the date of this writing is not operational. With production demands likely to increase over the next few months, staff continues to be concerned with their ability to meet production demands without all well stations

operational. Therefore, getting Well Station No. 7 back on line as soon as possible is staff's recommendation. To accomplish this, staff recommends that City Council authorize the Mayor to execute a contract with Layne Christiansen Company, Inc. of Aurora, Illinois, for an amount not to exceed \$40,000.00, to perform any and all necessary repairs to Well Station No. 7.

Sufficient funds are available in the Water Fund (06-34-47-4420) to cover this expense.

#### ACTIONS PROPOSED:

Approve Resolution No. 15-R-0031 authorizing the Mayor City Council approval for the Mayor to award a contract to Layne Christiansen Company of Aurora, Illinois, for an amount not to exceed \$40,000.00, for services related to the removal, inspection, repair, installation, and testing of the well and well assembly at the City's Well Station No. 7.

### **ITEM SUMMARY:**

In July 2015 the State of Illinois Department of Transportation (IDOT) will open bids for improvements on Illinois Route 59 at the Illinois Route 38 access ramps (i.e., Michael Browning Way and Dayton Avenue). The general scope of work for this project consists of widening (i.e., adding turn lanes) and resurfacing. The project also includes drainage improvements, traffic signal installation/upgrades, thermoplastic pavement markings, and any incidental and collateral work necessary to complete the project in accordance with the project plans and specifications. Construction activities are anticipated to commence in October 2015.

Prior to the contract award, IDOT needs the City to execute an Intergovernmental Agreement that acknowledges and approves of the project, and that defines the City's cost and payment obligations for certain improvements being completed by IDOT. For the referenced project, IDOT is asking the City to pay the actual costs to modernize (upgrade) the traffic signal Emergency Vehicle Pre-emption System at the intersection of Illinois Route 59 & Michael Browning Way and Illinois Route 59 & Dayton Avenue, estimated at \$16,100.00; and the actual costs to relocate a City fire hydrant, estimated at \$4,025.00. It should be noted that although the total Agreement references an amount of \$20,125.00, there is a notation in the Agreement that final costs will be determined by multiplying the percentages referenced above by the final quantities times the actual contract unit prices plus a fifteen percent (15%) markup for construction oversight and engineering design services.

The attached Intergovernmental Agreement as prepared by IDOT is in substantially the same form as previous Agreements approved by the City.

#### **ITEM SUMMARY:**

In March 2013, Strand Associates, Inc. (Strand) was hired to perform professional engineering construction oversight services for the Well #12 Well House project. Strand's original contract defined the scope of services to be performed for a lump sum contract amount of \$55,800 (Resolution No. 13-R-0015). This contract was amended in June of 2013 (Resolution No. 13-R-0048) to reflect an additional \$5,000.00 cost for evaluation of alternative pump and motor options. The contract was further amended in November of 2013 (Resolution No. 13-R-0083), increasing the upper limit of the contract to \$112,900.00. Amendment #2 was determined to be necessary in response to unanticipated delays and additional engineering needed to respond to ComEd's changing demands related to power supply parameters and delays in obtaining required electrical control components that were caused by ComEd's changes.

Schramm Construction Corporation (Schramm) of St. Charles, Illinois, is the project general contractor. Following Amendment #2, final project completion was expected of Schramm on July 10, 2014. However, Schramm's electrical sub-contractor (Aurora Wire & Fixture) experienced significant delays in obtaining the required electrical control equipment from EATON. Schramm's well sub-contractor (Water Well Solutions) also experienced significant manufacturing delays in obtaining the pump and motor components from SunStar. The original motor was received and installed in July 2014, but failed unexpectedly during start up testing during an overnight run in inclement weather. This failure generated further project delays due to the need to transport the failed motor to the manufacturer (SunStar) in Texas for inspection and replacement. Further manufacturing delays were experienced in complying with the City's mandate for a new motor; staff would not accept a rebuilt motor.

The second motor was received and installed in April 2015. However, that motor also failed during start up testing on April 24, 2015 on a clear sunny day. The second motor was then transported to SunStar for a complete inspection and replacement; again, staff will not accept a rebuilt motor. A third new motor is currently in the production process, but we do not have an anticipated delivery date at this time.

Strand's continued involvement has been and will be necessary to protect the City's interests and to keep the project moving forward. Issues related to the two motor failures continue to be debated amongst Schramm, its subcontractors and suppliers and Strand will need to be involved in the deliberations and resolutions as the City liaison. Finally, when motor #3 is installed, tested and brought into operational status, Strand will need to provide inspection services for the City.

Recently, Strand requested additional compensation for engineering services incurred above and beyond those considered at the time of Amendment #2 signing and required to see the project completed. In addition to the issues related above, Strand has experienced additional time requirements due to Schramm's delays and required revisions to previously approved documentation. These services and their associated costs are enumerated in a letter dated June 1, 2015 (see attached) resulting in a request for an additional compensation not to exceed \$79,665.00. Amendment #1 increased the initial contract to \$60,800.00, and Amendment #2 increased the overall contract \$112,900.00. Amendment #3 will increase the overall contract by \$79,665.00 to a not to exceed limit of \$192,565.00.

The City has been tracking liquidated damages against Schramm Construction Corporation since July 10, 2014 for failure to complete the Well #12 Well House project by its amended contract completion date. The costs for Amendment #3 to Strand's contract will be paid using funds withheld from Schramm for liquidated damages.

#### ACTIONS PROPOSED:

Approve Resolution No. 15-R-0033 authorizing the Mayor to execute Contract Amendment No. 3, in the amount of \$79,665.00, to the Professional Engineering Services Contract with Strand Associates, Inc., for construction oversight services related to the 2013 Well #12 Well House Project, thus increasing the upper limit of the Contract from \$112,900.00 to \$192,565.00 and extending the contract completion date to December 31, 2015.

WHEREAS, on or about May 26, 2015, Plote Construction, Inc. (the "CONTRACTOR") submitted a written request to commence work at 6:00 a.m. Monday through Saturday, from May 2015 through November 15, 2015, for construction activities related to the Illinois Route 38/Fabyan Parkway Intersection Improvement Project (the "PROEJCT"), as being performed on behalf of and under contract with the Illinois Department of Transportation (IDOT Project No. 63849); and,

WHEREAS, the Infrastructure Committee (the "COMMITTEE") of the City of West Chicago acknowledged that allowing the CONTRACTOR to start construction activities earlier than allowed by the City Code would help to expedite all operations and project completion, would help to alleviate traffic congestion, and would help to improve safety conditions to the motoring public, and thus provided a unanimous recommendation of approval on the matter on June 4, 2015.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of West Chicago, DuPage County, Illinois, in regular session assembled, as follows:

Section 1. A deviation from CHAPTER 10 "NUISANCES\*", ARTICLE V "NOISE CONTROL REGULATION", Sec. 10-37 "Day hours" of the City Code is hereby granted for the PROJECT to allow CONTRACTOR to perform construction activities from 6:00 a.m. to 7:00 p.m. from the effective date of this Ordinance thru November 15, 2015.

<u>Section 3</u>. A deviation from CHAPTER 10 "NUISANCES\*", ARTICLE V "NOISE CONTROL REGULATION", Sec. 10-38 "Night hours" of the City Code is hereby granted for the PROJECT to allow CONTRACTOR to perform construction activities from 6:00 a.m. to 7:00 p.m. from the effective date of this Ordinance thru November 15, 2015.

Section 4. A deviation from CHAPTER 15 "PUBLICWAYS\*", ARTICLE III "CONSTRUCTION OF UTILITIES IN THE RIGHTS-OF-WAY\*", Sec. 15-24 "Construction methods and materials", (d) "Operational restrictions", (3) of the City Code is hereby granted for the PROJECT to allow CONTRACTOR to perform construction activities from 6:00 a.m. to 7:00 p.m. from the effective date of this Ordinance thru November 15, 2015.

Section 5. That all ordinances and resolutions, or parts thereof, in conflict with the

<u>Section 6</u>. That this Ordinance shall be in full force and effect from and after its passage, approval and publication in pamphlet form as provided by law.

City staff proposes to revise requirements for the annual business registration program concerning fees and penalties.		
The proposed changes to the business registration program consist of revising fees to reflect a \$25 renewal fee prior to or on December 31 of each year, with an increase to \$100 from January 1 onward. Business owners may also be assessed penalties for paying their registration fees after the required December 31 deadline.		
City staff proposes these changes to simplify administration of the program, provide a more "busi- ness-friendly" registration approach, and to more closely align with the requirements of other commu- nities in the area. Currently, the Municipal Code requires a doubling of fees each month that they are not paid, which can quickly compound and cause financial duress for business owners. Business owners that adhere to the new fee schedule, even if slightly tardy in payment, will have less of a fi- nancial burden. Finally, as detailed in the attached notes, most other communities in the area that have business registration (or business license) fees charge a nominal rate for them.

The subject company, Bluestone

The subject company, Bluestone Single Tenant Properties, is requesting economic incentives to financially assist its plans to construct a fueling center and convenience store at the northwest corner of Route 59 and Route 38 (Roosevelt Road). The Economic Incentive Agreement, as jointly prepared by City staff and Bluestone, consists of sales tax revenue sharing for the revenues to be generated by the new business at this location. During previous zoning review of this project by the Development Committee, the applicant discussed the anticipated submittal of a financial incentive request at a later date. Bluestone has recruited Thornton's to occupy the subject site, and plans to assign the incentive to Thornton's as beneficiary.

The duration of the Agreement is fifteen (15) years, with a stipulation that the agreement will begin once the convenience store opens. The City will provide a 50% rebate for that period, up to a maximum of \$1,750,000. The agreement specifies that payments shall not exceed these time and amount limitations. Should the fueling center or convenience store cease operations for one hundred eighty (180) days or longer, then sales tax distribution payments shall cease, unless the developer is engaged in a remodeling project for this location.

The Agreement recognizes the significant offsite improvements, specifically to the new Route 59/Dayton Avenue intersection to be constructed, which will be completed by Bluestone as the project developer. The project also addresses a long-term City request to close the Oak Street right of way through the subject property, which will be vacated and made part of the development site, thereby minimizing cut-through traffic between Route 59 and Roosevelt Road. These improvements will provide a public benefit for the community overall, and for traffic management in the Route 59/Roosevelt Road area specifically.

The development project also includes demolition of the existing used car dealer and law office building in this area. The removal of these buildings, along with the Oak Street closure, will provide area on the site for a future retail use to go along with the Thornton's fueling center.

The development, as previously approved by the City, consists of a fueling center, including separate diesel pumps, along with a convenience store. The attached Fiscal Impact Study, prepared for Bluestone by Strategy Planning Associates, summarizes the economic benefits associated with this pro-

posed fueling center/convenience store project.

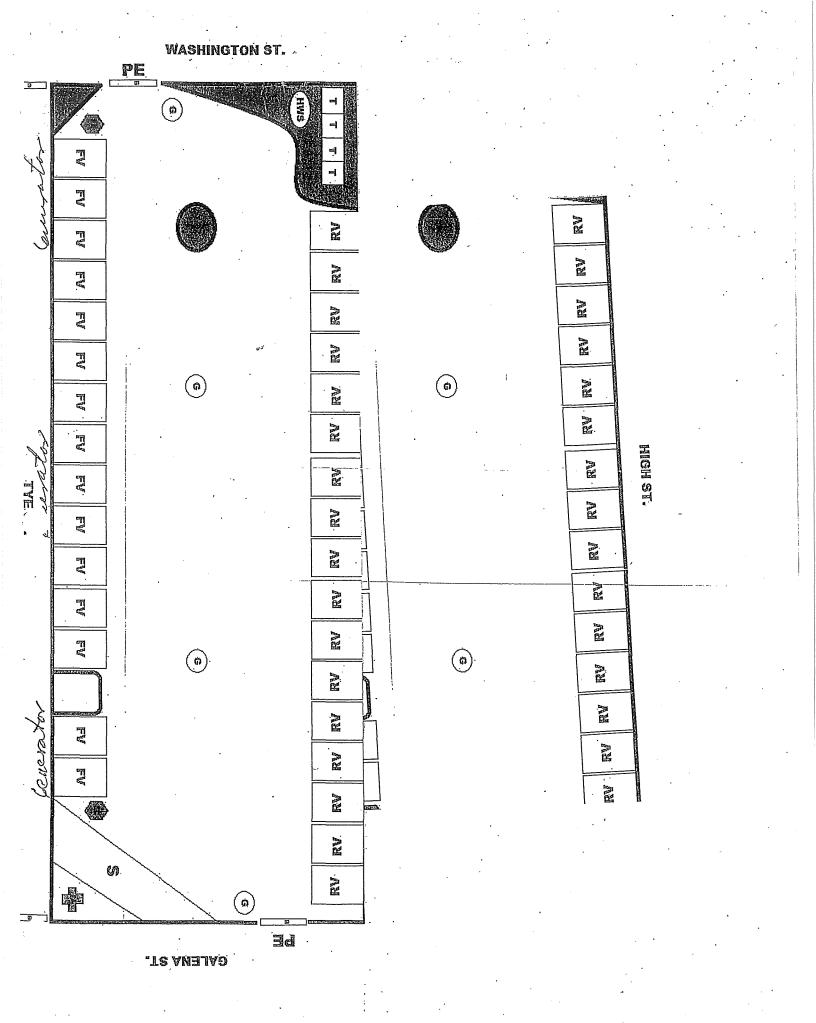
