CITY COUNCIL MINUTES
Regular Meeting
July 6, 2015

1. **Call to Order.** Mayor *pro tem* Lori J. Chassee called the meeting to order at 7:00 pm.
2. **Pledge of Allegiance to the Flag.** Alderman Earley led all in the pledge of allegiance.
3. **Invocation.** The City Clerk gave the invocation.
4. **Roll Call and Establishment of a Quorum.**

Smith, Kurt Meissner, Rebecca Stout, John F. Banas, and Noreen Ligino-Kubinski present. Alderman Mark Edwards was absent. The Mayor *pro tem* announced a quorum. Mayor Ruben Pineda was absent.

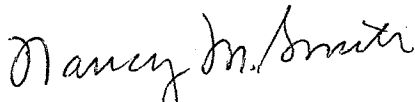
