November 2, 2015

1. **Call to Order.** Mayor Ruben Pineda called the meeting to order at 7:00 pm.
2. **Pledge of Allegiance to the Flag.** Alderman Hallett led all in the pledge of allegiance.
3. **Invocation.** The City Clerk gave the invocation.
4. **Roll Call and Establishment of a Quorum.**

Roll Call found Aldermen Lori J. Chassee, James E. Beifuss, Jr., Donald F. Earley, Jayme Sheahan, Laura Grodoski, Alton Hallett, Sandy Dimas, Melissa Birch, John C. Smith, Kurt Meissner, Rebecca Stout, and John F. Banas present. Aldermen Mark Edwalds and Noreen Ligino-Kubinski were absent. The Mayor announced a quorum.

City Clerk Nancy M. Smith was also present.

Also in attendance were City Attorney Patrick K. Bond, City Administrator Michael L. Guttman, and Chief of Police Mike Uplegger.

5. **Public Participation.** The following person spoke during Public Participation:

Marilyn Kroll, West Chicago, recapped issues she has spoken about before. She is interested in jobs, especially those where employees can walk to, and having the library and Chamber of Commerce have a job fair. She would like to see a commission for the disabled. She thanked Alderman Ligino-Kubinski for information on the lighting in her area. She would like to see a local restaurant with American and Hispanic food. She also thought the police officers and fire fighters should live in West Chicago so local residents can get the benefit of their off-duty services. She hoped people watched the YouTube video (about the City Club of Cleveland's solution to turning a town around). She thanked Alderman Chassee and Earley for all their hard work at the Lions Club breakfast. She had to walk too far though at Lehman Middle School. She would like local clergy to give the invocations, perhaps once a month.

6. **City Council Meeting Minutes – October 19, 2015.** Alderman Dimas made a motion, seconded by Alderman Banas, to approve the minutes of October 19, 2015, with no changes. Alderman Chassee thanked the community for supporting the Lions Club breakfast. She said the Bishop Street entrance is to be used for immediate access. They were able to do a number of hearing and vision screenings. The Mayor said new Eagle Scout Jonathan Butler was there as well as Troop Leader Steve Usedon, and Heide Morris.

The City Clerk announced that the Veterans Day services would be held at the American Legion. People are asked to arrive at 10:30 am. Mayor Pineda said he will be speaking and said there will be a film shown regarding Hispanic involvement in the Vietnam War.

The City Clerk said that also on Veterans Day at 1:00 pm, there will be a dedication of an anchor at the Veterans of Foreign Wars.

13. Mayor's Comments. The Mayor announced that West Chicago was working with the Metropolitan Mayors Caucus, the Metropolitan Planning Council, and the Chicago Metropolitan Agency for Planning on *Homes for a Changing Region*. This initiative provides free technical assistance for municipal leaders to chart future demand and supply trends for housing in their communities, and develop long-term housing policy plans. There will be a public meeting at City hall on Tuesday, November 17, 2015, 7:00 pm to get community input.

The Mayor said the West Chicago High School Drama students would be going to the *Edinburgh Fringe Festival* in Scotland next year to represent the United States. They are holding a fundraiser at the high school on Thursday, November 5, 2015, 7:00 pm, called, "Funny or Fringe" and will feature professional comedians who have performed on WGN, TBS, Zanies, and David Letterman. Cost is \$20.00 per person.



In accordance with the Intergovernmental Agreement (IGA) with the DuPage Airport Authority (DAA) both the DAA and City shall approve any development proposal within the DuPage Business Center (DBC). The attached Resolution includes final plans and elevations of the proposed development; preliminary plans were reviewed at the June 2015 Development Committee meeting, and preliminary approval was granted in July of 2015 by the City Council via Resolution 2015-R-0034.

As discussed in June, the site was originally approved in 2007 for development by Pella. Pella is vacating the property and Simpson Strong-Tie (SS-T) will be the new occupant. The terms of the IGA require the City Council to approve the development plan if it is in conformance with all of the controlling documents (the City's Airport Zoning District regulations and the DAA's Minimum Design Standards). City staff acknowledges that the proposed plans do comply. The DAA is tentatively scheduled to review SS-T's final development plans at their November 11th meeting.

As part of the site acquisition, SS-T proposes to expand the existing 150,000 square foot building by constructing a 7,000 square foot addition onto the northwest corner. SS-T will also be adding 15-20 tanks and silos in the existing truck dock area on the north side of the building. Lastly, SS-T will be installing a right-in only access drive at the northeast corner of the site for in-bound truck traffic. The new access drive will make their on-site trucking movements more efficient. Please refer to the attached Site Plan and Building Elevations for specific details.

This final plan approval process is the last approval step required prior to the beginning of the permit process for the construction of these proposed site improvements.

Professional custodial services are contracted for six (6) City owned and maintained facilities; City Hall, Police Station, Water Treatment Plant, Metra Station, Museum, and Grandlake Boulevard Facility. Since 2008, custodial services had been provided by Buck Services, Inc. of West Chicago, Illinois (at cost of \$79,567.50 for FY2015), by waiver of the competitive bidding process and multiple year contract awards by City Council. However, per direction of the Infrastructure Committee, professional custodial services for fiscal year 2016 were sought via the competitive bidding process. The process included the development of detailed cleaning responsibilities and frequencies for each facility, preparation of bid specifications, hosting of pre-bid meetings, verification of references, performing background checks, and awarding of a one year contract to a company determined to be lowest responsible bidder. Each contract also included provisions for up to two (2) contract extensions if pricing were held for each subsequent fiscal year, if the City were satisfied with services provided, and if approved by City Council.

The request for bids was advertised in the Daily Herald on September 29, 2015 and bids were opened on October 27, 2015. The City received four bids, with Open Works of Rosemont, Illinois submitting the lowest responsible bid proposal of \$73,464.00. The second lowest bid proposal submitted by Alpha Building Maintenance was \$75,224.00. Buck Services of West Chicago submitted two separate bids (see attached bid tabulation sheets for additional clarification).

Custodial services are budgeted and paid from various funds, depending on location for services. Adequate funds will be budgeted in the Commuter Parking Fund, the General Fund, and the Water Fund to cover future year's services.

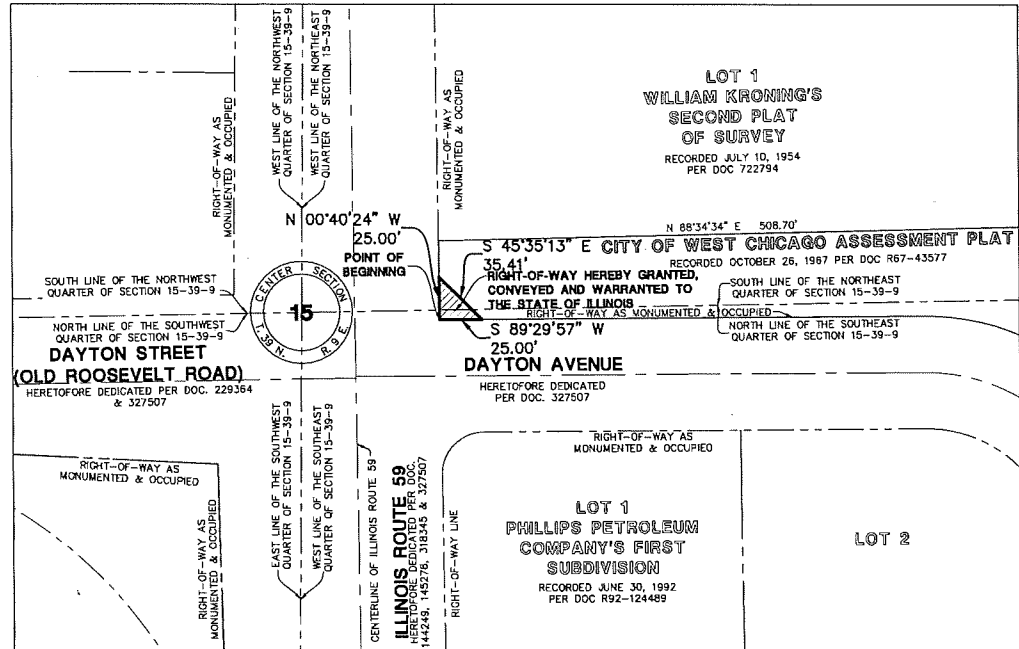

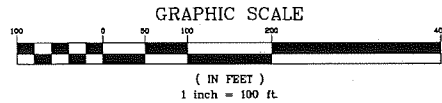

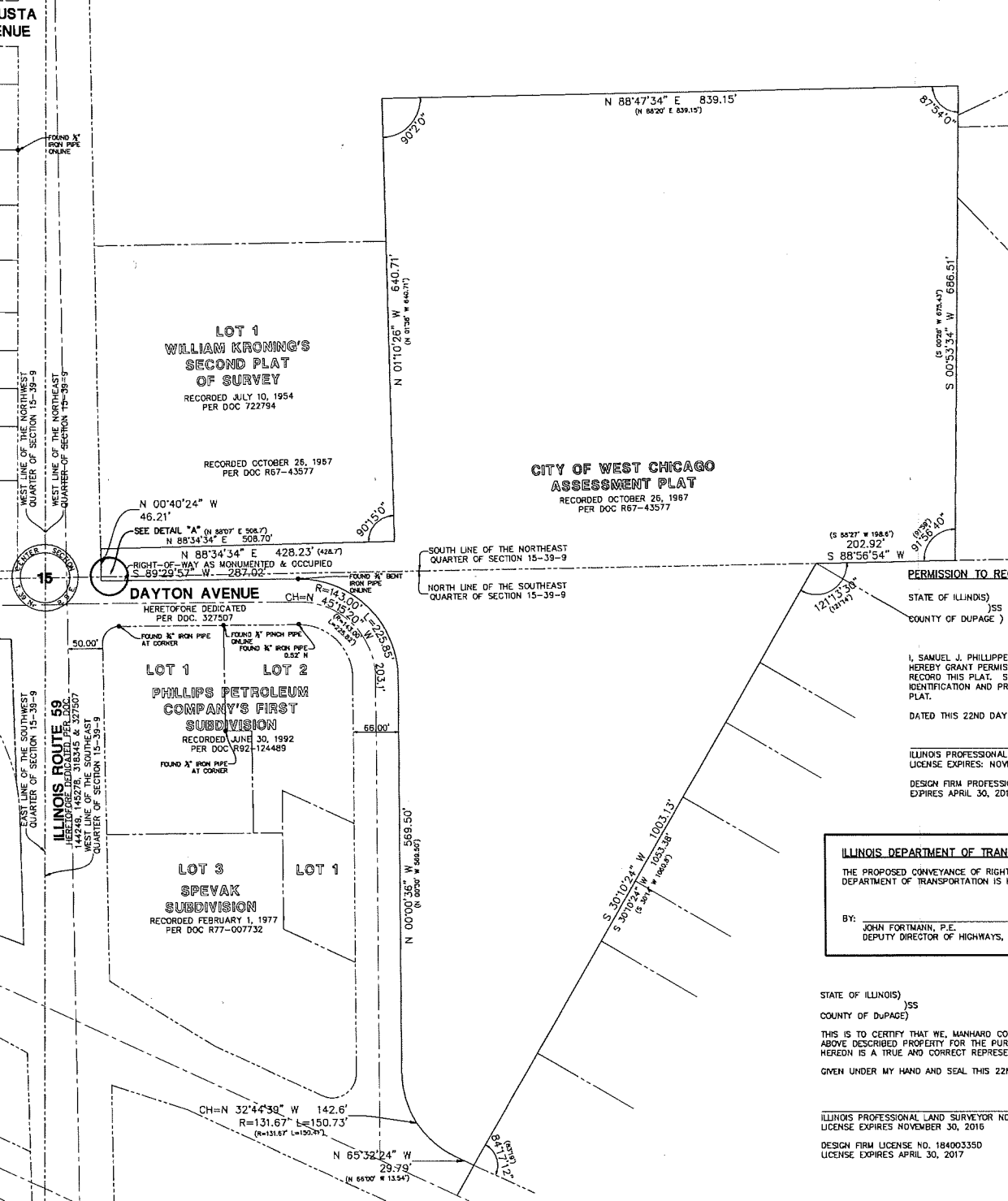
