#### **ORDINANCE NO. 16-O-0010**

#### AN ORDINANCE AMENDING THE ANNUAL BUDGET FOR THE CITY OF WEST CHICAGO, DUPAGE COUNTY, ILLINOIS FOR THE FISCAL YEAR COMMENCING JANUARY 1, 2016 AND ENDING DECEMBER 31, 2016 PASSED AND ADOPTED BY ORDINANCE NO. 15-O-0062

WHEREAS, the City of West Chicago has heretofore adopted the annual budget procedure providing for in 65 ILCS 5/8-2-9.1 through 5/8-2-9.10; and,

WHEREAS, the City of West Chicago has passed Ordinance No. 15-O-0062 passing and adopting the "2016 Proposed Budget" (ANNUAL BUDGET); and,

WHEREAS, said Ordinance No. 15-O-0062 was filed with the County Clerk of DuPage County as required by law; and,

WHEREAS, the City of West Chicago desires to revise the ANNUAL BUDGET to account for projects that the City Council approved but were not completed during the 2015 fiscal year, vehicles and equipment that were ordered but have not yet been received as well as the settlement of litigation; and,

WHEREAS, 65 ILCS 5/8-2-9.6 provides in part that by a vote of two-thirds of the corporate authorities then holding office, the annual budget of a municipality may be revised by deleting, adding to, changing or creating sub-classes within object classes and object classes themselves, provided no revision increasing the budget shall be made in the event funds are not available to effectuate the purpose of the revision.

NOW, THEREFORE, BE IT ORDAINED, by the City Council of the City of West Chicago, DuPage County, Illinois, in regular session assembled as follows:

SECTION 1. That the ANNUAL BUDGET of the City of West Chicago is hereby amended as detailed in "Exhibit A" and as summarized below:

ITEM SUMMARY:		
The City charges a fee for all change of occupancy inspections that covers the costs associated with such. Many times, owners list their property for sale, have the inspection, and then decide to remove the property from the market, and afterwards request a refund for the inspection fee (recognizing that if six months pass before the property is sold, another inspection and fee is required).		
While City staff thought it was evident that this fee should not be refunded (and has taken that position) since the City conducted an inspection (and perhaps one free re-inspection) and incurred the cost, we get challenged from time to time. Therefore, it would be best to amend the Code to include language that makes it abundantly clear that the fee is not refundable.

# AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF WEST CHICAGO – OCCUPANCY PERMIT FEES NOT REFUNDABLE

Section 1. That Section 10.1(2) of Appendix G of the Code of Ordinances of the City of West Chicago is hereby amended to add subsection (f) as follows:

"(f) All fees contained listed in Section 10.1 are not refundable."

Section 2. All ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 3. That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval, and publication in pamphlet form as provided by law.

ITEM SUMMARY:		
There are a significant amount of redundant provisions within the Boards and Commissions Section. The attached Ordinance strikes those provisions from within each Board/Commission Subsection and moves them to the beginning Section. No substantive changes have been made.		
Also, there were some ambiguous provisions regarding the selection of the chairman of each Board and Commission, and those were corrected to read as to what has been done for decades now: the Mayor has the power to appoint the chairman of each Board/Commission annually. The only substantive change that has been made is that the appointment must be done by June of each year, as opposed to the beginning of the fiscal year (which at the time this language was added to the City Code, it was May 1).

#### ORDINANCE NO. 16-O-0015

# AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF WEST CHICAGO – BOARDS AND COMMISSIONS – ADDRESSING DUPLICATIVE AND AMBIGUOUS PROVISIONS

BE IT ORDAINED by the City Council of the City of West Chicago, Illinois, in regular session assembled as follows:

Section 1. That Section 2-267 of the Code of Ordinances of the City of West Chicago, titled "Appointment" is hereby deleted in its entirety and the following language shall be substituted:

"All members of the plan commission and zoning board of appeals, building board of appeals, historical preservation commission, environmental commission and cultural arts commission shall be appointed by the mayor with the advice and consent of the city council. Any vacancy which exists in an unexpired term of a member shall be filled by appointment of the mayor, subject to the advice and consent of the city council, for the remainder of the unexpired term. Each member shall hold office as a member of a board or commission until a successor has been appointed.

All members of the civil service commission and the two resident appointees of the police pension board shall be appointed by the mayor. Any vacancy which exists in an unexpired term of a member shall be filled by appointment of the mayor, for the remainder of the unexpired term. Each member shall hold office as a member of a board or commission until a successor has been appointed.

The mayor, with the advice and consent of the city council, may remove any member who fails to regularly attend meetings without a valid reason."

Section 2. That Section 2-268 of the Code of Ordinances of the City of West Chicago, titled "Chairman Selection", is hereby deleted in its entirety and the following language shall be substituted:

"The mayor shall annually, on or before June 1<sup>st</sup> of each year, appoint one (1) member of each board and commission as chairman, unless the appointment is prescribed by state statute. A chairman may serve multiple terms as chairman. The boards and commissions shall select among themselves a secretary, assistant chairman or other positions as set out in their rules."

Section 3. That Section 2-279(c) of the Code of Ordinances of the City of West Chicago, under a section titled "Membership" for the Historical Preservation Commission, is hereby deleted in its entirety.

Section 4. That Section 2-361 of the Code of Ordinances of the City of West Chicago, titled "Established; membership" for the Board of Local Improvements, is hereby amended to replace "public works committee" with "infrastructure committee."

Section 5. That Section 2-383(a) of the Code of Ordinances of the City of West Chicago, titled "Terms of Office" for the Plan Commission and Zoning Board of Appeals, is hereby amended as follows:

- (a) the second sentence that references that the term of office will coincide with the city's fiscal year is hereby deleted; and
- (b) subsection (b) and (c) are hereby deleted in their entirety as the language was moved to Sections 2-267 and 2-268.

Section 6. That Section 2-427 of the Code of Ordinances of the City of West Chicago, titled "Terms" for the Environmental Commission, is hereby amended by deleting the second sentence as it is no longer needed since the terms of all members have already been established.

Section 7. That Section 2-437(b) and the second and third sentences of Section 2-438 (a) of the Code of Ordinances of the City of West Chicago regarding the Cultural Arts Commission, are hereby deleted in their entirety as the language was moved to Sections 2-267 and 2-268.

<u>Section 8.</u> All ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

Section 9. That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval, and publication in pamphlet form as provided by law.
