CITY OF WEST CHICAGO – 475 Main Street CITY COUNCIL MINUTES Regular Meeting December 5, 2016

- 1. Call to Order. Mayor Ruben Pineda called the meeting to order at 7:00 pm.
- 2. Pledge of Allegiance to the Flag. Alderman Stout led all in the pledge of allegiance.
- 3. Invocation. The City Clerk gave the invocation.
- 4. Roll Call and Establishment of a Quorum.

Roll Call found Aldermen Lori J. Chassee, James E. Beifuss, Jr., Alton Hallett, Sandy Dimas, Melissa Ferguson, John C. Smith, George L. Garcia, Rebecca Stout, John F. Banas, and Noreen Ligino-Kubinski present. Aldermen Jayme Sheahan, Laura Grodoski, and Kurt Meissner were absent. The Mayor announced a quorum.

City Clerk Nancy M. Smith was also present.

Also in attendance were City Attorney Patrick K. Bond, Public Works Director Rob Flatter, City Administrator Michael L. Guttman, Chief of Police Mike Uplegger, Community Development Director John D. Said, Marketing and Communications Coordinator Rosemary Mackey, and Luis A. Martinez, Community Development Business Development Coordinator.

- 5. Public Participation. No one spoke during regular public participation so the Mayor announced it was time to present the Brilliance in Business Awards.
- A. Presentation: Brilliance in Business Awards. Marketing and Communications Coordinator Mackey and Luis Martinez, City of West Chicago's Business Development Coordinator showed brief films of each of the 2016 winners of the Brilliance in Business Awards. After the film, Mayor Pineda congratulated and presented the award to each winner and thanked them for being in West Chicago.

<u>Outstanding Downtown Entrepreneurship</u>: Salud Dental, 334 S. Neltnor Boulevard. Attending were Dr. Hiren Patel, Dr. Darshil Ranpariya, and Office Manager Mukesh Pipaliya. Salud Dental has brought new energy to the east gateway of West Chicago's historic downtown. Salud Dental focuses on providing outstanding dental care, creating awareness for maintenance and preventative treatment, and alleviating some of the fear that is sometimes associated with a visit to the dentist. Within seven months of opening its doors, the practice has welcomed more than 500 patients. The trained staff also makes continuous efforts towards bringing local awareness through community dental services in local schools and healthcare facilities. The Mayor remarked how this business has been here less than a year and now has received this award.

Outstanding Growth Award: Evo Exhibits, 399 Wegner Drive. Attending was co-founder Kent Jean. The company was founded in 2009 in his basement and has now grown to a 50,000 square foot facility with an on-site fabrication shop and loading docks in West Chicago. Its creative products range from portable displays, to showroom environments, to full custom exhibits and large rental inventory. Evo provides its world wide clients with show labor, shipping, furniture/carpet, and A/V rentals replete with program management, exhibit storage and asset management. Evo was welcomed into Inc. Magazine's prestigious 5,000, an exclusive group of the fastest-growing private companies in America. The Mayor was especially proud that this business started in West Chicago and is now back in a large building.

Outstanding Growth Award: Wise Plastics Technologies, 1601 W. Hawthorne Lane. Attending were Fred Wise, President and CEO, and Lenore Tocki, Chief Finance Officer. This company was founded in 1974 and is headquartered in St. Charles, Illinois. They opened a 100,000+ square foot manufacturing, assembly, and warehousing facility in West Chicago in November 2015. The centerpiece is a 20,000 square foot environmentally controlled assembly room that can be configured to support manual, semi-automated, and fully automated assembly processes. Additional operations in West Chicago include plastic injection molding, raw material storage and finished goods warehousing and distribution. Their many markets include medical, automotive, appliance, military, lighting, and consumer products. The new jobs include machine operators, assembler, technicians, warehouse workers, engineers, and various supervisors, managers, and clerical support staff. The Mayor said he and Alderman Ligino-Kubinski are investigating and working with Union Pacific to get the rail spur behind the building operational.

Outstanding Small Business Award: Gloria's Jewelry, 178 W. Washington Street. Gloria's Jewelers is a successful family-owned business that has been a staple of West Chicago for 25 years. It has secured a tremendous reputation in the community and beyond for its quality and personal service. It credits word of mouth referrals for continued growth of its customer base. It created a niche in design and repair. It is one of the few stores that maintain a watch smith and jeweler on the premises every day for customer convenience. This year, Gloria's Jewelry implemented full in-house CAD design, with the equipment needed to produce the most intricate and detailed pieces its customers could image. Staff does everything from in-house design to molding, casting, and stone setting to produce one-of-a-kind jewelry pieces. The Mayor said Gloria's Jewelry built a brand new building across the street from their old location.

<u>Legacy Business Award</u>: The Jel Sert Company, 310 Spencer Street. Attending was Juan Chavez, Vice-President of Human Resources. This is the first year of this award which acknowledges and awards a longstanding member of the business community that honors a business that has served the community for 45 years or more and that has supported the economic vitality of West Chicago over several decades. Jel Sert is celebrating its 90th anniversary. Jel Sert is a family-owned business in its third generation of ownership and has consistently met its corporate goals while having a positive impact on the community. Jel Sert is one of the City's largest employers. Seventy-five percent of its approximately 800 employees reside in West Chicago.

The Mayor again thanked all the businesses for being in West Chicago and looked forward to a long relationship with the City.

ITEM SUMMARY:

The City of West Chicago petitions to designate, as ER-1, Estate Residence zoning district, those portions of the Wisconsin Central Railroad (a subsidiary of the Canadian National Railroad and formerly Elgin, Joliet & Eastern Railroad) that were annexed into the corporate limits in 2003. The designation of the ER-1 zoning district is being pursued in accordance with the terms of Article IV of the Annexation Agreement approved by the Corporate Authorities of the City of West Chicago on August 18, 2003 by Resolution 03-R-0082.

The subject property was voluntarily annexed into West Chicago's corporate limits in 2003. In 2003 the subject property was owned and operated by the Elgin, Joliet, and Eastern Railroad Company. Since 2003 the subject property has been acquired by another railroad (Canadian National Railroad, which is a subsidiary of the Wisconsin Central Railroad) and the terms of the annexation and the accompanying agreement are automatically binding to any successor owners. Per the terms of the annexation agreement the subject property was to be zoned ER-1, Estate Residence district. No formal ordinance establishing the ER-1 zoning designation for the subject property was ever formally approved by the City Council, which is typical because Section 6.5 of the Zoning Code (Appendix A of the Municipal Code) states that any land whose zoning designation is not specifically identified upon annexation to the City shall automatically be zoned ER-1 until such time that a different zoning classification is established by a zoning map amendment. It is believed that at that time City staff assumed that per the language in Section 6.5 the desired ER-1 zoning was properly established. However, Section 6.4 of the Zoning Code states that all railroad rights-of-way that are not given a specific zoning designation shall assume the same zoning designation as the abutting property. Current City staff has made the determination that the language in Section 6.4 supersedes the language in Section 6.5 resulting in some portions of the subject railroad property not having the desired ER-1 zoning designation because the railroad property is adjacent to land that is not zoned ER-1.

The requested zoning designation is being sought to clearly establish ER-1 zoning for the Wisconsin Central Railroad property per the agreed upon terms for the annexation of the subject property. The two specific portions of the subject property are as follows: 1) between Smith Road and the Geneva Spur of the Illinois Prairie Path, and 2) between Ann Street and a terminus westerly of the unincorporated May Street right-of-way. The City, nor the Wisconsin Central Railroad, currently has any known intentions of modifying the existing land use of the subject property in any way. Therefore, this zoning designation request is being considered a "housekeeping" procedure to ensure that the zoning that

was desired in 2003 upon the annexation of the subject property is properly implemented.

At its December 6, 2016 meeting, the Plan Commission/Zoning Board of Appeals unanimously recommended approval of the proposed designation of certain portions of the Wisconsin Central Railroad ER-1, Estate Residence zoning district by a (6-0) vote. Their recommendation is included as Exhibit "B" of the attached ordinance.

ORDINANCE NO. 16-O-0048

AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF WEST CHICAGO – APPENDIX A ARTICLE 6 OF THE ZONING CODE

WHEREAS, The City of West Chicago (the "APPLICANT") proposes an amendment to Article 6 of the Zoning Code, which is Appendix A of the Code of Ordinances of the City of West Chicago; and,

WHEREAS, Notice of Public Hearing on said application was published in the Daily Herald on or about November 18, 2016, all as required by the ordinances of the City of West Chicago and the statutes of the State of Illinois; and,

WHEREAS, a Public Hearing was conducted by the Plan Commission/Zoning Board of Appeals of the City of West Chicago, commencing on December 6, 2016, pursuant to said Notice; and,

WHEREAS, at the Public Hearing, the APPLICANT provided testimony in support of their application, and all interested parties had an opportunity to be heard; and,

WHEREAS, the corporate authorities of the City of West Chicago have received the recommendation of the Plan Commission/Zoning Board of Appeals which contains specific findings of fact, pursuant to Recommendation No. 16-RC-0018, a copy of which is attached hereto as Exhibit "A" which is, by this reference, made a part hereof.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of West Chicago, Du Page County, Illinois, in regular session assembled, as follows:

<u>Section 1</u>. That Appendix A, Article 6, Section 6.4 entitled "Zoning of streets, alleys, public ways, waterways and rights-of-way" and Section 6.5 entitled "Zoning of unclassified and annexed territory" of the Code of Ordinances of the City of West Chicago is hereby amended by deleting Sections 6.4 and 6.5 in their entirety and replacing them with the following language:

"6.4. - Zoning of public rights-of-way.

All streets, alleys, and public rights-of-way, if not otherwise specifically designated, shall be deemed to be in the same zone as the property immediately abutting upon such alleys, streets, and public rights-of-way. Where the centerline of a street, alley, or public right-of-way serves as a district boundary, the zoning of such areas, unless otherwise specifically designated, shall be deemed to be the same as that of the abutting property up to such centerline."

"6.5. - Zoning of unclassified and annexed land.

Any land whose classification is not shown on the official zoning map and land hereafter annexed to the city shall be automatically classified in the ER-1, Estate Residential District until differently classified by amendment. Streets, alleys and public rights-of-way shall comply with subsection 6.4, unless designated otherwise by ordinance."

<u>Section 2</u>. That all ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, expressly repealed.

<u>Section 3</u>. That this Ordinance shall be in full force and effect after its passage, approval and publication in pamphlet form as provided by law.

At the November 14 Development Committee meeting, three consultants (Farr, Solomon-Cordwell-Buenz and Teska) made presentations summarizing their proposals for the Central Main Street Plan Update. Prior to that meeting, City staff (City Administrator and Director of Community Development) met with the three consultants and concluded that each provided sufficiently strong proposals for further consideration.

During discussion after the presentations on November 14, a majority of Committee members expressed a general preference for Farr Associates. Committee members noted the strength of the proposal, along with the topics discussed at the November 14 meeting, as Farr's strongest supporting factors. Staff concurs with the Committee's preference, and recommends selection of Farr Associates for those same reasons. Farr's unique perspectives and abilities to offer alternative plan opportunities. track record, and City training services further support this request.

After the November 14 meeting, City staff worked with Farr Associates to reduce the project's cost by over \$10,000. At staff's request, Farr also reduced the project timeframe from ten months to eight months. The revised amount and timeframe are reflected in the attached scope of services.

After completion of the Plan Update, it is anticipated that the City can move forward with soliciting developers for acquisition and development of the City-owned sites within the Central Main Street Plan area. This will allow for a key component of Downtown revitalization to be initiated. Over time, it is hoped that the addition of residents and further development will enhance the Downtown economy and ensure long-term success.

ACTIONS PROPOSED:

City staff respectfully requests Committee concurrence with the recommendation to select Farr Associates as the consultant for the Central Main Street Plan Update.

Professional Services Agreement Central-Main Street Redevelopment Plan Update

PREAMBLE

This Agreement is made between Farr Associates Architecture and Urban Design (hereinafter "Contractor") having its principal place of business at 53 W. Jackson Blvd. Suite 650, Chicago, Illinois, and the City of West Chicago, an Illinois home-rule municipal corporation (hereinafter the "City" or "Client"; collectively the "Parties"):

WITNESSETH

FOR AND IN CONSIDERATION of their mutual promises, covenants, undertakings and agreements, the parties agree as follows:

GENERAL PROVISIONS

- Scope of Services. Contractor agrees to provide, as an independent contractor, the professional services included in Exhibit A, attached hereto and made a part hereof, as well as such other or incidental services as may be necessary to carry out said professional services, as well as any other professional services requested by the City (hereinafter the "Services"). Said Services shall be conducted in accordance with the nationally recognized standards in the industry, the expectations of the City, and the laws and regulations of the State of Illinois and the City of West Chicago. The express terms of this Agreement shall take precedence and control over any term or provision of any Exhibit that in any way conflicts with, differs from, or attempts to alter the terms of this Agreement.
- Licenses. The Services shall be provided by employees of Contractor, who are experienced, certified, and/or qualified and licensed, to the extent necessary to perform said Services in the State of Illinois.
- 3. Responsibilities of Contractor. It is understood and agreed by the parties that the Contractor is an independent contractor retained for the above-mentioned purpose. The City shall not control the manner nor the means of the Contractor's performance, but shall be entitled to a work product as described herein. The term "subcontractor" shall mean and include only those hired by and having a direct contract with Contractor for performance of work on the Project. The City shall have no responsibility to any subcontractor employed by Contractor for performance of work on the Project, and all subcontractors and material suppliers shall look exclusively to the Contractor for any payments due. The Contractor shall have the right to hire subcontractors with the prior written approval of the City which shall not be unreasonably withheld or delayed. The City will not be responsible for reporting or paying employment taxes or other similar levies that may be required by the United States Internal Revenue Service or other State or Federal agencies. Every subcontractor shall be bound by the terms and provisions of this Contract as far as applicable to their work. The Contractor shall be fully responsible to the City for the acts and omissions of its subcontractors, and shall ensure that any subcontractors perform in accordance with the requirements of this Agreement. Nothing contained herein shall create any contractual or employment relations between any subcontractor and the City. The Contractor is solely responsible for the safety procedures, programs and methods of its employees and agents and shall hold the City harmless for any and all damages resulting from violations thereof. The Contractor and its subcontractors shall comply with all applicable federal, State and local safety laws and regulations.
- 4. Compensation. Contractor will be compensated based upon the fee schedule attached hereto as Exhibit B. Total compensation to be paid the Contractor by the City shall not exceed the sum of \$118,000 for all services rendered, exclusive of reimbursable expenses. Total reimbursable expenses, including but not limited to travel shall not exceed \$2,700.00.
- 5. Payment Terms. The Contractor will submit monthly invoices at the end of each month. Payment is due within forty-five (45) days of invoice receipt. Billing will be based on actual work completed and scheduled deliveries.

Reimbursable expenses shall be itemized on each invoice at the actual cost thereof.

- 6. Ownership of Documents. Drawings, specifications, guidelines and other documents prepared by Contractor in connection with this Agreement shall be the property of the Client. However, Contractor shall have the right to utilize such documents in the course of its marketing, professional presentations, and for other business purposes with written authorization of the Client after satisfactory completion of the project.
- 7. Notices. Except to the extent that verbal notice is otherwise permitted herein, proper notice may be given from Contractor to City by personal service or certified or registered mail (return receipt requested), e-mail or facsimile transmission to:

The name and/or address to which notice is required may be amended at any time by written notice to the other party as provided herein.

- 8. Indemnification. Contractor will indemnify and hold harmless, protect and defend, at its own cost and expense, the City, its officers, officials, City Mayor and City Council, agents, employees, volunteers, representatives, assigns, successors, transferees, licensees, invitees, attorneys, or other persons or property standing in the interest of the City, from any and all risks, lawsuits, actions, damages, losses, expenses (including attorneys' fees), claims, or liabilities of any character, brought because of any death, injuries or damages received or sustained by any person, persons, or property on account of any act, omission, neglect or misconduct of Contractor, its officers, agents and/or employees, including any of its subcontractors, arising out of or in performance of any provision of this Agreement, including any claims or amounts arising or recovered under the Workers' Compensation Act or any other law, ordinance, order or decree.
- 9. Insurance. Contractor shall procure and maintain, at its own expense, during the term of this Agreement, insurance in the following types and amounts:
 - (a) Commercial General Liability Insurance with a limit of \$1,000,000 per occurrence and \$2,000,000 in the aggregate;
 - (b) Professional Liability Insurance with a limit of \$1,000,000 per occurrence and \$2,000,000 in the aggregate;

Contractor shall, at the Client's request, provide the Client with a certificate of insurance or other satisfactory evidence that such insurance has been obtained and that such policies are maintained in force throughout the term of this Agreement.

Upon the mutual agreement of Contractor and Client, Contractor shall procure and maintain one or more policies of insurance in addition to the types of insurance described above, or procure and maintain policies of insurance of the same types described above with increased policy limits, to the extent that such insurance is available. The Client, as

- an additional expense, shall reimburse additional premiums and costs incurred by Contractor in connection with obtaining such additional or different policies of insurance.
- 10. Warranty. Contractor represents and warrants to the City that it has the experience and ability to perform the services required by this Agreement, that it will perform said services in a professional, competent and timely manner, as represented and suitable for the performance of the Agreement, and that that it has the power to enter into and perform this Agreement.
- 11. Conflict of Interest. The Contractor certifies that to the best of its knowledge, no Client's employee or agent is interested in the business of Contractor or this Agreement. The Contractor further certifies that, to the best of its knowledge, no person associated with the Contractor has any interested that would conflict in any manner or degree with the performance of this Agreement. Contractor shall not accept employment or assignments from other local governments having overlapping jurisdiction with the Client for the duration of this Agreement and for a period of five years thereafter, unless specifically released in writing to do so by the Client. In addition, Contractor shall not accept employment or assignments from third parties who are proposing or opposing property developments within Client's boundaries or within one and one-half miles of such boundaries for the duration of this Agreement and for a period of five years thereafter, unless specifically released in writing to do so by Client
- 12. Time for Performance. All services and products to be provided by Contractor shall be delivered to the Client in a timely manner in accordance with the Estimated Task and Time Schedule set out in Exhibit B except for Excusable Delays, as provided herein. Contractor shall complete the delivery of all services and products to the satisfaction of the Client by 8/31/17.
- 13. Excusable Delays. Contractor and Client shall not be in default by reason of any failure in performance if such failure arises out of causes beyond the reasonable control and without the fault or negligence of the Contractor or Client, respectively. Such causes may include, but are not restricted or limited to, acts of God, or of a public enemy, acts of the government in either its sovereign or contractual capacity, fires, floods, epidemics, quarantine restrictions, strikes, illness, accidents, freight embargoes, and unusually severe weather, but in every case the failure to perform must be beyond the reasonable control and without the fault or negligence of the Contractor or the Client, respectively.
- 14. Independent Contractor. It is mutually understood and agreed, and it is the intent of Contractor and Client that an independent contractor relationship be established and is hereby established under the terms and conditions of this Agreement; that employees of the Client are not, nor shall they be deemed to be, employees of Contractor; and, that employees of Contractor are not nor shall they be deemed to be employees of Client.

15. Nondiscrimination and Affirmative Action.

- A. Consultant and all sub-contractors shall, as a party to a public contract:
 - Refrain from unlawful discrimination in employment and undertake affirmative action to assure
 equality of employment opportunity and eliminate the effects of past discrimination;
 - 2. By submission of this proposal, the Bidder/supplier certifies that he is an "equal opportunity employer" as defined by Section 2000 (e) of Chapter 21, title 42, U.S. Code Annotated and Executive Orders #11246 and #11375, which are incorporated herein by reference. The Equal Opportunity Clause, Section 6.1 of the Rules and Regulations of the Department of Human Rights of State of Illinois, is a material part of any contract awarded on the basis of this proposal.
- B. It is unlawful to discriminate on the basis of race, color, sex, national origin, ancestry, age, marital status, physical or mental handicap or unfavorable discharge of military service. Consultant shall comply with standards set forth in the Title VII of Civil Rights Act of 1964, 42, U.S.C. 2000 et seq., The Human Rights Act of the State of Illinois, 775 ILCS 5/1-101 et seq., and The Americans with Disabilities Act.
- 16. Confidentiality. Contractor shall not disclose, publish or authorize others to publish data, drawings, specifications, surveys, reports or other information pertaining to the work assigned to Contractor by the Client without the prior

written approval of the Client and shall require each of the subcontractors to sign a written agreement of nondisclosure. Following the expiration or earlier termination of this Agreement, upon receiving a written or verbal request from the Client, the Contractor shall return to the City all originals and copies of drawings, specifications, data and other material obtained by Contractor from the Client or developed by the Contractor or its subcontractors in connection with the performance of this Agreement.

- 17. Waiver. The waiver of one party of any breach of this Agreement or the failure of one party to enforce any provisions hereof, shall be limited to the particular instance and shall not operate to bar or be deemed a waiver of enforcing against other or future breaches.
- 18. Severability. If any provision of this Agreement is found to be invalid, illegal or unenforceable, that provision shall be severable from the rest of this Agreement and the validity, legality and enforceability of the remaining provisions will in no way be affected or impaired.
- 19. Modification. This Agreement shall not be modified in any manner, except by an instrument in writing executed by or on behalf of all parties.
- 20. Interpretation. This Agreement provides for services to be performed within the State of Illinois. Accordingly, this Agreement, and all questions of interpretation, construction and enforcement hereof, and all controversies hereunder, shall be governed by the applicable statutory and common law of the State of Illinois. The parties agree that for the purpose of any litigation relative to this Agreement and its enforcement, venue shall be in the Circuit Court of Cook County, Illinois and the parties consent to the *in personam* jurisdiction of said Court for any such action or proceeding.
- **21. Entire Understanding.** This Agreement sets forth all of the entire understanding of the parties relative to the subject hereof and supersedes any and all prior agreements, express or implied, oral or written. No amendment or modification of this Agreement shall be effective unless reduced to writing and executed by the parties.
- 22. Term. The effective date of this Agreement is the date the City executes the agreement by signing below. Either party may terminate this Agreement at any time and for any reason, upon providing twenty-four hours written notification. As of the date of termination, Contractor shall cease work and deliver all materials associated with the project to the City. The City will pay Contractor compensation for services completed up to the termination date.
