Christian Brothers Automotive Corporation, 17725 Katy Freeway, Suite 200, Houston, TX 77094, petitions the City of West Chicago for a special use for an automobile care center in accordance with Sections 5.5 and 10.4-5(C) of the West Chicago Zoning Ordinance. The vacant subject property is located on the west side of Neltnor Boulevard (IL Route 59) between North Avenue (IL Route 64) and Heritage Woods Drive in West Chicago, Illinois.

Martingale Road, Suite 700, Schaumburg, IL 60173, petitions the City of West Chicago for a special use to landbank required off-street parking in accordance with Sections 5.5 and 13.3(B) of the West Chicago Zoning Ordinance. The subject property is located on the south side of Western Drive at Kress Road and is commonly known as 1760 and 1860 Western Drive in West Chicago, Illinois.
