- **1. Call to Order**. Mayor Ruben Pineda called the meeting to order at 7:00 pm.
- 2. Pledge of Allegiance to the Flag. Alderman Chassee led all in the pledge of allegiance.
- **3. Invocation**. The City Clerk gave the invocation.

# 4. Roll Call and Establishment of a Quorum.

Garcia, Rebecca Stout, Bonnie A. Gagliardi, and Noreen Ligino-Kubinski present. Alderman Melissa Birch-Ferguson was absent. The Mayor announced a quorum.

City Clerk Nancy M. Smith was also present.

Also in attendance were City Attorney Mary E. Dickson, Public Works Director Rob Flatter, City Administrator Michael L. Guttman, Chief of Police Mike Uplegger, Community Development Director Tom Dabareiner, and Administrative Services Director Linda Martin.

# 5. Public Participation.

The following person spoke during Public Participation:

1) Ms. Emma Villa, 900-904 E. Roosevelt Road, West Chicago, spoke of her displeasure with the liquor licensing procedures. The Mayor advised her to call to set up a Liquor Commission meeting where she would be able to discuss the situation at length.

\* Public Hearing: 2018 Proposed Budget. The Mayor opened the public hearing at 7:08 p.m. The Mayor said the proposed budget has decreased from 2017. Because of the State's problems, the City will have to be creative to continue to maintain its fiscal soundness. He thanked the staff for all their hard work to put the budget together. Alderman Dimas made a motion, seconded by Alderman Ligino-Kubinski, to approve the above item. During discussion, Alderman Beifuss said this item came up in the Infrastructure Committee and staff recommended that we waive competitive bidding and extend the contract with Alaniz. They have had right-of-way landscaping for the last five years and they were the lowest responsible bidder in 2017. There was no consensus in the Committee meeting. Alderman Beifuss felt it should go out to bid unless there is a compelling reason not to. Putting it out to bid evens the playing field, and assures the public that it is done in a fair manner. Alderman Dimas said their service has been excellent and they were willing to keep or lower their price. There have been no complaints unlike some issues in the past. Alderman Ligino-Kubinski also said they provided good service over the years. They know the City's rights-of-way and know where they should mow, and there have been no complaints unlike the past. Alderman Chassee said in general, she would always err on the side of bidding this out, but after looking at additional information, she said their bid was \$30,000-\$25,000 lower than the next lowest bid. So coupled with good service and the lack of complaints, she now understands the reason to continue to go ahead with this contract. Mayor Pineda said the City should repay their loyalty. Other companies can do the work, but in tough economic times, Alaniz has kept their price lower. If things change next year, it can be looked at it again. He felt it was fair. Voting Aye: Aldermen Chassee, Brown, Sheahan, Ferguson, Hallett, Dimas, Meissner, Garcia, Stout, Gagliardi, and Ligino-Kubinski. Voting Nay: Alderman Beifuss. Motion carried.
