CITY COUNCIL MINUTES
Regular Meeting
January 15, 2018

1. **Call to Order.** Mayor Ruben Pineda called the meeting to order at 7:00 pm.
2. **Pledge of Allegiance to the Flag.** Alderman Ferguson led all in the pledge of allegiance.
3. **Invocation.** Alderman George L. Garcia gave the invocation in honor of immigrants on Dr. Martin Luther King, Jr. Day
4. **Roll Call and Establishment of a Quorum.**

Roll Call found Aldermen Lori J. Chassee, James E. Beifuss, Jr., Heather Brown, Jayme Sheahan, Michael Ferguson, Alton Hallett, Sandy Dimas, Kurt Meissner, George L. Garcia, Rebecca Stout, Bonnie Gagliardi, and Noreen Ligino-Kubinski present. Alderman Melissa Birch-Ferguson was absent. The Mayor announced a quorum.

City Clerk Nancy M. Smith was also present.

Also in attendance were City Attorney Patrick K. Bond, Public Works Director Rob Flatter, City Administrator Michael L. Guttman, Chief of Police Mike Uplegger, Community Development Director Tom Dabareiner, and Administrative Services Director Linda Martin.

5. **Oath of Office:** City Clerk Smith administered the oath of office to newly appointed Matthew E. Garling as Alderman in Ward 5 for the Unexpired Term Ending April 30, 2019. Alderman Garling then took his seat at the Council. The Mayor said it is always exciting when a new Alderman takes the oath of office. It takes commitment and a lot of time and effort in this job. There is now a full council. The Mayor said the City has a great Council that works well together and will get a lot of work done. He said Alderman Garling has done a lot of good things in the community and he welcomed him.

6. **Public Participation:** The following people spoke during Public Participation:

1) Connie Schmidt, Sierra Club, 3S501 Landon Avenue, Warrenville, IL 60555-3618, spoke about the Clean Energy Forum to be held January 29, 2018, at IBEW Local 701 Hall, 28600 Bella Vista Parkway in Warrenville from 6:00 – 9:00 p.m. The Forum will explain the impact of the Future Energy Jobs Act (FEJA) passed by the State of Illinois to stimulate job creation and provide opportunities to strengthen local economies by expanding solar/renewable energy programs. Ms. Schmidt invited everyone to attend.

2) The Mayor said a great business has come to West Chicago, a Cuban/Puerto Rican restaurant. Alderman Garcia, with Alderman Stout, introduced Pablo and Gloria Araujo, owners of the new *Treasures of the Caribbean Restaurant* at 960 E. Roosevelt Road. Alderman Garcia said they bring a whole new flavor to West Chicago. The Mayor thanked them for opening in West Chicago as a lot of people like Cuban/Puerto Rican food. Ms. Araujo said they have many plans for the restaurant including opening up a patio, having music and dancing, and providing daily specials.

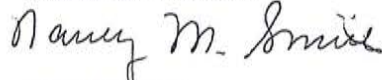
