MINUTES

INFRASTRUCTURE COMMITTEE

May 3, 2018 7:00 P.M.

1. Call to Order, Roll Call, and Establishment of a Quorum. Chairman Beifuss called the meeting to order at 7:00 P.M. Roll call found Aldermen James Beifuss, Heather Brown, Sandra Dimas, George Garcia, Matt Garling, and Alton Hallett present. Alderman Noreen Ligino-Kubinski was absent.

Staff present included Director of Public Works Robert Flatter and Administrative Assistant Ashley Cunningham.

2. Approval of Minutes

A. Infrastructure Committee Minutes of April 5, 2018. Alderman Brown made a motion, seconded by Alderman Hallett to approve the Meeting Minutes of April 5, 2018.

Voting Yea: Aldermen Beifuss, Brown, Dimas, Garcia, Garling, and Hallett. Voting Nay: 0.

3. Public Participation / Presentations. None.

4. Items for Consent. Alderman Beifuss requested discussion on Consent Item B. Alderman Dimas made a motion, seconded by Alderman Garling to approve:

- A. Resolution No. 18-R-0032 Contract Award Schroeder & Schroeder, Inc. for the 2018 Sidewalk, Curb, and Gutter Maintenance Program
- C. 2018 Asphalt Materials Procurement DuPage County Joint Purchasing Program – Plote Construction, Inc.
- D. Purchase of Four 2018 Ford Utility AWD Police Interceptor Vehicles Currie Motors, Frankfort, Illinois

Roll call found the vote unanimous for approval. Voting Yea: Aldermen Beifuss, Brown, Dimas, Garcia, Garling, and Hallett. Voting Nay: 0.

5. Items for Discussion.

4.B. Resolution No. 18-R-0033 – An Intergovernmental Agreement Between the City of West Chicago and the County of DuPage, Illinois, for the Implementation of the National

Pollutant Discharge Elimination System Program in the West Branch. Alderman Beifuss wanted a brief summary of this item and to clarify if the City would save money by participating. Mr. Flatter explained that all municipalities in DuPage County, along with the County of DuPage, are required to apply for and maintain a National Pollutant Discharge Elimination System (NPDES) Phase II Storm Water Permit. The General NPDES Permit No. ILR40 authorizes discharges from municipal separate storm sewer systems (commonly referred to as MS4). The Permit also requires development, implementation, and enforcement to the maximum extent practicable to protect water quality, and to satisfy the appropriate water quality requirements. The MS4 storm water program requires applicants to submit an application or Notice of Intent (NOI) to the Illinois Environmental Protection Agency (IEPA) along with a storm water management plan that identifies the best management practices (BMPs) and measurable goals for six minimum control measures, along with a timetable for implementation and the person(s) responsible for implementation. Recently, DuPage County has received approval to formally submit a Countywide NOI. Under the Countywide ILR40 permit, DuPage County will submit the NOI and obtain the ILR40 permit, take the lead on all six control measures, and pay the annual fee. In return, the City will be required to execute an Intergovernmental Agreement (IGA) with DuPage County for the implementation of the NPDES program. Under this Agreement the City will save \$1,000.00 annually since DuPage County will be paying the fee on behalf of all participants. Alderman Garling made a motion, seconded by Alderman Dimas to approve.

Voting Yea: Aldermen Beifuss, Brown, Dimas, Garcia, Garling, and Hallett. Voting Nay: 0.

6. Unfinished Business. Alderman Beifuss inquired about the status of Elm Road's reconstruction. Mr. Flatter noted that a complete review of the 2018 Elm Road Rehabilitation Project will be brought before the Infrastructure Committee in June, but in the meantime a Neighborhood Information Meeting will be held on May 17 to discuss and encourage residents to quitclaim deed the public right-of-way to the City.

7. New Business. None.

8. Reports from Staff.

A. DuPage County's CH55 / Great Western Trail Extension from Sassafras Drive to Illinois Prairie Path – Use of City's Streets During Construction. DuPage County has received federal funding from the State to extend the Great Western Trail west from behind the Forest Trails Subdivision near Prince Crossing Road to Sassafras Drive. The County is looking to start the project around June 1, and the only way to access this path is through Sassafras Drive. They have requested permission to use Atlantic Drive, Shingle Oak Drive, Sandcherry Lane, and Hemlock Lane for construction purposes to bring trucks in and out of Preston Fields Subdivision to access this portion of the Trail. Staff has reviewed the plans, and this is the only logical location for them to work on this extension. The County has already been given permission to use these streets during the process, but Mr. Flatter wanted to share this with the Committee for informational purposes.

B. ComEd's Smart LED Street Lighting Program. Mr. Flatter noted that Alderman Ligino-Kubinski worked with Mayor Pineda to help facilitate this program for West Chicago. All ComEd owned streetlights will be changed to LED lights at no cost to the City. By switching these streetlights to LEDs, ComEd is estimating that the City will see a \$22,000.00 energy savings annually. Alderman Dimas asked if there were any LED streetlights installed already, and Mr. Flatter explained that they were in various parts throughout the City. Alderman Brown asked if they were much brighter than the old bulbs. Mr. Flatter said that was dependent upon the wattage, which is why Public Works has been experimenting with different wattages in the Arbors Subdivision. The primary difference is color; LEDs are not vellow like the high pressure sodium bulbs, which can make them appear brighter. However, LEDs have a more direct cast and light concentration than the old bulbs which have more of a glow around them. Alderman Dimas inquired about how these might affect light pollution. Alderman Beifuss commented that the Environmental Commission has been pushing for a Dark Sky initiative to decrease light pollution in the area. Mr. Flatter noted that it began as a campaign to reduce residential light pollution but has since expanded to campaign for less municipality lighting as well. This could create safety issues, however, if not executed carefully.

9. Adjournment. At 7:35 P.M., Alderman Hallett made a motion to adjourn, seconded by Alderman Dimas. Motion was unanimously approved by voice vote.

ITEM SUMMARY:	

City staff has identified surplus equipment, stock inventory, and/or personal property that has no useful life and is no longer useful to the City, has little or no salvage value, and should be properly disposed of (please refer to Ordinance No. 18-O-0027 and Attachment A for additional information).

ORDINANCE NO. 18-O-0027

AN ORDINANCE AUTHORIZING THE DISPOSAL OR SALE OF SURPLUS EQUIPMENT, STOCK INVENTORY, AND/OR PERSONAL PROPERTY OWNED BY THE CITY OF WEST CHICAGO

WHEREAS, in the opinion of the corporate authorities of the City of West Chicago, it is no longer necessary or useful to or for the best interests of the City of West Chicago, to retain ownership of the surplus equipment, stock inventory, and/or personal property hereinafter described; and,

WHEREAS, it has been determined by the City Council of the City of West Chicago to properly dispose of said surplus equipment, stock inventory, and/or personal property.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of West Chicago, Illinois, in regular session assembled as follows:

SECTION I. Pursuant to 65 ILCS 5/11-76-4, the City Council of the City of West Chicago finds that the surplus equipment, stock inventory, and/or personal property listed on Attachment A are no longer necessary or useful to the City of West Chicago and the best interests of the City of West Chicago will be served by their disposal.

<u>SECTION 2.</u> Pursuant to said Statute, the City Administrator is hereby authorized and directed to dispose of the aforementioned surplus equipment, stock inventory, and/or personal property in any manner deemed appropriate, with or without consideration.

SECTION 3. All ordinances and resolutions, or parts thereof, in conflict with the provisions of this Ordinance are, to the extent of such conflict, hereby repealed.

<u>SECTION 4.</u> That this Ordinance shall be in full force and effect ten (10) days from and after its passage, approval, and publication in pamphlet form as provided by law.

ITEM SUMMARY:				

The 2018 Sherman Street Area Resurfacing Project, as prepared by the City's engineering consultant Thomas Engineering Group (TEG), consists of approximately 0.39 miles of roadway resurfacing on Sherman Street between Stimmel Street and Ann Street, and on Stimmel Street and Blair Street between the Pearl Street right-of-way extended and the CN Railroad Tracks. The project's work generally consists of pavement milling, hot-mix asphalt (HMA) resurfacing, full-depth HMA pavement patching, intermittent concrete sidewalk, curb ramps, and combination concrete curb and gutter removal and replacement, utility structure adjustments, installation of area reflective and strip reflective crack control treatment, parkway restoration, Thermoplastic pavement markings, and all incidental and collateral work necessary to complete the project as shown on the project plans and detailed in the project specifications.

The request for bids was advertised in the Daily Herald on May 8, 2018, and bids were opened on May 29, 2018. There were eight plan holders, and the City received six bids with A Lamp Concrete Contractors, Inc. of Schaumburg, Illinois, submitting the lowest responsible bid of \$234,886.44. The second lowest bid was submitted by Chicagoland Paving Contractors, Inc. of Lake Zurich, Illinois, for \$247,900.00. The engineer's estimate of probable cost was \$234,584.69 (see attached bid tabulation sheet for additional clarification).

A Lamp Concrete Contractors, Inc. has satisfactorily performed similar work for the City for its 2014 Alta Vista Gardens Rehabilitation Project. TEG also called several of A Lamp's project references and responding agencies provided satisfactory references. A Lamp Concrete Contractors, Inc. is registered by the Illinois Department of Transportation as a prequalified contractor.

It is staff's recommendation that a contract be awarded to A Lamp Concrete Contractors, Inc. of Schaumburg, Illinois, for the 2018 Sherman Street Area Resurfacing Project, for a contract amount not to exceed \$234,886.44.

The cost of this project will be paid from the Capital Projects Fund (08-34-53-4807) where \$1,283,200.00 has been budgeted for street improvements in 2018.

Approve Resolution No. 18-R-0043 authorizing the Mayor to execute a Contract with the lowest responsible bidder, A Lamp Concrete Contractors, Inc. of Schaumburg, Illinois, in an amount not to exceed \$234,886.44 for the 2018 Sherman Street Area Resurfacing Project.

The 2018 Asbestos and Lead Based Paint Abatement Project, located at 200 Main Street, as prepared by the City's environmental consultant, Midwest Environmental Consulting Services, Inc. (MEC), includes, but is not limited to, the removal of asbestos containing material utilizing gross removal methods within a full containment work area, and scraping and stabilizing of all lead-based paint (LBP) within the work area. ITEM SUMMARY:

The 2018 Contractual Street Striping Program consists of pavement marking removal and installation of thermoplastic pavement markings on Atlantic Drive between the UP Railroad and North Avenue (Illinois Route 64), at the Wilson Street and Joliet Street Intersection (shifting stop bars to improve stopping sight distance), and at the Hawthorne Lane and Prince Crossing Intersection (shifting stop bar for the east leg to improve stopping sight distance). The Program will also include installation of Urethane pavement markings on Washington Street between Roosevelt Road (Illinois Route 38) and Neltnor Boulevard (Illinois Route 59).

Since 2012, the City has participated in a joint purchasing program to procure the services of pavement marking contractors. This year, unit pricing is being offered through two joint purchasing programs; the Suburban Purchasing Cooperative (SPC), and the DuPage County Joint Purchasing Program organized by the DuPage County Division of Transportation. The SPC Joint Purchasing Program is sponsored by the Northwest Municipal Conference, DuPage Mayors and Managers Conference (West Chicago is a member), South Suburban Mayors and Managers Association, and Will County Governmental League, together representing over 150 municipalities, townships and other governmental agencies. A Thermoplastic Road Striping or Lane Marking Program is one of many programs for which SPC has procured joint purchase pricing through a competitive bidding process. The DuPage County Joint Purchasing Program allows participating local agencies to utilize the bid results offered under DuPage County's competitive bid process.

FY 2018, Superior Road Striping, Inc. holds a joint purchasing contract through both the SPC and the DuPage County programs. Based on a comparison of unit prices between the SPC and DuPage County, using the City's plan quantities for 2018, the pricing offered under the DuPage County Joint Purchasing Program provides the lowest cost to the City. After careful consideration, City staff recommends that the City participate in the DuPage County Purchasing Program by awarding a contract to Superior Road Striping for an amount not to exceed \$40,000.00.

Superior Road Striping, Inc. has satisfactorily performed work on previous City projects and is an IDOT Prequalified Firm.

It is staff's recommendation that City Council award a contract to Superior Road Striping, Inc. of Melrose Park, Illinois, for the 2018 Street Striping Program, using pricing obtained from the DuPage County Joint Purchasing Program, in an amount not to exceed \$40,000.00. This year's program will be paid for using Capital Project Funds (08-34-53-4869).

ITEM SUMMARY:	

For FY 2018, or for the 2018-2019 winter season, City staff participated in the DuPage County Rock Salt Purchasing Program for the purchase of rock salt. On Monday, March 19, 2018, City staff submitted information to DuPage County of the City's intent to participate in its Rock Salt Purchasing Program for the purchase of 2,000 tons of rock salt (1,600 tons (80%) minimum purchase required and 2,600 tons (130%) maximum purchase guaranteed available).

On Wednesday, April 25, 2018, DuPage County opened bids for RFP#18-093-JM. Four bids were received with Detroit Salt Company, LLC of Detroit, Michigan, submitting the lowest responsible bid of \$67.15 per ton of rock salt delivered (see attached bid tabulation sheet). On Monday, May 7, 2018, DuPage County advised all program participants that it would be awarding its 2018-2019 salt procurement contract to Detroit Salt Company, LLC of Detroit, Michigan. Detroit Salt Company has requested a contract/commitment from the City of West Chicago by Monday, July 23, 2018.

Based upon pricing received under the DuPage County Rock Salt Purchasing Program, City staff recommends that City Council authorize the purchase of up to 2,600 tons of rock salt, at the price of \$67.15 per ton delivered, from Detroit Salt Company, LLC, of Detroit Michigan for the 2018-2019 winter season under the DuPage County Joint Purchasing Program.

Purchase History:

- For FY 2017, or the 2017-2018 winter season, the City paid \$51.49 per ton of rock salt delivered under the DuPage County Rock Salt Purchasing Program.
- For FY 2016, or the 2016-2017 winter season, the City paid \$56.35 per ton of rock salt delivered under the DuPage County Rock Salt Purchasing Program.
- For FY 2015, or the 2015-2016 winter season, the City paid \$70.44 per ton of rock salt delivered under the DuPage County Rock Salt Purchasing Program.
- For FY 2014, or the 2014-2015 winter season, the City paid \$112.69 per ton of rock salt delivered under the CMS program (State of Illinois Program).

DuPage County has shared that they initially requested that Detroit Salt Company honor its 2017-2018 salt pricing for the 2018-2019 winter season; Detroit Salt Company refused stating that pricing will increase due to last year's high demand causing low inventory and increased production costs, resulting in a 30% price increase.

ACTIONS PROPOSED:

That the West Chicago City Council authorize the purchase of up to 2,600 tons of rock salt, at the price of \$67.15 per ton delivered, from Detroit Salt Company, LLC, of Detroit, Michigan, under the DuPage County Rock Salt Joint Purchasing Program for the 2018-2019 winter season.


