The Western DuPage Chamber of Commerce is proud to again be hosting the 49th Annual Railroad Days Parade, Saturday, June 8, at 3:00 pm.

Parade theme:

“METAMORPHOSIS”

The West Chicago Parade committee has agreed to provide float judging; prizes will be awarded in a variety of categories:

Heritage Award: The float that shows the most spirit and enthusiasm.

Turner Award: The float that most creatively communicates what the business or organization does.

Grand Marshal Award: The float that best represents the parade theme.

- The parade group will assemble at 2:00 PM.
- Step-off time is 3:00 pm sharp!
- The parade route is approximately 1 mile in length.

Attached please find an application and parade guidelines/rules, which all participants must follow. Return your completed application with a brief narrative describing your group by Tuesday, May 28, 2019.

Contract Participants: We have limited space and budget, so those submitting early will receive top priority. Your application will be given approval/rejection within two weeks of date received.

GUIDELINES & RULES SECTION

Guidelines:

(A) The parade will step off promptly at 3:00 pm from the corner of Ingaltion and Elmwood Streets. All parade units must assemble at their assigned starting locations by 2:00 pm. Parade participants that are not in their assigned parade formation 15 minutes before step-off will not be allowed to participate and will be asked to leave **(no exceptions)**.

(B) Line-up positions will be determined by the Chamber of Commerce. We will attempt to accommodate requests as possible based upon special needs (not everyone can be in the front of the parade).

(C) Units in the parade should attempt to maintain even spacing, not to exceed 20 feet, between entries. Please advise us if special spacing is required. Motor vehicles must be operated in a responsible manner.

(D) "Antique" vehicle entries must be 25 years or older. Newer model entries will be limited to 10 vehicles at the discretion of the parade committee.

(E) Animal Entries: **ALL ANIMAL ENTRIES MUST PROVIDE THEIR OWN CLEAN-UP CREW!**

(F) Those requesting an honorarium, please line up at your designated starting location. We will bring checks to you.

Rules:

(1) The use or possession of **ALCOHOLIC BEVERAGES** by participants in the parade is **PROHIBITED. NO SMOKING IS ALLOWED IN THE PARADE.**

(2) The use of all water devices is prohibited.

(3) **HANDOUTS:** (a) items to be distributed during the parade must be approved in advance. Please note on your application what you will be distributing and please keep in mind that these items often end up in the hands of small children. (b) Approved items should be handed out, not thrown. For your safety and the safety of the children, we ask you to walk alongside the curb when distributing approved items. We do not want children running into the street in front of parade vehicles.

Please note that any violation of these rules and guidelines will result in excluding your participation with future Railroad Days parade or your immediate removal from the parade. We want everyone to safely enjoy the parade and have fun.
