September Is National Suicide Prevention + Action Month

PROCLAMATION

WHEREAS, September is known around the United States as “National Suicide Prevention Awareness Month”, most of us are quite aware of suicide. **National Suicide Prevention + Action Month** is intended to help promote and give attention to the Suicide Prevention services available to us and our community. The goal is to speak openly about the topic of suicide to help erase the stigma surrounding it, and to direct those in need to the appropriate support services; and

WHEREAS, Suicidal thoughts can affect anyone regardless of age, gender, race, orientation, income level, religion, or background; and

WHEREAS, According to the American Foundation for Suicide Prevention (AFSP), more than 47,000 people died by suicide in the year 2017; and

WHEREAS, Suicide is the 10th leading cause of death among adults in the US, and nearly 20% of all suicides were completed by people ages 45-54; and

WHEREAS, **West Chicago, Illinois** is no different than any other community in the country, but chooses to publicly state and place our full support behind local educators, mental health professionals, athletic coaches, pack leaders, police officers, and parents, as partners in supporting our community in simply being available to one another; and

WHEREAS, local organizations like Suicide Prevention Services (SPS), national organizations like the National Alliance on Mental Illness (NAMI) and international groups like Hope For The Day (HFTD) are on the front lines of a war that many still refuse to discuss, as suicide and mental illness remain too uncomfortable of a topic to talk about; and

WHEREAS, every member of our community should understand that throughout life’s struggles we all need the occasional reminder that we are all fighting our own battles; and

WHEREAS, I encourage all residents to take the time to check in with their family, friends, and neighbors on regular basis and to honestly communicate their appreciation for their existence by any gesture they deem appropriate. A simple phone call, message, handshake, or hug can go a long way towards helping someone realize that suicide is not the answer.

NOW, THEREFORE, be it resolved that I, **Ruben Pineda**, do hereby proclaim the month of September 2019, as National Suicide Prevention Awareness Month in the City of West Chicago.

CITY COUNCIL MINUTES
Regular Meeting
August 19, 2019

1. **Call to Order.** Mayor Ruben Pineda called the meeting to order at 7:00 pm.
2. **Pledge of Allegiance to the Flag.** Alderman Garling led all in the pledge of allegiance.
3. **Invocation.** The City Clerk gave the invocation.
4. **Roll Call and Establishment of a Quorum.**

Roll Call found Aldermen Lori J. Chassee, James E. Beifuss, Jr., Heather Brown, Jayme Sheahan, Michael D. Ferguson, Sandy Dimas, Christopher Swiatek, Matthew E. Garling, Jeanne M. Short, Bonnie A. Gagliardi, and Noreen Ligino-Kubinski present. Aldermen Alton Hallett, Melissa Birch-Ferguson, and Rebecca Stout were absent. The Mayor announced a quorum.

City Clerk Nancy M. Smith was also present.

Also in attendance were City Attorney Sean Conway, Acting City Administrator Linda Martin, Chief of Police Mike Uplegger, and Community Development Director Tom Dabareiner. City Administrator Michael L. Guttman was absent.

5. **Public Participation.**

A. Presentation: Railroad Days Parade Awards. The Mayor called upon David Sabathne, CEO and Executive Director of the Western DuPage Chamber of Commerce and Industry, to make the presentation. Mr. Sabathne thanked the Mayor for the opportunity to present the Railroad Days parade award recipients to the community. He noted the challenges in the date change and wanting to go with the butterfly theme. The theme evolved into change and metamorphosis. He said working with the parade was his honor and then he asked Mayor Pineda to help present the awards. The Turner Award went to Smile View Dental. Accepting the award was Dr. Reem Shafi and her assistant, Anna. The Heritage Award went to the West Chicago Elementary School District 33 Ballet Folklorico. Many of the members were there. The Grand Marshal award went to a person that has represented our community for many years, Richard Truitt. Mayor Pineda said former Mayor Truitt was a mentor of his, and got him involved in cleaning the Boy Scout cabin at Reed-Keppler Park. Mayor Truitt of West Chicago did many things. The big prairie in West Chicago is named after him. He is a World War II veteran. He should be thanked for what he did to give us freedom. Former Mayor Truitt then spoke. He said he turned 95 a few weeks ago. His family wanted to give him a special treatment so a bagpiper came in and played for him. Mayor Truitt said he was 19 years old when he landed at Normandy, and he spent 300 days on the front. He went through the Battle of the Bulge. He taught school for 30 years and started many building and instigation of organizations in West Chicago with the help of a lot of people. His wife passed away a few years ago. She was a World War II nurse. He has six children, two of which were here tonight. At the request of his son, the bagpiper played Danny Boy, a song that his grandmother used to sing to him. Mayor Truitt got a standing ovation.

After all the people left, the City Clerk announced that as of forty-one years and five minutes ago, Alderman Ferguson and his wife, Diane, said their "I do's."

During discussion, Alderman Garling said in Item 10. he did not vote for the approval of the special event permit so his name should be deleted as voting aye. Aldermen Chasse and Swiatek amended their motion to approve the amended minutes.

Voting Aye: Alderman Chassee, Beifuss, Brown, Ferguson, Dimas, Swiatek, Garling, Short, Gagliardi, and Ligino-Kubinski. Voting Nay: 0. Alderman Sheahan abstained. Motion carried.

7. **Corporate Disbursement Report.** Alderman Dimas made a motion, seconded by Alderman Garling, to approve the August 19, 2019, Corporate Disbursement Report in the amount of \$811,130.79. Voting Aye: Aldermen Chassee, Beifuss, Brown, Sheahan, Ferguson, Dimas, Swiatek, Garling, Short, Gagliardi, and Ligino-Kubinski. Voting Nay: 0. Motion carried.



ITEM SUMMARY: In 2015, the Finance Committee endorsed a package of incentives to attract larger businesses to our community, which included a partial property tax abatement, partial rebates of utility taxes and a partial waiver of building permit fees. Alton Industry Ltd. Group is looking to construct a 140,000-160,000 square foot building on between 10-23 acres in the DuPage Business Center and move its office/warehousing operation from Batavia, Illinois. The incentives tentatively agreed to by the parties include the following: (1) a 50% property tax abatement for 10 years, up to \$4,000,000 by District 33, District 94, the Fire Protection District, the Library District, the DuPage Airport Authority and the City; and (2) a waiver of 50% of the building permit fees by the City (excluding the sewer capacity charge and third party fees paid for by the City). In return for the incentives, the building would need to remain operational for 15 years, or else there are clawback provisions that would result in portions of the incentives being repaid, the amount determined by the number of years the building was occupied. These are the same incentives given to Suncast, Norix and Ball Horticultural, but in those, there was an incentive for a utility tax rebate of there was a manufacturing component.
