Good afternoon,

I'm writing to you with our concerns with a new waste treatment facility in our area. After reading Lakeshore Recycling's proposal, it appears as though they have covered their bases for the most part. One point does concern us, though. With Kress Creek and some wetlands are on their property - albeit at the edges - there is a potential for water contamination. LRS stated that they have never had an issue with leakage, and therefore it shouldn't be a concern. What they currently recycle, which is construction debris, is much different than garbage debris and hydro-excavation waste. Since water contamination does not stay in a set area, but travels far and wide, and with nearly 2,000 additional daily tons of this new waste going to their facility there is a much greater risk of contamination for citizens and wildlife. As you well know removal of contaminants in water and ground is expensive and it is not possible to completely remove all carcinogens from those areas. LRS states that they will have measures in place to mitigate any bleeding into those areas, but nothing man-made is ever fool proof. There are always opportunities for leakage.

Another issue is the increase of truck traffic and pollution of air and noise. They have created a proposal for in and out procedures of their facility, but one can not deny that main and side streets and air quality won't be effected. There will be a huge increase in truck traffic bringing in and distributing to other locations.

Thank you for giving us a chance to give our feedback on this issue. The people of West Chicago and surrounding areas work hard to maintain safe, well kept communities. Just because a company checks off all the boxes it doesn't mean that their desire is in the best interest of the area.

Hello,

I greatly oppose the waste transfer station coming to our community. I attended the town hall meetings open minded and unconvinced and over the course of these long nightly meetings I was swayed to strongly oppose the project.

1) Yes, LSR claims all of their trash trucks will be covered or at least have a manual tarp, however, they hold no authority over the other, non-company trucks that will deliver a wide array of trash and products that could be potentially harmful. They will have no authority or mandate for the public, junkers or construction trash to be covered and not spill potentially hazardous material onto our roadways, into our sewer system and eventually into the groundwater. With much of West Chicago using shallow wells for water could put the community at additional harm. I was there when the rain system and spillage was discussed but I know that the proposed area and a massive amount of spilled waste will be hitting soil and will be entering our groundwater. There is just no way around that. Plus, W.Chicago doesn't even fully control all of the rainwater systems. For example near me (on the east side of r-59), it's W.Chicago AND DuPage that deal with storm and rain water and to further complicate things, the PARKS department is in charge of another section of it (at least in my area). I know this as the storm drain at the end of my street was not functioning correctly and thousands of gallons of storm-water was EJECTING out of an opening meant to collect the storm water. The water was being expelled right next to my well-water-cap. I will even attach a video showing RAINWATER ejecting out of a basin and flooding part of a neighborhood, A pic of the water, after ejection sitting on residential property and a picture of me in the rain-water-flood. My point being, there is no way to guarantee that storm and rain water will not make it back into people's water sources. Adding an attraction, like another transfer station, for those carrying potential hazardous waste and material to this site will undoubtedly put the surrounding areas at a greater health risk. There is just no way around that.

2) The comments by the engineer saying there is no logistical need for the station. This engineer showed some diagrams and LSR attempted to discredit his research. I understand some of the critiques, like, how and where did he come up w/ his 15 mile radius for accessibility. However, I want to push back on some of those views. 1) In one case, a station was not needed but was approved to help fuel competition <this location was on the north side I believe> and yes, competition is good, however w/ LSR already having one location, the competition argument holds no weight here. 2) Another location was approved by this engineer for a transfer station even though a landfill was nearby <this location i believe was south of I-88 in the Sugar Grove area-ish> And members of the committee asked why he approved this site though a landfill was nearby, and it seemed like the engineers analisis where being questioned due to him approving this site and opposing the LSR proposed site. However he approved that site to bring the ability to recycle to that entire area and correctly helped recycling efforts overall reducing the amount of waste going into the landfill. So, Although this engineer seemed to be questioned, like his analysis was flawed, it was not flawed at all. When this engineer said there was no need for an additional waste transfer station in West Chicago, he was being accurate, truthful and correct, no matter who hired him.

3) We are JUST getting over the thorium spill. When my family and I began looking for our home West Chicago stood out as a unique up and coming area. Many surrounding towns and friends (strongly) advised me to ignore West Chicago due to the radioactive thorium spill that was still having work done to mitigate danger up until 2017 (maybe even 2019, I can't remember exactly) However I trusted the local government that the people had been put first and trusted our scientific and governmental efforts to contain and fix the problem. Now, only about 5-ish years after that massive stain on West Chicago's name and tons of work for the clean up, NOW we want to add another trash station??? Do we care about how our town is perceived at all? DO we care about the additional health hazards? This leads me to my next point

4) Un-investable. My wife and I loved some of the new coffee shops and existing local restaurants in the area and had/are planning to open an establishment (hopefully downtown) in the coming years. Well now, we question W.Chicago's reputation and if people will want to have a nice dinner in a town known for radioactive waste and trash stations and trash trucks... Its just really sad so see the city take this obvious wrong turn. W.Chicago has SO much potential to have a cool downtown and be just as unique and awesome as some other surrounding downtowns. There is no way that can happen by taking a step in the direction I hoped the town was moving away from, the direction and stigma of trash, waste, and health hazards. This "view" will not be a healable scar, it will be branded as the health hazard town. It is really sad.

5) Trash station jobs. So I called the current trash station and an employee said that the station operates on less than 20 people (not counting truck drivers coming and going). Is all of this worth it? Are all the hazards worth 15-25 jobs? I was also extremely disappointed that the only public comment (one night) was that of an employee voicing her opinion that these jobs will "help put kids in college". As this employee took her seat, all of her superiors and her boss supported her and thanked her for making the comment. Is that fair to you? that an employee got to voice their concerns IN PERSON while residents get nearly no public say?

I want to thank you for reading this lengthy email. It is clearly an important topic to me and I was really planning my future here in West Chicago. I urge you to take the residents into strong consideration for this proposal. Please feel free to reach out with any questions or concerns.

Good afternoon. I am sending this Email to let you know that I am opposed to the Waste Transfer proposal from Lakeshore Recycling Systems being considered by the City council of West Chicago.

I live at 910 Woodside Dr, the northwest corner of Woodside & Hawthorne. I have lived there now for going on 10 years and have really enjoyed my time here. My wife, Marlena, and I are very happy we chose to live here.

WEGO is a great place to live. The Police & Fire Departments are very professional and have always been very polite and concerned with our welfare any time we have had to interact with them. The same can be said of all the city employees. Always very helpful & informative.

We all ready have one waste transfer station, operated by Groot here in WEGO and the one meeting I was able to attend, at the High School, I heard it was not near capacity yet. So I question do we really need another one here? Someone argued our bill would go down because of less transportation costs. Again, it's already here. This is where I am lost.

One of the speakers who mentioned she was for the new transfer station was because LRS already had a transfer station for waste construction materials and the good things they did with these recycled materials. I have to believe there is a big difference between lumber, sheetrock, bricks and regular household garbage, so didn't understand that.

I heard comments about this being a state of the art, fully enclosed facility that would prevent a lot of people's concerns, smells, bugs, etc.. But what about the trucks that will more than likely be lined up outside the facility, waiting to get in to unload? And after they unload what prevents the smells, spills & bugs. The station is proposed to operate 6 days a week. How will these trucks get there, how many and how often? I think these are questions that really cannot be answered here and now. Change is inevitable and that is what needs to be considered today.

Hawthorne has it's own issues, keeping semitrucks off of it and stopping the race cars that show up in the spring. I have even seen them drag race down Hawthorne. I foresee the garbage trucks going up and down it to save time. People who have been able to use Powis to get down to Roosevelt, downtown, or Reed/Kepler, without having to go to ST Charles or RT 59 will encounter problems as well I imagine.

I was once told by someone, representing a facility being built by my house in Lombard, off of Roosevelt that was going to increase traffic and make a left turn dangerous, that if I wanted to go west to Glen Ellyn, I should just endure the inconvenience, turn right, go into Lombard, turn right at Finley, go to Downers Grove, Turn right onto Butterfield and go west until I hit a street to take me to Glenn Ellyn and back to Roosevelt road.

He was at the hearing. Glad I didn't have to listen to him. On the other hand, all the people that I did get to listen to were all in support of LRS's proposal. The interesting thing was except for maybe one they all lived somewhere other than West Chicago. I heard Wayne, Wheaton and elsewhere. To eyes that see:

Entering West Chicago from the east on Geneva Road, you see on the north side, across from High Lake, a picture of serenity: a large pond covered with marshes and lily pads in the summer, and in the winter blanketed with pristine snow. In the spring, you may observe a heron or egret flying conspicuously over the water or else waiting stock-still near the bank for a fish to swim by. Instead of enjoying the view from your seat, you want to shut your eyes.

Sure, municipal tax revenue might increase from locating another stinking eyesore in West Chicago, but inevitably home property values will suffer, and with them the city's tax base. Public morale will go down. Quality of living will go down.

You have a choice: favor the city's coffers, or listen to your soul. It's a no-brainer.

As residents for over two decades, we feel as if our concerns have been not addressed in opposition of the upcoming hearing on the Lakeshore Waste Transfer Station. We not only have several major intersections of Illinois rumbling through our streets at all hours of the day and night (garbage and more) which tremble our homes (much like living right next to an airport), we now feel completely helpless and insignificant when it comes to our voices not being heard. All of the notes we received about attending any meeting came in snail mail, way after the fact of the local meeting, how absolutely convenient so our voices were silenced! Walking my now blind pup alongside Route 59 near St Andrews Golf Course, you would think we lived in a war zone, or the worst part of the city in Chicago where streets are overlooked due to bad budgeting. Regarding the proposal, on that first night PODER counsel clearly explained that the proposal should be dismissed because the engineering firm had not delivered the appropriate legally required documentation to the appropriate interested railroads either to the accurate address or accurate company. In fact, they had not even confirmed receipt. Rather than dismiss the proposal there the "judge" rudely told counsel to, essentially, hurry up.

There is clearly no need for a second waste transfer station in our town. Though he reluctantly admitted it, it was made clear, by LRS's own engineering firm that there is plenty of healthy competition already.

There is too much noise and pollution in the current situation. With additional trucks driving on and off Route 64, which already affects rush hour traffic, the situation will worsen. And there is already quite a bit of garbage and refuse that "sails" off those garbage trucks as they speed down the road. They drive over the limit, recklessly as it is.

According to the State of Illinois, there are 14 current transfer stations in DuPage County, most of which are operating far below capacity. There is no proven need for another station, neither for capacity nor for competition.

This situation is an obvious circus, mandated by law, that the City is participating in because they must but will do what they want, regardless of the desire of their citizens. None of us want this station. None of us want to live in the garbage capital of DuPage County. If LRS truly believes they need another transfer station, there are plenty of other towns and cities in the County they can choose.

The hearings were a biased farce and the City will lose what little respect it has left and many of its citizens will leave. The housing prices will suffer, as will the schools. The town is already in crisis, having just barely recovered from the Kerr McGee fiasco and now they want to jeopardize our health and safety again.

I am in direct opposition to this proposal. Should it pass, I and many of my neighbors, will likely leave. Our City government is placed in their offices for US and should be listening to our concerns.

Please take this letter to heart - I am very concerned about what is happening to my town.

As residents for over two decades, we feel as if our concerns have been not addressed in opposition of the upcoming hearing on the Lakeshore Waste Transfer Station. We not only have several major intersections of Illinois rumbling through our streets at all hours of the day and night (garbage and more) which tremble our homes (much like living right next to an airport), we now feel completely helpless and insignificant when it comes to our voices not being heard. All of the notes we received about attending any meeting came in snail mail, way after the fact of the local meeting, how absolutely convenient so our voices were silenced! Walking my now blind pup alongside Route 59 near St Andrews Golf Course, you would think we lived in a war zone, or the worst part of the city in Chicago where streets are overlooked due to bad budgeting. It has been allowed to happen, we have been a doormat for big builders using Route 59 to drag their massive loads and other trucks which are not allowed on Randall or Route 53 which shaves bucks off their tollway bills and adds stress to the locals . At the request of Lakeshore Recycling Systems, LLC., Associated Property Counselors, Ltd. (APC) completed a study of the proposed West DuPage Recycling and Transfer Station to determine if the development satisfies Illinois Environmental Protection Act, 415 ILCS 5/39.2 (a) (iii), commonly referred to as "Criterion 3". Criterion 3 requires that "the facility is located so as to minimize incompatibility with the character of the surrounding area and to minimize the effect on the value of the surrounding property".

The report by APC was presented at the public hearing and offered into evidence on January 4, 2023. On January 12, 2023 Kurt Carl Kielisch offered testimony about the conclusions presented in the consulting report prepared by APC. It is noteworthy that Mr. Kielisch is not a licensed appraiser in the State of Illinois according to the Illinois Department of Financial and Professional Regulation website.

The following is my response to the testimony of Mr. Kielisch as found on pages 919 thru 940 of the record of the January 12, 2023 hearing.

The Illinois Environmental Protection Act, at 415 ILCS 5/39.2 (a)(iii), requires that an applicant for a transfer station siting demonstrate that the proposed facility is located "so as to minimize incompatibility with the character of the surrounding area and to minimize the effect on the value of the surrounding property". Associated Property Counselors, Ltd. (APC) completed a study of the proposed West DuPage Recycling and Transfer Station to determine whether the proposed development satisfies this requirement.

Studies such as this require the application of several analytical tools depending on the situation, location of the property, surrounding applications and timing of the proposed development. The applicable analytical techniques to be applied are determined by these variables so there is not a "one size fits all" methodology that is to be applied to result in a credible conclusion. This is known as the Scope of Work Rule under the Uniform Standards of Professional Appraisal Practice (USPAP). These standards were applied in completion of the APC report.

Unlike situations where the first recycling and/or transfer station is being introduced into an area where none exists, the subject siting request involves the expansion of an existing recycling facility to include the development of a transfer station in a location where one currently exists in close proximity to the subject property. The LRS request does not involve the introduction of the first transfer station in the area but is the expansion of an existing recycling facility to include transfer station services similar to a nearby competitive facility (located to the north). This fact is clearly ignored in the testimony of Mr. Kielisch.

The APC analysis examined Criterion 3 on several levels. Since the proposed use is not the introduction of the first transfer station into this market, a before and after examination or paired sales analysis of this location is not possible. A nearby existing transfer station has been in existence for nearly 20 years and distinguishing between the impact of the proposed LRS facility from the existing facility after a nearly 20 year history of operation is difficult and likely impossible. Another fact ignored in the Kielisch testimony.

Because of the actual circumstances surrounding the subject property, the applicable scope of work for the subject does not involve a "paired sales" or "near and far" analysis. The most reasonable analytical technique to be applied in this matter involves the examination of value patterns, resistance to the location, examination of marketing periods, examination of sales periods, lowering of price points, rejection of the location, declining rental rates and deteriorating condition of properties in the area over an extended period of time. This was done and the APC report discusses the results of this analysis. A fact clearly ignored in the testimony of Mr. Kielisch.

In effect, there is no before and after in this matter. There is only a 15 to 20 year after period since the establishment of the first transfer station in the area.


While applying the correct analytical technique, APC found no resistance to the area, found no decrease in value, and found that there has been positive development near and away from the proposed and existing transfer stations. The report and Power Point presentation accomplishes this in the aerial photographs. A fact ignored in the testimony of Mr. Kielisch.

The testimony of Mr. Kielisch centers on his opinion that a Highest and Best Use study alone is insufficient in scope to determine if the Criterion 3 standard is met. I actually agree with this theory. For that reason, APC did not only apply the analysis of Highest and Best Use to formulate the conclusion presented. The applied HBU Study is used to support the opinion that the property meets the letter and spirit of Criterion 3 was and remains only part of the analysis applied by APC. The examination of HBU and the conclusion that the proposed use of the subject is the Highest and Best Use of the property is only one factor used by APC to formulate the conclusion that the subject is located "so as to minimize the effect on the value of the surrounding property". The fact that the proposed development is the HBU lends additional credibility to the work completed by APC.

Appraisal principles state that when an application is the Highest and Best Use of the property, the greatest value is achieved. This is clearly a positive feature for the buyer and seller. Mr. Kielisch ignores, however, that when an application is the Highest and Best Use of a property, the market is positively impacted. It is reasonable to conclude that if the development is a positive in the market, "the facility is located so as to minimize incompatibility with the character of the surrounding area and to minimize the effect on the value of the surrounding property". Mr. Kielisch further ignores the fact that when a property meets the tests of HBU it is not a form of locational obsolescence and is not a negative for surrounding properties. Therefore, a property that meets the tests of Highest and Best Use supports the Criterion 3 standard to "minimize the effect on the value of the surrounding property".

Lastly, the opinions presented by Mr. Kielisch misstate the conclusions presented in the APC report and are an attempt to play "hide the ball" by redirecting the attention of the testimony and report to only a part of the work completed. This is consistent with the cross examination that occurred during my testimony of January 4, 2023. The implication that not presenting a "paired sales" or "near and far" analysis causes the APC report to lack credibility is incorrect because these analytical techniques are not applicable for the subject property. It is noteworthy that Mr. Kielisch presented no opinion that the proposed development will have an adverse impact on area properties. He opines only that he does not think a Highest and Best Use analysis is solely sufficient to determine that the standards of Criterion 3 have been met. Unfortunately, Mr. Kielisch ignores all other analysis presented in the APC report.
