

Illinois Home Weatherization Assistance Program (IHWAP)

What is it?

The Illinois Home Weatherization Assistance Program (IHWAP) offers eligible households the opportunity to reduce their energy bills by making their homes more energy efficient while increasing the comfort of their homes.

This may include but is not limited to the following areas:

- Seal air leaks to reduce heat loss and drafts
- Insulating walls, attics and basement/sidewalls to recommended levels
- Weather stripping exterior doors
- Repair or replacement of older, inefficient furnaces, air conditioners, and water heaters
- Installation of smoke detectors, carbon monoxide detectors and other health and safety measures



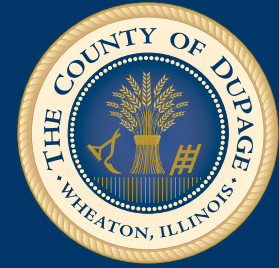

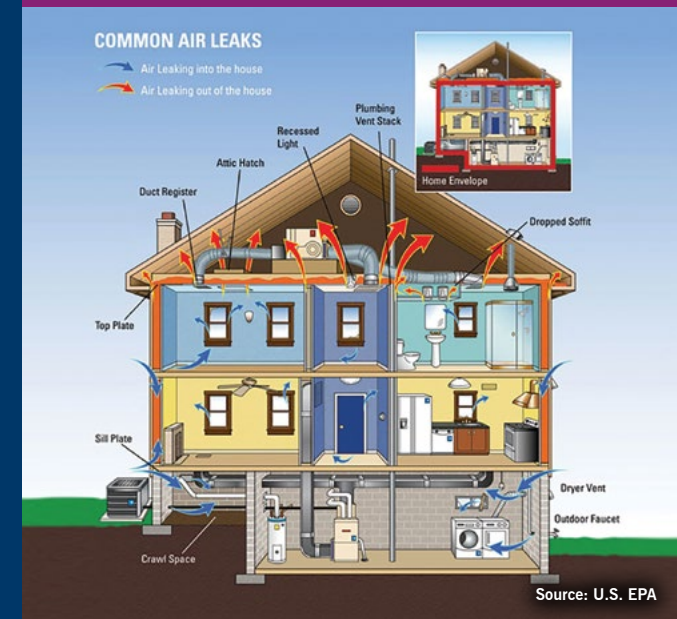

Illinois Home Weatherization Assistance Program (IHWAP)

How do I qualify?

If someone in your home has received a LIHEAP credit or a payment from TANF, AABD, or SSI within the last 12 months prior to applying, you may qualify for assistance. If you have not received any of these payments, but are within the guidelines listed, you may still qualify.

How do I apply?

Please contact our offices at **(630) 407-6500** and ask to have a referral made to the Weatherization Department, or you can have a referral made at any Township Office in DuPage County or LIHEAP intake site. Someone from the Weatherization Department will then contact you to set up an appointment to fill out an application (*wait time varies by priority status*). Seniors, disabled individuals and families with children 5 years of age or below are given priority.

* **200% level:** For each household member over 12 add \$10,280.

** **60% of State Median Income (State):** For each additional member above 12 persons, add \$2,080. This is per guidance provide from U.S. HHS information memo # LIHEAP-IM-2023-02.

When you apply for IHWAP assistance, be sure to bring the following information:

- Proof of gross income for all household members for the 30 days prior to the date you apply (income guidelines may be subject to change)
- A copy of your most recent gas and/or electric bill(s)
- Proof of Social Security numbers for all household members
- If you rent, proof of your rental agreements along with landlord information
- If you own, proof of home ownership (Tax bill, deed, or mortgage statement)
