1. Call to Order, Roll Call, Establishment of a Quorum

- *B.* 2025 Art Banner Exhibit: Theme Selection. Commissioner Gsedl made a motion, seconded by Commissioner Walsh, to approve Sustenance/Sustento as the theme for the 2025 Art Banner Exhibit. Voting Aye: Chairman Kuharich and Commissioner Plumlee and Treudt. Motion Carried.

- A. 2024 Art Banner Exhibit Status: Commissioners discussed the status of 2024 Art Banner Exhibit. Manager Peck reported that banners may be ready for production within the follow week.
- B. *Arteculture:* Commissioner Plumlee provided and update on the Arteculture Exhibit that will take place during Blooming Fest.
- C. Olmec Trails Commission Involvement: Manager Peck provided an overview of the upcoming art exhibit, Olmec Trails: Culture and Legacy, and explained the level of volunteer involvement the Mexican Cultural Center DuPage would be seeking from the Commission, which included decorating around sculptures that are located within West Chicago. Commissioners did not express interest.
