







Dear City of West Chicago staff:

In last quarter's Bulletin, I shared a new opportunity for interested City employees to chat with Tia Messino and me on a quarterly basis. These "Ask the Administrator" sessions will be held the third Tuesday in February, May, August and November and our first one will be on May 21st from 8:00-9:30 a.m. at City Hall; we will rotate building locations (and potentially time periods) each quarter so that it may be more convenient for those not located within City Hall. No signup is necessary. If you are interested in joining us for one or more sessions, please let your Department Head know a few days in advance so that your request can be accommodated; you need not stay for the entire time, especially if there are multiple people from a Department or Division wishing to attend the same day.

These open-door sessions are an opportunity to ask questions, raise concerns, share ideas or just find out what the City is doing and where it is going. This is your chance to share any thoughts you've had on new services, opportunities, or ways we can enhance our service delivery, regardless of whether an idea has been rejected before. All ideas will be shared with the Senior Leadership Team for discussion, anonymously if that's desired. It is also a great opportunity to get to know one another better. This said, these "Ask the Administrator" sessions are not meant to address issues of pay and benefits, or concerns with co-workers or supervisors. There are more appropriate avenues for dealing with these concerns, and they also should be dealt with in a timely manner if they arise.

For those wishing to attend our first session on May 21st, here's a question to think about: how was your onboarding experience with the City of West Chicago, and what would you suggest we do differently for future hires? The Senior Leadership Team is looking to create a formal onboarding program for new hires, and we'd appreciate your feedback.

Staff Fitness Membership Program Expanded

As part of continued efforts to support employee wellbeing, the City piloted a partial reimbursement of an ARC Fitness Center Membership last year. Based on your survey feedback, we are expanding the Program this year to cover any fitness center, enabling employees to prioritize wellness conveniently. Employees not already covered with a fitness reimbursement determined by a Collective Bargaining Agreement can have 50% of their fitness center membership reimbursed, up to \$100. In-person fitness centers not your style? Check with Human Resources Division staff to see if your preferred virtual fitness classes qualify.

To use the incentive, employees will need to submit their receipt/s to Human Resources Division staff by Friday, December 6th, 2024. Once documentation has been verified, participating employees will receive a reimbursement check from the City by the end of January 2025.

Financial Wellness Planning Materials Available on Employee Shared Drive

Thank you to all staff members who were able to attend the April 9th financial wellness lunch and learn session led by the Illinois Municipal Retirement Fund (IMRF) and the Money Management Educators (MME). Both presenters emphasized the importance of having a balanced financial plan, having a short- and long-term strategy for saving and investing, and starting early in order to reach your financial goals.

Long-Standing Projects Moving Forward in 2024

The City formally executed several grant agreements in the beginning of 2024 with the Illinois Department of Commerce and Economic Opportunity (DCEO), including: repainting the Fremont Street Water Tower; the completion of the West Washington Street Environmental Remediation project; and the installation of a traffic signal at Roosevelt Road and Technology Boulevard.

The City has been anticipating completing each of these projects for several years but needed the appropriate agreements in place in order to be reimbursed for the costs of each. With the new agreements finally in place, the City will be able to proceed with each of these important projects and, in the process, save approximately \$2 million.

• The Fremont Street Water Tower will finally get a fresh coat of paint after several years of waiting. For background, the tower is the City's oldest water tower, constructed in 1952, and has not been painted since 1990. It initially faced demolition due to its small size despite functioning properly. However, considering the development plans for the adjacent Washington Street property, the City decided to retain the water tower as it didn't impact development. After receiving the proper grant agreement to proceed with the project, the City Council authorized a contractor to repaint the tower, with work having started in the first week of April.

• The City will receive funding to assist with supporting the costs

for the environmental remediation of West Washington Street. At this time, the City is awaiting a report from its Civil and Environmental Engineering consultant that will provide remediation options and costs based on residential versus industrial/commercial land uses. Although this report is anticipated to be received by the end of this year, the project is progressing, and with the additional grant funding, the City will finally be able to prepare this property for development, including the new proposed municipal campus that was presented to the City Council's Development Committee in March of this year.

• The City performed several studies in 2022 for the installation of a new traffic signal at IL-38 and Technology Boulevard. The project required coordination with the Illinois Department of Transportation and the DuPage Airport Authority to receive a 'greenlight' to proceed with installation. With the new grant agreement in place, the City will be able to move forward with the installation of this much-needed traffic signal. This project is anticipated to start in Fall 2024.

The City has many great projects in the works and on the horizon, many of which will be outlined in Mayor Pineda's State of the City Address on May 20th. A recap of the Address will be provided in the Summer Bulletin.
