1. Call to Order, Roll Call and Establishment of a Quorum

2. Approve Meeting Minutes of January 2, 2020

3. Presentation by Mary Lester for Taco Night/Art Show

Mary presented some ideas, deadlines, and timeframes for the show, which is to take place on Saturday, August 8, 2020 from approximately 3:00pm to 8:00 or 9:00 pm. They are willing to extend the ours to begin earlier in the morning if we chose to do so. Lew would like to participate with a Jazz Occurrence.
