**City of West Chicago** Short-Term Home Rental Requirements



## PLEASE READ ALL SHORT-TERM HOME RENTAL REQUIREMENTS BELOW

- A Short-Term Home Rental (Rental) is permitted in any residentially zoned district when located in a single-family detached home.
- A Rental shall require a Special Use Permit when located in a single-family attached home, such as a townhome, or in a two-family home such as a duplex.
- Rentals are prohibited in condominiums and apartments.
- A Rental is only permitted in a house that is normally occupied by the owner of the house. The Short-Term Home Rental Owner (Owner) must have the deed to the house and must normally live in the house at least 183 days every calendar year.
- An Owner may not have more than one (1) Rental within the City of West Chicago (City).
- An Owner shall use a Short-Term Home Rental Hosting Platform (Platform) to market the Rental and contract with a Short-Term Home Rental Guest (Guest). Examples of a Platform include Airbnb or Vrbo.
- Prior to advertising the Rental on a Platform, the Owner shall obtain a Short-Term Home Rental License (License) from the City.
- Prior to the issuance of a License, the Rental shall be inspected by the City to ensure compliance with the City's Life Safety Codes.
- The License shall expire twelve (12) months after issuance but may be renewed every twelve (12) months thereafter. Licenses are not transferrable and shall expire upon the sale of the property.
- A copy of the License shall be posted in a conspicuous location in the Rental.
- The cost of the License, and each renewal, is \$50.
- The minimum rental period shall be no less than three (3) consecutive days and no more than thirty (30) consecutive days. No Guest may use the Rental for consecutive stays.
- Use of a Rental solely for the purpose of hosting a party is strictly prohibited.
- All parking shall be located on a paved surfaced on the Rental property. No off-site nor on-street parking is permitted overnight.
- A maximum of two (2) persons are allowed per bedroom and a maximum of ten (10) persons are allowed within the Rental.
- The Owner shall provide the City with the names, addresses, and telephone numbers of all Guests staying at the Rental if requested by the West Chicago Police Department due to a complaint of disturbance or other criminal activity occurring during a rental period.
