May 18, 2022, 7:00 P.M.

**Blooming Fest**

The event is Saturday May 21, 2022 from 9:00 A.M. to 3:00 P.M. Volunteers should plan to arrive at 8:00 A.M. to help setup. Commissioner Beebe will bring his tent and the Environmental Commission banner. Mr. Wilcox said a table will be delivered by Street Division staff. Magnetic clips and reusable shopping bags were received from Groot Industries, Inc. Mr. Wilcox has printed copies of the Recycling 101 flyer and has numerous other materials related to storm water management as well. He also has a map of the City showing the Adopt A Highway roads available. A recycling sorting game is planned and informational flyers about monarch waystations will be available.

Commissioner Beebe said he will email the group emergency shelter information which was left out of the event application packet.
