| In October of last year, the City Council entered into a contract with Upland Design Ltd. for park planning services for the former Kerr-McGee site on the southern portion of the City. Upland Design conducted two public forums at City Hall in November of last year and conducted two separate online surveys soliciting input from residents on what type of park amenities they would like to see in the park. The second public forum as well as the survey that followed also sought suggestions for what the park should be named. Based on the results of the feedback received at the public forums and through the surveys, Upland has drafted a Preliminary Master Plan for the future park site. This plan, as well top five names submitted in the survey, will be presented by Upland Design at the January 23, 2023 Public Affairs Committee. |   |  |



# **Department Overview**

The Mission of the West Chicago Police Department is to Protect Life and Liberty, Provide Quality Police Services, and Forge Community Partnerships with Integrity and Professionalism.

There are three divisions in the Police Department: The Office of the Chief of Police, the Patrol Division, and the Investigations/Administrative Division.

The primary responsibility of the Office of the Chief of Police s to provide general management direction and control for the Department. The Office of the Chief of Police consists of the Chief of Police, the Management Analyst, and the Administrative Assistant.

The Patrol Division consists of Uniformed Patrol Officers, the Community Service Officer, and the Training Officer.

The Investigations/Administrative Division consists of Detectives, School Resource Officers, Evidence/Property, the Community Relations Officer, the Administrative Sergeant, and Social Services.

# Personnel

On November 6<sup>th</sup>, Officer Jones began his role as the Department's Training Coordinator.

On November 9<sup>th</sup>, the Police Explorers learned how to detect intoxicated drivers and administer field sobriety tests to gauge impairment. Officer Rigler was on hand to assist Officer Arms with the training.



On November 14th, Matthew Lukaszek was sworn in as the Department's newest officer.



# **Criminal Activities**

## **Criminal Damage to Property:**

#2201874 Person(s) unknown damaged a window on the south side of City Hall, 475 Main St.

#2201947 Person(s) unknown threw an oil-based liquid on the south side of a house in the 500 block of Highland Ave.

## **Retail Theft:**

# Aggravated Discharge of a Firearm:

#2201900 Person(s) unknown fired seven rounds into a residence in the 800 block of Lyman St. Surveillance video shows that the shots came from a white vehicle that left the scene on Forest Ave., toward Pearl Rd. No one inside the residence was struck. The investigation is ongoing.



# Officer Activities

#2201783 On October 18<sup>th</sup>, Detective Flanigan was assigned a Cyber Tip from the National Center for Missing and Exploited Children (NCMEC). The tip advised of possible child pornography being uploaded from a Media Lab/Kik account. A search warrant was obtained for the account suspected of downloading the materials. The results successfully identified a suspect, suspect address, and additional child pornography. A search warrant was obtained for the residence where the suspect lived, and the images were downloaded. On November 22<sup>nd</sup>, Detectives Herbert and Eversole, Officers Moore, Chapman, Castro, and Montgomery, Community Service Officers Sollis and Trevino, and Detective Sergeant Peterson executed the warrant. An iPhone and an iPad were seized and forensically analyzed, leading to the discovery of additional child pornography images. Interviewed at the Police Station by Detectives Herbert and Flanigan, the suspect admitted to possessing and sharing the images. The DuPage County State's Attorney's Office approved a charge of Possession of Child Pornography- A victim Under 13 Years of Age against the suspect, who was fingerprinted, photographed, and transported to the DuPage County Jail.

#2202017 On November 23<sup>rd</sup>, officers responded to the area of Whitney Rd. and Locust Ave. in unincorporated DuPage County to assist Bartlett Police Department personnel in locating a suspect who fled from a stolen vehicle case. Upon arrival in the area, a subject fitting the suspect's description was observed running across Neltnor Blvd. and onto St. Andrews Golf Course. Officer Alaniz ran after the suspect and kept visual contact for approximately one and a half miles, relaying information to other officers over the radio. K9 officers and drone assets were called to assist in tracking and locating the suspect. The suspect ran to a residence on Waterford Ln. and asked the homeowner to call a cab. The resident instead called 911, and officers were dispatched to the area. Officer Rigler and K9 Mondo were in the area, observed the suspect, and after a short pursuit, were able to place him under arrest. The suspect was read his Miranda Rights and turned over to Bartlett Police Officers.



# **Criminal Damage to Property:**

#2202134 Person(s) unknown damaged a vehicle parked in the 1200 block of Kings Circle. The owner determined the rear brake lines to the SUV had been cut.

The second victim also was notified that his debit card had been used at the St. Charles Walmart. Loss is estimated at \$1,880.00. The investigation is ongoing.

# **Burglary:**

#2202146 Person(s) unknown forcibly entered three apartments in the 801 and 805 Burr Oaks Dr. buildings. A fire had displaced all residents of the buildings, which were then secured by padlocks and boards by management while repairs took place. Management later allowed residents back into the buildings to obtain some property. Some residents noticed damage to their doors. One apartment resident observed damage to the doorframe and noted that a guitar, amplifier, and Apple Air Pods had been removed from the apartment. Loss is estimated at \$430.00. A second resident entered his apartment and noted that an Xbox gaming system, Ugg boots, and \$200.00 in U.S.C. were missing from the apartment. A third resident observed pry marks on the apartment door. However, it is not believed entry was gained. A fourth resident stated a hat containing \$8.00 in loose change was located in her apartment, and the hat did not belong to any of the apartment's occupants. The investigation is ongoing.

#2202209 Person(s) unknown entered Arbor Liquors located at 110 Arbor Ave. Officers responded to an alarm call and found the front glass door to the business had been shattered, and the cash register was found on the counter without any paper currency. The owner responded and determined an unknown amount of liquor had also been taken from the business. No suspects were located in the business or surrounding area. The investigation is ongoing.

### Theft Over \$500.00:

#2202078 Person(s) unknown removed a package from the hallway of an apartment building in the 900 block of Lorlyn Dr. The package had been delivered, and by the time the victim went to retrieve it, the package had been taken. Inside was a Samsung phone valued at \$1,200.00.

#2202137 A known person removed a tire machine and wheel balancer from a business in the 900 block of W. Washington St. The victim contacted the suspect, who advised he wanted money and would return the equipment. Officer attempts to contact the suspect have been unsuccessful. Loss is estimated at \$18,000.00.

### **Theft Under \$500.00:**

# Officer Activities

#2202212 On December 11th, officers responded to the area of Roosevelt Rd. and Technology Blvd. for a pedestrian struck by a vehicle. An unresponsive, but breathing, victim was located on the grass next to a damaged bicycle. The offending vehicle had fled the scene. DuPage Metropolitan Emergency Response and Investigation Team (MERIT) was called to investigate the crash. The West Chicago Fire Protection District personnel transported the victim to Good Samaritan Hospital. Black plastic auto parts marked with Kia were located in the grass near where the victim was found. A Google search of Kia parts learned that the parts came from a Kia 5. On December 13th, Community Service Officer Sollis advised that she had located the possible suspect's damaged vehicle, a Kia 5, in a parking lot in the 600 block of Discovery Dr. Detectives ran the suspect vehicle's registration through surveillance cameras in neighboring municipalities and located the vehicle now with front passenger side damage eastbound on Roosevelt Rd. in Villa Park. Detectives viewed a video of the facility that showed the suspect exiting the building, entering the driver's seat of the suspect vehicle, turning onto Discovery Dr., then proceeding northbound on Technology Blvd. toward Roosevelt Rd. Investigators were told the suspect was making deliveries in St. Charles. Detectives Calabrese and Moore located the suspect, placed her under arrest, and transported her to the Police Station, where she was interviewed by Detectives Herbert and Flanigan. Initially, the suspect denied striking an individual and stated the damage to her vehicle occurred after striking a curb in Plainfield. Eventually, the suspect admitted to hitting a bicycle or an animal while in West Chicago. The driver did not report the crash because she was scared. The DuPage County State's Attorney's Office approved charges of Failure to Report an Accident Involving Personal Injury. The arrestee was fingerprinted, photographed, and transported to the DuPage County Jail.

#2202075 On December 5th, Officers O'Neil, Kowalik, and Montgomery, and Sergeant Bowers responded to the area of Joliet St and Brown St for a report of criminal damage to property in progress. Upon arrival, the driver of the damaged vehicle was located in the intersection with cuts to his hands. The victim's truck was located in the parking lot of La India with damage to both side mirrors, and all but the driver-side rear door window had been broken. The owner explained that a known suspect had followed him from the outlet mall in Aurora. Along the way, the suspect rammed the victim's truck from behind and side-swiped the victim's truck, causing damage to the driver's side and side mirror. When the victim stopped his vehicle at the intersection of Roosevelt Rd. and Joliet St., the suspect got out of his vehicle and broke more windows of the victim's vehicle using a drill or nail gun. The victim drove his vehicle north on Joliet St., and when he stopped his truck for the sign at Brown St., the suspect exited his vehicle and broke more windows on the victim's truck. The victim placed his hands up, and the shattering glass caused cuts to his hands. The suspect then left the area southbound on Joliet St. A witness stated that he observed the suspect and victim cutting each other off in traffic, and then the suspect exited his vehicle with a nail gun and shot it at the victim's truck. The witness took photos of the suspect vehicle, which provided officers with the suspect's registration plate. Officers obtained a phone number for the suspect, contacted him, and asked him to come to the Police Station and talk about the incident. The suspect arrived at the police station and, when questioned, stated he was watching his wife with the victim and followed the victim from the mall. The suspect said the victim struck his vehicle, causing damage. The suspect continued to follow the victim, and they had two more confrontations, the last being at Joliet St. and Brown St. The suspect stated he was frustrated that the victim had a relationship with his wife. The suspect was arrested and charged with Criminal Damage to Property, fingerprinted, photographed, and released from custody.

#2202077 On December 5<sup>th</sup>, Officers Castro, Bertany, Chapman, Lukaszek, and Mielke responded to a residence in the 300 block of Center St. for a domestic. Upon arrival, the caller stated the suspect broke into the residence through the backdoor, yelled profanities at her, and then repeatedly struck another occupant of the house with closed fists. The caller attempted to stop the battery and was also struck. The second victim stated he heard a loud noise from the back of the house and saw the suspect coming at him,

yelling profanities. The suspect struck this victim in the back of the head before leaving the house. The suspect then fled the residence. The suspect was placed under arrest and transported to the Police Station. The offender was charged with Battery and Criminal Trespass to Residence, fingerprinted, photographed, and then released from custody.

On December 9<sup>th</sup>, while on patrol, Officer Rigler observed a suspect stumbling in a lane of traffic in the area of Neltnor Blvd. and Main St. The suspect was seen stumbling in the 200 block of Neltnor Blvd., where a consensual encounter was made with the individual. Officer McGuire arrived to assist. The subject provided a name and date of birth, stating he was on his way home, and agreed to a search of his pockets. Found on the individual were a pipe, a plastic straw, and baggies containing white residue. The subject was arrested for Possession of Drug Paraphernalia and was transported to the Police Station. Dispatch provided a driver's license photograph for the person whose identifiers were supplied by the suspect. The photograph did not match the suspect who was in custody. The suspect's mask was removed, and a baggie of white powdery substance fell out. The substance field tested positive as cocaine. The suspect eventually provided his real name, and it was determined the subject was wanted out of Cook County on a Burglary warrant. The suspect was transported to the DuPage County Jail to be held for Cook County on the warrant.
