Prevention of Significant Deterioration (PSD)/Construction Permit Application.
Invenergy, Rock Falls, IL. Preparation of permit application for 1000 MW peaking combustion turbine facility in downstate Illinois. Work included dispersion modeling of the existing area sources as well as the proposed new plant using AERMOD. Also, included ecological impact analysis on potential threatened and endangered species. Facility was issued a permit to construct in 2015.

Impact Analysis of Existing Air Emission Sources upon a Proposed Housing Development. Confidential Client, Chicago, IL. Evaluated noise and air quality impacts an existing steam plant and chilled water plant upon a proposed residential housing development and hotel. Work included modeling of the steam plant emissions and the air quality impact upon both new developments. Used AERMOD to determine downwind concentrations of NOx at the building exterior as well as along the building facade at elevations to 200 feet. Results indicated that a new building configuration was needed to resolve air quality impacts upon the building and its residence. The new configuration dropped the maximum building height to less than 160 feet.

Historical Odor Impact Analysis of a Landfill Operation upon nearby commercial and residences. Confidential Client, Chicago, IL. Modeled the odor emissions from a landfill using a surrogate for a mixture of odors and correlated the complaint log from the nearby city records and the same time meteorological data to validate the model results. Using AERMOD

and local meteorological data, we were able to validate the model and do predictive modeling to show the extent of odor impacts over time.
