CONSTRUCTION NOTICE

March 23, 2023

RE: Fair Meadows Subdivision Rehabilitation Project

Dear Residents & Business Owners,

The City of West Chicago's Fair Meadows Subdivision Rehabilitation Project is anticipated to begin in early April 2023, weather dependent. Initially, the City's contractor, Schroeder Asphalt Services, Inc., and its subcontractors will begin with light activities such as layout, traffic control & protection, equipment transfers, saw cutting, etc., to begin preparing for the heavier construction activity. Specific project improvement locations and limits are in the enclosed Location Map. The project is anticipated to be substantially complete by August 2023.

This project is being partially funded by a Capital Development Block Grant (CDBG), which is awarded and administered through DuPage County. The project's proposed improvements include, but are not limited to, pavement milling and hot-mix asphalt (HMA) resurfacing, full-depth HMA pavement patching, intermittent concrete sidewalk and combination concrete curb & gutter removal and replacement, ADA-compliant sidewalk ramps, sanitary and storm sewer repairs, manhole structure repair and adjustments, new water main & residential water service lines replacement (both along Bishop Street from the Dale Avenue easement to Forest Avenue), new street lights along Augusta Avenue and Bishop Street, and thermoplastic pavement markings.

All construction activities are scheduled between 7:00 AM to 6:00 PM, Monday through Friday, and 8:00 AM to 4:30 PM on Saturday. Traffic flow may be restricted temporarily during construction hours, but all streets will be open to traffic at the end of each business day. In addition, access to driveways may also be temporarily restricted. If driveway access is restricted, overnight street parking will be permitted for those residents affected by driveway construction. Please obey all other local parking restrictions and signage. Please notify the City's Police Department at (630) 293-2222 or submit an online request at <http://westchicago.org/overnight-parking> if overnight street parking is required at your residence during construction. Furthermore, mail & package delivery and waste collection services are not anticipated to be disrupted during construction.

If you have any privately-owned items within the City Right-of-Way (ROW) along any of the streets noted above, including but not limited to, landscape items, buried dog fences, sprinkler systems, etc., please remove and/or clearly identify these items prior to the start of construction so the contractor is aware of their presence. The City's ROW typically extends from the center of the roadway to one foot beyond the edge of the City sidewalk. Please note that neither the City nor its contractor(s) is responsible for any damage done to privately-owned items located within the City ROW.

NOTICIA DE CONSTRUCCION

RAZON: Proyecto de Rehabilitación de Fair Meadows Subdivision

Estimados Residentes y Dueños de Negocios,

El Proyecto de Rehabilitación de Fair Meadows Subdivision de la Ciudad de West Chicago está anticipada empezar a principios de abril 2023, dependiendo del clima. Inicialmente, el contratista de la Ciudad, Schroeder Asphalt Services, Inc. y sus subcontratistas empezaran actividades ligeras tales como plan, control y protección de tráfico, transferencia de equipo, corte de sierra, etc., para empezar a preparar para la actividad de construcción pesada. Sitios específicos de mejoramiento de proyecto y limites están en el Mapa de Sitio adjunta. El proyecto se anticipa ser terminado para agosto 2023.

Este proyecto es siendo parcialmente fundado por la Subvención en Bloque de Desarrollo de Capital (CDBG, por sus siglas en inglés), lo cual es otorgado y administrado por el Condado de DuPage. Las mejoras propuestas del proyecto incluyen, pero no son limitadas a, moler pavimento y repavimentar con asfalto con mezcla caliente (HMA, por sus siglas en ingles), parchar pavimento de profundidad completa (HMA), banqueta de concreto intermitente y combinación de bordillo de concreto y eliminación y reemplazo de cuneta, rampas para aceras que cumplen con ADA, reparos de alcantarillado sanitario y pluvial, reparo de estructura y ajustes de la boca de alcantarilla, nueva cañería principal y reemplazo de líneas de agua de servicio residencial (ambos a lo largo de Bishop Street desde la servidumbre de Dale Avenue a Forest Avenue), nuevas luces de calle a lo largo de Augusta Avenue y Bishop Street y marcas de pavimento termoplásticas.

Todas las actividades de construcción están programadas entre 7:00 AM a 6:00 PM, lunes a viernes, y 8:00 AM a 4:30 PM el sábado. El tráfico será restringido durante las horas de construcción, pero todas las calles estarán abiertas al tráfico al final de cada día laboral. En adición, acceso a los driveways pueden ser temporalmente restringidos. Si el acceso al driveway es restringido, el estacionamiento por la noche será permitido para aquellos residentes afectados por la construcción del driveway. Por favor obedezca toda otra restricción de estacionamiento o letrero local. Por favor notifique al Departamento de Policía de la Ciudad al (630) 293-2222 o entregue una petición por línea en <http://westchicago.org/overnight-parking> si el estacionamiento por la noche es requerido en su residencia durante la construcción. Además, no se anticipa la disrupción de la entrega de correo o paquetes y servicios de colección de desechos durante la construcción.

Si usted tiene cualquier artículo privado dentro del derecho de paso de la Ciudad (ROW, por sus siglas en inglés) a lo largo de cualquiera de las calles mencionadas arriba, incluyendo, pero no limitado a, artículos de jardinería, cercas de perro, sistemas de riego, etc., por favor remueva y/o claramente identifique estos artículos para que el contratista esté enterado de su presencia. El derecho de paso de la Ciudad típicamente se extiende del centro de la carretera a un pie de la orilla de la banqueta de la Ciudad. Favor de notar que la Ciudad ni el contratista es responsable por cualquier daño hecho a artículos privados situados dentro del derecho de paso de la Ciudad.

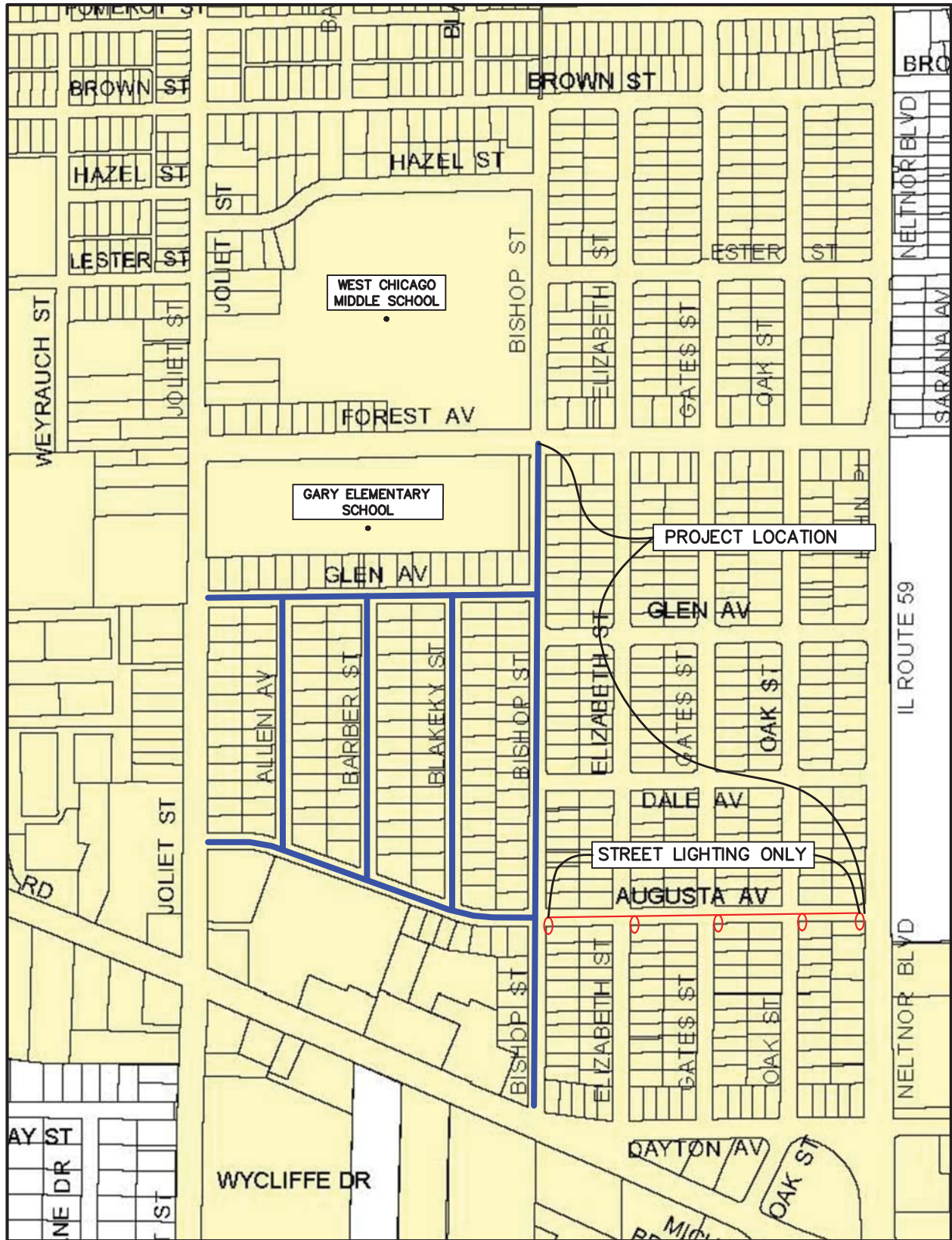

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Dear Water Customer:

Today's Date: March 23, 2023

This notice contains important information about your water service and may affect your rights. We encourage you to have this notice translated in full into a language you understand and before you make any decisions that may be required under this notice.

Lead Informational Notice

IMPORTANT INFORMATION ABOUT YOUR DRINKING WATER

Our water system will soon begin a water line maintenance and/or construction project that may affect the lead concentrations in your drinking water. Lead, a metal found in natural deposits, is harmful to human health, especially young children, and pregnant women. It can cause damage to the brain and kidneys and can interfere with the production of red blood cells that can carry oxygen to all parts of your body. The most common exposure to lead is swallowing or breathing in lead paint chips and dust. However, lead in drinking water can also be a source of lead exposure. In the past, lead was used in some water service lines and household plumbing materials. Lead in water usually occurs through corrosion of plumbing products containing lead; however, disruption (construction or maintenance) of lead service lines may also temporarily increase lead levels in the water supply. This disruption may be sometimes caused by water main maintenance/replacement.

The purpose of this notice is for informational purposes only. While it's not known for certain whether this construction project will adversely affect the lead (if present) plumbing in and outside your home, below describes some information about the project and some preventative measures you can take to help reduce the amount of lead in drinking water.

Project Start Date: April 2023 Project expected to be completed by: August 2023

Project location and description: Refer to the enclosed Location Map for project limits.

The Project Scope includes the installation of approximately 1,000 feet of a new 8-inch water main along Bishop Street, including 20 new water services, pavement milling, hot-mix asphalt (HMA) resurfacing, full-depth HMA pavement patching, intermittent concrete sidewalk, curb ramps, and combination concrete curb and gutter removal and replacement, utility structure adjustments, parkway restoration, and thermoplastic pavement markings.

What you can do to reduce lead exposure in drinking water during this construction project:

- *Run your water to flush out lead.* If the plumbing in your home is accessible; you may be able to inspect your own plumbing to determine whether you have a lead service line or lead solder. Otherwise, you will most likely have to hire a plumber.
 - If you do not have a lead service line, running the water for 1 – 2 minutes at the kitchen tap should clear the lead from your household plumbing to the kitchen tap. Once you have done this, fill a container with water and store it in the refrigerator for drinking, cooking, and preparing baby formula throughout the day.
 - If you do have a lead service line, flushing times can vary based on the length of your lead service line and the plumbing configuration in your home. The length of lead service lines varies considerably. Flushing for at least 3 – 5 minutes is recommended.
- *Use cold water for drinking, cooking, and preparing baby formula.* Do not cook with or drink water from the hot water tap; lead dissolves more easily into hot water. Do not use water from the hot water tap to make baby formula.
- *Look for alternative sources or treatment of water.* You may want to consider purchasing bottled water or a water filter that is certified to remove "total lead".
- *Clean and remove any debris from faucet aerators on a regular basis.*
- *Do not boil water to remove lead. Boiling water will not reduce lead.*
- *Purchase lead-free faucets and plumbing components.*
- *Remove the entire lead service line.*
- *Test your water for lead.* Call us at: 630-293-2255 to find out how to get your water tested for lead. While we do not do the testing, we can provide a list of laboratories certified to do the testing. Laboratories will send you the bottles for sample collection. Please note that we are not affiliated with any laboratory, and they will charge you a fee.
 - If test results indicate a lead level above 15 ug/L, bottled water should be used by pregnant women, breast-feeding women, young children, and formula-fed infants.
