 - i. *Discussion: Commissioners had an open discussion on better outreach efforts and teaming up with local partners in 2024 for the Pumpkin Composting event.*

 - i. *Discussion: Shah provided an update to the Commission on the event advertising efforts and ongoing coordination with Groot and City Staff on recycling bin drop-offs at various sites throughout the City. Shah further explained that the collected lights would be dropped off at the SCARCE facility in Addison, IL by Groot.
