April 17, 2024, 7:00 P.M.

 Discussion: The Commission was not interested in a Spring clean-up

 The Commission was further interested in adopting a different section of
 roadway for their Adopt-A-Highway efforts.

Discussion: Shah mentioned that the volunteers will meet at the Great Western Trail endpoint at Sassafras Drive beginning at 9am in the Willow Creek & Prestonfield Subdivision.

 - i. Shah distributed uniforms to the Commissioners.
 - ii. Rodriguez asked why the City did not invite the Commission to a new park's ribbon-cutting ceremony. Shah mentioned that he was not aware of any ribbon-cutting ceremony sponsored by the City in recent weeks but will look into it. Rodriguez further stated that the City should involve the Commission in City matters involving Environmental impact on the Community. The Commission would further like to be involved with new community park development at the former Kerr-McGee property as the Commission believes that there are various portions of the park planning that are directly related to the Environmental it's impact on the community. Rodriguez instructed Williams to work with elected officials and instructed Shah to work with the City Administration to discuss these matters.
 - iii. Charrington was interested in discussing items pertaining to various Environmental topics such as meadowscaping, usage of gas-powered equipment, effects of pesticides, etc. with the City Council in the upcoming months.

Bring up to (10) standard office-sized boxes of documents to be destroyed. Documents and/or paper may also be brought in plastic bags. Bags and boxes will not be disposed on-site.

Please remember to remove all binders, rubber bands, binder clips, page protectors, plastic bags, plastic file tabs, CDs, vinyl checkbook holders, batteries, and other hard items. Staples and paper clips do not need to be removed.

Medication and Sharps Disposal

The DuPage County Sheriff's Department will be accepting the following on-site:

- Expired or unused medications and vitamins.

 Please place all pills and ointments in a zip-lock bag; please do not bring pill bottles.
- Medical sharps including syringes, epi-pens, lancets, and needles. Please place all collected sharps in a thick plastic container, such as a laundry detergent bottle, and secure lid with tape.
- Inhaler canisters. Please do not bring holders.

Additional Items Accepted

The West Chicago Environmental Commission will also be accepting used American flags, eye glasses, and hearing aids at the event for proper recycling.

Rain-Barrel Program Pick-Up


Pick up your pre-ordered rain barrel from the City's Rain Barrel Program. Please make sure to have an adequately sized vehicle and room to transport barrel(s).
