### **MEETING MINUTES**

#### ENVIRONMENTAL COMMISSION

April 16, 2025, 5:00 P.M.

- 1. Call to Order Establish a Quorum
  - a. Dave Shah, Staff Liaison, called the meeting to order at 5:04 P.M.
  - b. Roll call found Co-Chair Tom Cherrington, Commissioner Bob Blaus, Commissioner Victoria Burris, Commissioner Tyler Kesler, and Commissioner Allen Rodriguez present. Chair Nazree Williams was absent.
  - c. Aldermanic liaison present included Alderman Christopher Swiatek.
  - d. Staff liaison present included Assistant Director of Public Works, Dave Shah.
- 2. Approval of Minutes
  - a. Environmental Commission Meeting Minutes of March 20, 2025
    - *i.* Rodriguez made a motion, seconded by Cherrington, to approve the Meeting Minutes.
      - 1. Voting Yea: Cherrington, Blaus, Burris, Kesler, Rodriguez

- 5. Review and Discuss the Commission Priority List
  - a. Current List

<u>Discussion</u>: Kesler shared that contact was made with the City of Batavia to get feedback from City staff and elected officials regarding their experience since the implementation of single-use bag fees. He plans to share the results of this outreach with the Commission at the May meeting.

- b. New Additions or Upcoming Events
  - i. Spring Adopt-A-Highway Clean Up Event (Hawthorne Lane) 1. Today around 6:00 P.M.
  - ii. Blooming Fest May 17, 2025, 9:00 A.M. 3:00 P.M.
    - 1. Location: Downtown West Chicago

<u>Discussion</u>: Shah updated the Commission on preparations for Blooming Fest. Bareroot preparation will take place in the garage at the Water Treatment Plant on May 15, 2025, at 5:00 P.M. immediately following the Environmental Commission Meeting. Burris and Rodriguez are making efforts to have an arborist in attendance for Blooming Fest as well. Rodriguez suggested ordering City logo hats for interested Commissioners to wear during the event.

- iii. Paper Shredding Event & Rain Barrels Pick Up June 7, 2025, 9:00 A.M. 12:00 P.M.
  - 1. Location: West Chicago METRA Station Parking Lot

<u>Discussion</u>: Shah noted that so far two rain barrel orders have been received, and the Commission should advertise the rain barrel sale during Blooming Fest. Two shredders have been confirmed for the event, and eWorks will accept textiles for recycling/reuse as well. The draft event flyer was reviewed, and Rodriguez suggested changing the background to green to be in line with the Commission's green initiative.

- 6. Other Business
  - a. Participation Certificate for the Holiday Lights Recycling Event <u>Discussion</u>: Shah provided the certificates for the Commissioners to present to participants.
  - Arbor Day and Earth Day Proclamation at the April 21, 2025, City Council Meeting at 7:00 P.M.
    <u>Discussion</u>: Shah invited the Commissioners to attend the meeting in support of the Proclamations.
  - c. Arbor Day Tree Planting Event Invitation <u>Discussion</u>: Shah invited the Commissioners to attend the tree planting in support of the City's Arbor Day celebration on April 25, 2025, at 10:00 A.M. at 135 W. Grandlake Boulevard.
  - d. Monarch Butterfly Action Items <u>Discussion</u>: Shah shared that he and Burris met with the City's Street Superintendent to discuss planting pollinators in town. Burris will work with the West Chicago Garden Club to seek volunteers to plant pollinator gardens at the METRA parking lot and two of the City's entryway signs (one on Route 64 near Fair Oaks Road and one on Neltnor Boulevard just south of St. Andrews Golf and Country Club). They will also maintain the existing pollinator garden at City Hall. Public Works staff are preparing these areas, and Commissioners are invited to volunteer with the plantings. A planting date will be set for some time in May. Burris will also be giving a presentation at Ball Horticultural on April 22, 2025, at 12:00 P.M.
  - e. Water Treatment Plant Tour
    - i. Took place today after the meeting.
  - f. Adopt-A-Highway Cleanup
    - i. Took place today after the Water Treatment Plant tour and concluded at 7:55 P.M.
  - g. Rodriguez inquired about the City's upcoming Open House. Shah shared that it would be held on April 23, 2025, from 5:00-7:00 P.M. at City Hall. City staff will be there in an informal setting to share information about public engagement, community resources, and projects going on in the City. All are invited to attend.
  - h. Shah noted that DuPage County shared information with him about a nonprofit entity aiming to connect low-to-moderate income households with Community Solar Project. The residents would save a minimum of 10% on the energy portion of their ComEd bill by participating. They are looking for events to do some outreach and hopefully sign up some households. Shah asked the Commission if they would be interested in having the nonprofit at Blooming Fest; they would like more information first. Cherrington suggested sharing information about ComEd's free energy assessment at Blooming Fest as well.
- 7. Adjournment
  - a. Upon completion of the Adopt-A-Highway cleanup event at 7:55 P.M., there was a general agreement by the Commissioners to conclude the meeting.

### Paper Shredding

Bring up to (10) standard office-sized boxes of documents to be destroyed. Documents and/or paper may also be brought in plastic bags. Bags and boxes will not be disposed on-site.

Please remember to remove all binders, rubber bands, binder clips, page protectors, plastic bags, plastic file tabs, CDs, vinyl checkbook holders, batteries, and other hard items. Staples and paper clips do not need to be removed.

Service provided by Accurate Document Destruction which is a subsidiary of West Chicago's waste management service provider, Groot Industries.

### **Medication and Sharps Disposal**

The DuPage County Sheriff's Department will be accepting the following on-site:

• *Expired or unused medications and vitamins.* Please place all pills and ointments in a zip-lock bag; please do not bring pill bottles.

• *Medical sharps including syringes, epi-pens,* lancets, and needles. Please place all collected sharps in a thick plastic container, such as a laundry detergent bottle, and secure lid with tape.

• Inhaler canisters. Please do not bring holders.

### **Clothing, Shoes, Apparel Accessories**



eWorks will be collecting clean clothing, shoes, apparel accessories (such as belts, hats, scarves, and purses), bedding, towels, and other household textiles. Items can be in any condition as long as they are clean and not wet or moldy. Rips, tears, stains that won't wash out, and missing buttons or zippers are all acceptable.

The West Chicago Environmental Commission will also be accepting used American flags, eye glasses, and hearing aids at the event for proper recycling.





### **Design Tips:**

- Don't worry about copying the design exactly!
- These plants move and spread naturally and this natural design reflects that
- Focus on heights—short plants towards borders, tall plants towards the middle/back
- Roughly 15" spacing for all plants and no straight lines is easiest
- Dig all holes first to establish spacing, then lay out plants



### GENERAL NOTES: LANDSCAPE

- Notes indicated on grading plans shall pertain to landscape plans. Final grade of planting beds shall be as per grading plan.
- The landscape contractor shall be responsible for making themselves familiar with all underground utilities and structures.
- All existing plant material and trees shall be saved and protected unless otherwise noted. Contractor to protect new and existing trees and landscaping from damage and shall restore all areas disturbed as a result of construction.
- Plant material shall be supplied from Northern Illinois nursery stock, shall be dug the planting season it is installed, and shall conform to the American Association of Nurseryman's standards.
- Plant material shall be size and type specified. Substitution of plant material shall be on a case by case basis and approved in writing by the Owner's Representative. In no case shall plant material be smaller than indicated in the plans.
- Do not willfully proceed with plantings as designed when it is obvious that obstructions and/or grade differences exist that may not have been known during the design process. Such conditions shall be immediately brought to the attention of the Owner's Representative. All plant material shall be inspected and approved by the Owner's Representative prior to the
- installation of any and all plant material. Plant locations shall be flagged in field with Owner's Rep. Final location of all plant material shall be subject to approval of the Owner's Representative prior to digging any holes. The landscape contractor is responsible for providing Owner's Representative with 48 hour minimum advance notice prior to planting.
- Plants shall be watered on the day they are planted and maintained with watering until final acceptance of the project.
- 10. Apply a pre-emergent as per manufacturer's specification prior to installing mulch.
- 11. Beds and tree rings (6' diameter) shall have 3" of hardwood shredded mulch applied and a 4" deep spade edge at lawn. Trees that are not located in beds, shall have a tree ring. 12. Landscape plant material shall be guaranteed for 12 months from final acceptance. Any
- plant 1/3 dead or more shall be replaced under the guarantee.
- 13. Contractor to prepare landscape beds by roto-tilling 2" of Mushroom Compost into new beds. Do not add compost nor roto-till within drip line of existing trees.
- 14. Lawn Seeding shall be under favorable weather conditions, and shall follow dates in specification. All irrigation shall be installed and functioning prior to seeding.
- 15. Turf mixes shall be installed and lawn established at all disturbed areas. 16. Do not overseed into mulch beds, artificial turf, and paving.
- 17. Contractor shall restore all areas disturbed as a result of construction.
- 18. Landscape contractor to coordinate all work with irrigation work.
